



NPDES Stormwater Multi Sector Generic Permit Guidance

Sector D: Asphalt Paving and Roofing Materials Manufacturers and Lubricant Manufacturers

Sector D - Glass, Clay, Cement, Concrete, and Gypsum Manufacturing Facilities of the Multi-Sector Generic Permit (MSGP) covers storm water discharges associated with industrial activities at facilities which manufacture asphalt paving mixtures and blocks, asphalt felts and coatings, and lubricating oils and greases. Manufacturers of Asphalt Paving Mixtures and Blocks (SIC 2951). Manufacturers classified in SIC 2951 store purchased asphalt in above ground tanks

Recommended Best Management Practices BMPs

Stormwater treatment BMPs are intended to prevent or minimize the contamination of runoff, or treat runoff contaminated with pollutants. Asphalt Paving and Roofing Manufacturers and Lubricant Manufacturers BMPs include (not limited to):

- Minimize exposure
e.g., covering, curbing, or diking)
- Treat stormwater discharges
(e.g., oil/water separators, sediment basins, or detention ponds).
- Good stockpiling practices: storing materials on concrete or asphalt pads; surrounding stockpiles with diversion dikes or curbs; and revegetating areas used for stock piling in order to slow runoff.
- Use an oil/water separator sult of material handling operations or aggregate drying.
- Implement spill plans to prevent contact of runoff with spills of significant materials.

Regulated Activities:

Standard Industrial Classification (SIC) Codes:

2951 Asphalt Paving Mixtures and Blocks

They stockpile a variety of raw materials such as sand, gravel, crushed limestone, and recycled asphalt products (RAP). These facilities produce asphalt concrete and may also mold and cure asphalt concrete products such as asphalt blocks.

2952 Asphalt Felts and Coatings

Manufacturers classified in standard industrial code 2952 typically produce bitumen-based roofing products such as asphalt shingles, built-up roofing (BUR), modified bitumen sheet material, asphalt saturated felts and bitumen-based root coatings, mastics and cements.

2992 Lubricating Oils and Greases

Establishments primarily engaged in blending, compounding, and re-refining lubricating oils and greases from purchased mineral, animal, and vegetable materials.

2999 Products of Petroleum and Coal

Establishments primarily engaged in manufacturing packaged fuel, powdered fuel, and other products of petroleum and coal, not elsewhere classified.

Industrial facilities which have the potential to discharge stormwater to surface waters of the State or into a municipal separate storm sewer system (MS4) and fall under any one of the 11 categories of industrial activities identified in 40 CFR 122.26(b)(14), may require coverage under the Multi-Sector Generic Permit.
