Biscayne-Everglades Greenway Facts

- 43 mile world class greenway. This non-motorized multi-use trail will traverse and serve the
 both incorporated and unincorporated portions of Miami-Dade County and link together
 numerous resources, including the Biscayne National Park, Florida City, the City of
 Homestead (and its planned revitalized downtown with museums, shops and restaurants),
 the agricultural farming area, Robert is Here (vegetable fruit stand), Everglades Alligator
 Farm, Miami Speedway, numerous housing developments, schools and Everglades National
 Park
- The greenway will connect to 9 other trails in the South Dade Greenways Network
- Southern Miami-Dade County is home to wide variety of rare and endangered birds and animals that are not often seen elsewhere. These include: Florida panthers, manatees, roseate spoonbills, southern bald eagles, loggerhead turtles and Everglades snail kites to name a few. Everglades National Park is the only place in the world where alligators and crocodiles exist side by side
- The 22 mile northern route or Mowry Route utilizes 17.3 miles of South Florida Water Management District (SFWMD) right-of-way
- The 21 mile southern route utilizes portions existing road right-of-way and SFWMD right-of-way. The southern route provides direct connectivity to the national parks and points of interest as well as provides alternative transportation opportunities for users
- The total estimated cost of project is \$49.9 million
