FINANCIAL SUMMARY FOR FY 2012/2013

The FY2012-2013 Local Government Funding Request (LGFR) submitted to the Legislature on November 4, 2012 contained a total of \$91,882,526 in funding requests from local governments to conduct beach erosion control projects. Funding requests were presented on either the Beach Management List or the Inlet Management List. The Beach Project List contained the Beach Restoration and Nourishment Projects, New Projects: Feasibility and Design Phase, and Post-Construction Monitoring projects. The Inlet List contained the Sand Bypassing and Inlet Management Plan Implementation Projects.

In FY 2012-2013, the Department received a new appropriation of \$10,000,000 for beach and inlet projects. The Department also received \$11,863,814 from funds that the Legislature reverted from previous appropriations, of which \$9,927,482 was re-appropriated in Chapter 2012-118 Section 60 with proviso being the same as above and \$1,936,332 was retained in the Ecosystem Management and Restoration Trust Fund. A total of \$19,927,482 was used to fund projects, according to Chapter 2012-118, Laws of Florida, Line item 1669, which states:

Funds in Specific Appropriation 1669, as part of the Department of Environmental Protection's Beach Management Funding Assistance program for Fiscal Year 2012-2013, shall be allocated to the seven highest prioritized projects on the department's Nourishment Projects list and funded in the amounts as indicated in the agency's submittal with the exception of priority project number four. The state's share for this project is reduced 50 percent from the submitted request based on local project sponsor modifications, project eligibility, and reduced total project costs. Additionally, pursuant to section 161.143 (5)(a), Florida Statutes, 10percent of the amount appropriated for beach restoration and nourishment projects will be used for the three highest ranked projects on the department's separate Inlet Sand Bypassing/Management Projects list. Of this 10 percent, the department may allocate up to \$300,000 in support of sand source needs assessment and management pursuant to section 161.144, Florida Statutes. Furthermore, post-construction monitoring will be funded at 50 percent of the department's request.

All projects included in the FY 2012-2013 LGFR are listed in the following tables, grouped by the Beach Management List (Table 1), Inlet Management List (Table 2), New Projects: Feasibility & Design (Table 3) and the Post-Construction Monitoring List (Table 4). Tables include the project name, local sponsor, funding request amount, and appropriation amount. The contract status of each project having received an appropriation, as of January 15, 2013, is included for reference. All funds will be encumbered by January 31, 2014, when scopes of work have been approved.

Post-Construction monitoring after Year 1 was limited to 50% of funds requested by the Department as per the proviso language cited above.

Funding, Accountability and Transparency Reporting

In the Laws of Florida Chapter 2012-65, Subsection (20) of section 161.101, Florida Statutes was amended to read “The department shall maintain active project listings on its website by fiscal year in order to provide transparency regarding those projects receiving funding and the funding amounts, and to facilitate legislative reporting and oversight. In consideration of this intent:

- (a) The department shall notify the Executive Office of the Governor and the Legislature regarding any significant changes in the funding levels of a given project as initially requested in the department’s budget submission and subsequently included in approved annual funding allocations. The term “significant change” means those changes exceeding 25 percent of a project’s original allocation. If there is surplus funding, notification shall be provided to the Executive Office of the Governor and the Legislature to indicate whether additional dollars are intended to be used for inlet management pursuant to s. 161.143, offered for reversion as part of the next appropriations process, or used for other specified priority projects on active project lists.
- (b) A summary of specific project activities for the current fiscal year, funding status, and changes to annual project lists shall be prepared by the department and included with the department’s submission of its annual legislative budget request.
- (c) A local project sponsor may at any time release, in whole or in part, appropriated project dollars by formal notification to the department, which shall notify the Executive Office of the Governor and the Legislature. Notification must indicate how the project dollars are intended to be used.
