2019 Biennial Hazardous Waste Report Training and Guidance

Dear Hazardous Waste Report Coordinator:

The Florida Department of Environmental Protection (FDEP) is pleased to offer a set of training sessions on the completion of the 2019 Biennial Hazardous Waste Report (BR). There will be five locations for the training. The training sessions will be 3-hour morning basic Large Quantity Generator (LQG) training sessions and 3-hour afternoon sessions on the 2019 Biennial Hazardous Waste Report.

US EPA offers web based program for the report for use by all reporting sites. This software makes the reporting process easier and more accurate. The BR sessions will be held from 1:30 PM to 4:30 PM (except for the Tampa and Jacksonville session) at each site with extended questions and answers as needed. These sessions will be oriented toward a complete, basic coverage of the paper and software BR reporting process for LQG sites and TSD Facilities. Morning sessions have been added that will cover rules and regulations pertaining to LQGs. Please contact your district offices for information on registration and scheduling for the morning sessions.

The **West Palm Beach** session will be held in the Water Management District Offices at 3301 Gun Club Road in West Palm Beach, Florida 33406 on Monday, December 9, 2019.

Directions: From 95 head west on Southern Blvd, then head south on S Congress Ave. Turn right (west) onto Gun Club Rd and the South, Water Management District will be on the right. Please sign in at the security office in building B1.(561) 681-6600

The **Orlando** session will be held in the conference room of the Central District FDEP office at 3319 Maguire Blvd, Suite 232 in Orlando, Florida 32803 on Tuesday, December 10, 2019.

Directions: Go East on Colonial Drive/State Road 50 from I-4 (exit) in Orlando for 3 miles. Turn left (north) on Maguire Boulevard. Turn left onto Executive Center Drive past the first light and make an immediate right-hand turn into the first parking lot. It is a two-story building with lots of windows (Lexington building). The **Pensacola** session will be held in Training Room at 504 in the Chappie James Building at 160 W. Government St. in Pensacola Florida 32502 on Thursday, December 12, 2019.

Directions: In Pensacola, from I-10 take I-110 South towards East Garden St. Take exit 1C from I-110 South and merge onto E Garden St. Turn left on South Spring St. and then right on W. Intendencia St. The Chappie James Building will be on your left. The **Jacksonville** session will be held in the 5th floor conference room (Room 550) of the Florida Coastal school of Law Building located at 8787 Baypine Rd in Jacksonville Florida 32256 on Wednesday January 29, 2020.

Directions: From I-95 exit onto West Union Street. The FSCJ Downtown Campus, Building A, is approximately 7 blocks west of I-95 on the north side of West State Street between Pearl Street and North Laura Street. Please use the Student Parking lots #3 and #4 located on North Laura St or #5 and #6 located on Bethel Baptist St. The Auditorium Room A1068 on the 1st floor of Building A.
