II. DEM Watershed Management Plans

III. Cedar Key Shoreline Management Master Plan/Living Shoreline Suitability

Savanna Barry, of Florida Sea Grant, told us about the Shoreline Management Master Plan/Living Shoreline Suitability Model project being done in Cedar Key. This innovative tool, adapted by a similar tool developed by the Virginia Institute of Marine Science, identifies appropriate shoreline treatments in vulnerable areas and indicates the potential permitting needs on a parcel level. Expansion of the model for use in other areas is a possibility. Emergency managers and Aquatic Preserve managers should be involved, especially with the drafting of the master plan. V. FRCP Updates

A. Impact of Governor's Executive Order

Governor DeSantis' Executive Order changes the name of the Florida Coastal Office to the Office of Resilience and Coastal Protection (RCP), bringing more visibility and emphasis to the resilience efforts of the agency. RCP submitted, and the Governor included in his budget proposal, an expanded budget for resilience projects with local governments. Stay tuned!

An evaluation team will provide recommendations on those applications and an announcement will be made in May, after the 2019-2020 state budget is finalized. VII. Questions, comments, announcements, updates

- Jennifer Carver and Carl Spirio from FDOT announced that the Florida Transportation Plan Update would kick off with visioning in May with goals of making the state transportation system agile and resilient. There will be a resilience subcommittee. They are also doing research on risk as it relates to transportation planning. The Sea Level Scenario Sketch Planning Tool developed by FDOT and UF's GeoPlan Center is undergoing an update to include more recent sea level rise projections and new flooding information. They are looking for comments from users! Resilience guidance for Metropolitan Planning Organizations is coming, as are results from the recent Strategic Intermodal System study. The Federal Highway Authority will be hosting a transportation resilience conference in mid-November in Washington DC and will be putting sea level rise information into important engineering guidance.
