In accordance with the requirements of 40 CFR Part 60, Subpart B, and on behalf of the Secretary of the Florida Department of Environmental Protection (Department), the Department is submitting a proposed revision to Florida's pending 111(d) State Plan for Municipal Solid Waste (MSW) Landfills.

On October 21, 2020, the Department published a notice of opportunity to submit comments and request a public hearing in the Florida Administrative Register, with the public hearing, if requested, to be held on December 1, 2020. Pursuant to 40 CFR 60.23(g), EPA has approved alternative public participation procedures allowing the Department to cancel the December 1, 2020 public hearing if no hearing was requested by November 20, 2020. No hearing was requested by November 20, 2020 and, therefore, no hearing was held.

This State Plan submittal incorporates the August 29, 2016, promulgation of the Emission Guidelines for MSW Landfills, codified at 40 C.F.R. Part 60, Subpart Cf. 81 Fed. Reg. 59,276. The Department has identified 42 facilities that are subject to these regulations, which are included in the source inventory section of this State Plan submittal.

The Department has sent the complete SIP submittal package directly to the Air Analysis and Support Branch via EPA's State Planning Electronic Collaboration System (SPeCS).
