
Request for approval of management plan amendment at Erna Nixon Park in

West Melbourne, Brevard County, Florida

The Brevard County Parks and Recreation department manages state-owned property known as Erna Nixon Park through lease #2925. The state approved a Land Management Plan for the property on July 16, 2013. Erna Nixon Park is approximately a 59.93-acre community park located at 1200 Evans Road, Melbourne FL, 32904. The main features of the park are 3,000 ft elevated boardwalks that wind through the natural Florida Hammock and nature preserve. The park also features a medium sized pavilion with a small nature center, office and restrooms. Brevard County Parks and Recreation is proposing an outdoor pavilion to utilize as an outdoor environmental education classroom which is consistent with the approved uses of the property. The pavilion will be screened and supplied with electricity for fans and lighting. The classroom will be used for education purposes during camps and special events. Brevard County is requesting approval for the management plan amendment for Erna Nixon Park. This project will be incorporated in the ten-year land management plan. With state approval the project would be completed in the year 2020.


The proposed pavilion is a RCP shelter 28' x 20' in size. The pavilion will be screened, lighted and ceiling fans will also be installed. The proposed pavilion installation will be placed next to the existing structure onsite. The overall pavilion footprint will be upland and located on the previously disturbed area of the park. Brevard County does plan to remove an existing lean-to shed and clear existing scrub palms from the pavilion location prior to the installation process. We will ensure the area where the classroom is going does not contain any endangered or threatened plant or animal species. This function and the construction oversight will be done by the naturalist at the park.

Site plans, conceptual structure designs, site maps and photographs relating to the proposed project are provided as item backup to this request for approval of management plan amendment at Erna Nixon Park.


