## Florida Department of Agriculture and Consumer Services, Florida Forest Service Land Management Plan Amendment to the Blackwater River State Forest Ten-Year Land Management Plan

## August 2021

The Florida Forest Service (FFS) is requesting ARC approval of a Land Management Plan Amendment to the Blackwater River State Forest (BRSF) Ten-Year Land Management Plan (LMP) to reroute approximately 150 feet of a tertiary road off private property to maintain the current level of access for the public and FFS operations. The FFS-managed BRSF is an approximately 213,000-acre, multiple-use state forest, located in Santa Rosa and Okaloosa Counties. The Board of Trustees of the Internal Improvement Trust Fund of the State of Florida (BOT) hold title to the affected portion of the state forest.

The reroute of the subject road, B90, is necessary to construct because a portion currently resides on private property. This reroute will maintain public access and allow the FFS to operate without having to traverse over private property. The project footprint consists of mostly pre-merchantable pines and will be approximately 150 feet in length by 12 feet in width with a total area of 1,800 square feet.

FFS staff and a certified archaeological resource monitor surveyed the proposed site area for threatened or endangered species and possible historical and/or archaeological evidence, and concluded no known archeological sites occur in the project area, as well as, no evidence of threatened or endangered species. FFS additionally consulted with the Florida Natural Areas Inventory (FNAI), the Division of Historic Resources (DHR) and the Northwest Florida Water Management District regarding the proposed activities; there are no resource conflicts reported. Consulting agency (FNAI, DHR, NWFWMD) response letters are included with this request, as are other applicable supporting documents.

Dear Mr. Knapp:

Our office reviewed the referenced project in accordance with Chapter 267, Florida Statutes, and implementing state regulations, for possible effects on historic properties listed, or eligible for listing, in the National Register of Historic Places (NRHP) or otherwise of historical, architectural or archaeological value.

The proposed project includes rerouting a 150' section of Florida Forest Service road to avoid a private inholding. There are no cultural resources previously identified in this area. Based on the limited nature of the project and environmental characteristics suggesting the area has a low probability for archaeological sites, it is our opinion that the project will have no effect to historic properties listed, or eligible for listing, in the NRHP. However, since there is some potential to encounter archaeological resources during the project, we request that ground disturbing activities be monitored by someone who has completed the Archaeological Resource Management (ARM) training program. Once the project is complete, the monitor should submit the appropriate monitoring forms to this agency. In the event that unmarked human remains are encountered during permitted activities, all work shall stop immediately and the proper authorities notified in accordance with Section 872.05, Florida Statutes.
