ITEM XX:

Consider whether an approximately 3.213-acre public easement for public right-of-way across Cross Seminole Trail is consistent with the Board of Trustees' Incompatible Use Policy.

LOCATION:

Seminole County, Section – 9 & 31, Township – 21S, Range – 31E

APPLICANT:

Florida Department of Transportation

DSL STAFF REMARKS:

The Applicant has requested this easement across the Cross Seminole Trail (Trail) for public right-of-way as part of the project to widen Seminole Expressway (SR 417) from the existing four lanes to a proposed eight lanes, from Aloma (SR 426) to north of SR 434. The widening project is intended to improve operations and safety and increase traffic capacity. The easement term will be for as long as the area is needed for public right-of-way.

The proposed easement area is currently managed by Seminole County (County) under Board of Trustees' (BOT) Lease No. 4770. The Trail was acquired by the BOT in 1996 with P2000 funds for conservation and recreational activities. The Trail will remain open for public use during daytime hours. The Trail will be closed to the public at night during construction activities. The Applicant will place signs to notify the public of the hours the Trail will be closed to the public.

The County consented to the easement in a letter dated November 29, 2022. In a letter, dated March 7, 2023, the Division of Historical Resources (DHR) stated that the proposed project is unlikely to affect historic properties. In the event unexpected finds occur during ground disturbing activities, the permitted project shall cease all activities involving surface disturbance in the vicinity of the discovery and the Applicant shall contact DHR.

Avoidance:

There are no other practical alternatives for this easement request.

Minimizing Impacts:

The proposed easement will result in the Trail being closed at night during construction activities. The proposed easement will not impact daytime use of the Trail. The Applicant at its expense, is responsible for repairing any damages caused to the Trail that are a direct result of this project.

Gopher tortoises are commonly found in open areas adjacent to the Trail. The Applicant shall conduct a survey to identify any tortoises located within the requested easement area and work with the County to relocate them prior to any construction activity. Other imperiled species that occur within the Trail include the indigo snake, Florida mice, gopher frogs, bald eagle, yellow rat snake, eastern coral snake, bobcat, turkey vulture and osprey.

Compensation:

The easement fee is waived for public agencies. Per the BOT's incompatible use policy, net positive benefit, in the form of replacement land or goods and services, will be provided at 1.5 times the market value of the easement area.

Our office reviewed the referenced projects in accordance with Chapter 267, Florida Statutes, and implementing state regulations, for possible effects on historic properties listed, or eligible for listing, in the National Register of Historic Places, or otherwise of historical, architectural or archaeological value.

It is the opinion of this office that the proposed project is unlikely to affect historic properties. However, unexpected finds may occur during ground disturbing activities, and we request that the project include the following special condition regarding inadvertent discoveries:

• If prehistoric or historic artifacts, such as pottery or ceramics, projectile points, dugout canoes, metal implements, historic building materials, or any other physical remains that could be associated with Native American, early European, or American settlement are encountered at any time within the project site area, the permitted project shall cease all activities involving subsurface disturbance in the vicinity of the discovery. The applicant shall contact the Florida Department of State, Division of Historical Resources, Compliance Review Section at (850)-245-6333. Project activities shall not resume without verbal and/or written authorization. In the event that unmarked human remains are encountered during permitted activities, all work shall stop immediately and the proper authorities notified in accordance with Section 872.05, *Florida Statutes*.

According to the office of Greenways and Trails, an average of 12,000 users access this trail per month.

4. Description of the natural resources, land cover, vegetation, habitat or natural community, if any, that are currently present on the parcel.

To the best knowledge of the Seminole County Land Management Office, this trail is home to an abundance of native flora and fauna, as well as, gopher tortoise and bald eagles. As the managing partner, we are committed to preserving the aforementioned in their present condition/habitats which will remain undisturbed.

5. Description and list of the imperiled and other wildlife species, if any, that occur on or use the parcel.

According to the Cross Seminole Trail, Land Management Plan and Operational Report, the following wildlife habitat the corridor: gopher tortoise, indigo snake, Florida mice, gopher frogs, bald eagles, yellow rat snake, eastern coral snake, bobcat, turkey vulture, and osprey.

6) Description and list of historical or archaeological resources, if any, that occur or have the potential of occurring on the site.

No archeological resources have been identified along the subject corridor or have been encountered during construction.

7) Formal alternative siting analysis that includes a description and assessment of other potential alternative sites and why they are not feasible or practicable alternatives.

This easement is being requested within the area of an existing crossing for road widening purposes.

8) Assessment of the impacts the proposed alternative use will have on the natural/historical/archaeological/recreational resources, if any, as well as on the current public use and purpose for the site or parcel.

A wetland exists directly adjacent to SR 417.

The affected area is utilized as a recreational, educational, conservation corridor, as long as the trail remains open and the native flora, fauna and wildlife habitats are undisturbed, the impacts will be minimal.

9) Assessment of the potential impacts on the larger area of conservation lands the parcel is located within (park, wildlife management area, forest trail, etc.) and on any surrounding conservation lands, if any.

As noted in the Cross Seminole Trail Land Management Plan and Operational Report, construction of the CSX rail corridor impeded, but did not adversely affect drainage quantities, due to the construction of a swale and culvert system. Recent new home development and the extension of the Greeneway (SR 417) have had the greatest negative effect on the area's drainage system.

10) Assessment of how the proposed package of consideration and net positive benefit for the requested alternative use of the parcel, such as the generally standard requirement for replacement land (depending on the parcel's size), will offset the impacts and benefit the larger area of conservation lands (park, forest, wildlife management area, trail system, etc.) the parcel is within and particularly how it will offset the impacts or benefit the natural/historical/archaeological resources, habitat and public recreational uses of the public conservation area the parcel is located within.

> The County will coordinate with the Division of State Lands to determine the amount of NPB and the County will coordinate with FDOT on how to satisfy the NPB.

It will be the responsibility of the managing agency on whose property a non-conservation or non-public recreation use is proposed to have staff at ARC meetings who will be able to answer questions about the effect of that proposed use on the lands that they manage and about their justification for agreeing to allow it. BPLA staff will continue to present the items, but managing agency staff should be ready to answer any questions related to the resources and recreation on the site and the effects of proposed uses.
