A. Certification by a Community Water System (CWS)

I am duly authorized to sign this report on behalf of the CWS identified in Part I of this report. I certify that the CWS performed the following checked public education tasks on/during:

Delivered printed materials meeting the content requirements of 40 CFR 141.85(a)(1), 141.85(a)(2), and 141.85(b)(1) (2009) to all bill paying customers.

Delivered education materials that met the content requirements of 40 CFR 141.85(a)(1), 141.85(a)(2), and 141.85(b)(1) (2009) to local public health agencies even if they are not located within the water system's service area, along with an information notice that encouraged distribution to all the organization's potentially affected customers or community water system's users. ** A community water system (CWS) shall perform the public education tasks listed in, and shall complete, Part II.A of this report unless the CWS is serving a facility (such as a prison or hospital) where the population served is prevented from making plumbing improvements and is not separately charged for water consumption, in which case the CWS may perform the public education tasks listed in, and may complete, Part II.B of this report. A non-transient-non-community water system shall perform the public education tasks listed in, and shall complete, Part II.B of this report.*

INSTRUCTIONS: This report shall be completed and submitted by community or non-transient non-community water systems that exceed the lead action level based upon tap samples and that, therefore, are subject to the public education requirements in 40 CFR 141.85 (2009). **WITHIN 60 DAYS AFTER THE END OF THE LEAD AND COPPER MONITORING PERIOD IN WHICH THE LEAD ACTION LEVEL WAS EXCEEDED, A WATER SYSTEM IS REQUIRED TO PERFORM PUBLIC EDUCATION TASKS IN ACCORDANCE WITH 40 CFR 141.85(b) (2009).** Within 70 days after the end of the lead and copper monitoring period in which the lead action level was exceeded, the water system shall complete this report and submit it to the appropriate Department of Environmental Protection District Office or Approved County Health Department. For systems that are on a reduced lead and copper monitoring period, the end of the lead and copper monitoring period is September 30th of the calendar year in which the sampling occurred. All information provided in this report shall be typed or printed in ink.
