THE PERMITTEE IS REQUIRED TO SUBMIT THE FOLLOWING ITEMS:

2. A table containing the result of vegetation survey, showing location, species, coverage and condition of native beach-dune vegetation, the degree and extent of disturbance of the vegetation, and the degree and extent of compliance with permit requirements [paragraph 62B-56.140(5)(b)]
3. Project photograph (preferably taken from the same location each year), dated and taken at three points along the site (See attached sketch for guidance).
4. Provide a description of the maintenance activities since last report, in accordance with the terms and conditions of the permit. Include fill placement, repairs and planting activities.

Instructions:

The responsible entity shall provide for the inspection of the reconstructed dune at least once every year after conversion of a permit to the maintenance phase to verify that the core of the reconstructed dune feature is covered with a minimum of 3 feet of sand and native beach-dune vegetation is established and maintained as specified in the permit. A report describing the results of the inspection must be filed with the Department within 30 days after the inspection.

Inspections shall be conducted in consideration of state nesting and federally endangered and threatened species and nesting activity, and as specified in the permit.

The sand depth shall be measured at 50-foot intervals along the seaward edge of the reconstructed dune and at 10-foot intervals along each profile line at 50 foot intervals from the seaward edge of the reconstructed dune to its landward limit. If there is less than the required depth of sand cover over the core structure, the responsible entity shall place beach compatible sand over the core structure to reestablish the required depth of sand cover prior to the start of the marine turtle nesting season and in consideration of state nesting and federally endangered and threatened species. The sand placement shall be in accordance with the terms and conditions of the approved permit. [Section 62B-56.140(5), F.A.C.]

All work performed as of this date is described above and is hereby certified to be in compliance with the project description and plans approved by the Department of Environmental Protection as part of the permit and with all conditions of the permit. Locations and elevations of all construction as of this date have been specifically verified as applicable and have been found to comply with the project description, approved plans, and conditions of the permit.
