#### **OVERVIEW**

The Florida Communities Trust (FCT), created by Chapter 380, Florida Statutes (F.S.), is a state-funded land acquisition program within the Florida Department of Environmental Protection's (DEP) Division of State Lands.

FCT assists communities in protecting natural resources, providing recreational opportunities and preserving Florida's traditional working waterfronts through the Parks and Open Space and the Stan Mayfield Working Waterfronts grant programs. Through a competitive application process, these programs provide funding to local governments and eligible nonprofit organizations to acquire land for parks, open space, greenways, and projects supporting Florida's seafood harvesting and aquaculture industries.

FCT is governed by a five-member board with the Secretary of DEP or their designee serving as chair. Also serving are four members of the public appointed by the Governor, which include a former elected official of a metropolitan municipal government; a former elected official of a county government; a representative of a nonprofit organization that has among its principal goals the conservation of natural resources or protection of the environment; and a representative of the development industry.

#### PARKS AND OPEN SPACE PROGRAM

FCT's Parks and Open Space Program assists communities in meeting the challenges of growth, supporting viable community development, and protecting natural resources and open space.

This program requires local governments to provide a minimum 25% match, except for small local governments. FCT awards 100% grants to small local governments, which are defined as municipalities with a population of less than 10,000 and counties with a population of less than 75,000.

Projects funded under this program provide land for recreational opportunities to enhance the health and well-being of Florida residents. The majority of FCT's projects meet one or more of the following objectives to implement local government comprehensive plans:

- Provide conservation lands.
- Provide urban open spaces.
- Provide public parks.
- Provide greenways.

After a project has been acquired by the grant recipient, FCT stewardship continues in perpetuity through a formal agreement to provide guidance on park development and management oversight. This is accomplished through annual stewardship reporting and site visits.

During this reporting year, FCT staff reviewed 15 project applications for funding under the Parks and Open Space Program. Utilizing funding from Fiscal Year 2018-19 and FY 2020-21, 10 projects were funded and are in various stages of acquisition. Once completed, these 10 projects will provide more than 400 acres for conservation and outdoor recreation.

Meanwhile, two projects closed – Rocky Creek Trails and Wellington Environmental Preserve – and the grant recipients were reimbursed. FCT awarded Hillsborough County (Rocky Creek Trails) \$825,000 in grant funding to acquire 10.10 acres. The project site for Rocky Creek Trails will provide recreational trail opportunities as well as environmental education about the site's natural resources. The Village of Wellington (Wellington Environmental Preserve) was awarded \$3,386,250 in grant funding to acquire 45.02 acres. The project site for Wellington Environmental Preserve will provide recreational trails, picnic facilities and access to waterbodies in the preserve. Educational programming will be expanded to increase awareness of significant resources such as the Everglades.

#### STAN MAYFIELD WORKING WATERFRONTS PROGRAM

The preservation of Florida's rich history in the traditional seafood harvesting and aquaculture industry was the inspiration behind the creation of FCT's Stan Mayfield Working Waterfronts Program.

This program provides grant funding for the acquisition of land for the restoration and preservation of working waterfronts that directly support the commercial harvest of marine organisms. While this program does not require a match, it does award extra points to an application if a 25% or more match is provided.

Funding may also be used to acquire land for exhibitions, demonstrations, educational venues, civic events, and other purposes that promote the economic, cultural and historic heritage of Florida's traditional working waterfronts. To date, the program has invested nearly \$7 million to restore more than eight acres of traditional working waterfronts.

During FY 2022-23, one grant application was received for the Stan Mayfield Working Waterfronts Program. The application for the Blue Crab Cove, Phase Two project was approved by the FCT Governing Board and the Board of Trustees of the Internal Improvement Trust Fund. Located in Brevard County, the 0.96-acre site will serve as an expansion to the original site acquired in 2010. This phase will expand the use of the property to include a marine education center and maritime museum, along with an aquaculture and nursery support facility. Brevard County was awarded \$1.4 million to purchase the site. Once acquired, the site will be preserved as a working waterfront and aquaculture support center in perpetuity.
