## **Natural Resources**

The park contains 10 distinct natural communities:

- Mesic Flatwoods
- Depression Marshes
- Flatwoods
- Dome swamps
- Hydric Hammock





## Natural Resources

Atlantic Ridge Preserve State Park protects and provides habitat for 3 imperiled plants and 8 imperiled animals including:

- American alligator
- Wood stork
- Banded wild pine
- Florida manatee





## **Natural Resources**

31 exotic plant species listed by the Florida Exotic Pest Plant Council have been observed at the park including:

- Bishop wood
- Australian pine
- Air-Potato
- Old World climbing fern





## **Resource Management**



## **Resource Management Objectives**

#### **Natural Communities Management**

- Maintain 4,613 acres of the park with fire in 10 years
- Restore 464 acres of abandoned pasture

### **Imperiled Species Management**

• Monitor gopher tortoises

### **Exotic Species Management**

- Annually treat up to 1,628 gross acres of various exotic plant species
- Implement control measures on feral hogs






### **Conceptual Land Use Plan**

The objective in park planning is to achieve a <u>BALANCE</u> between preserving natural conditions and providing public access for recreation purposes.
