All samples to date have shown no impacts related to process water from the sinkhole at the Mosaic New Wales facility. While most wells have met applicable federal Safe Drinking Water Act standards, DEP and DOH continue to work with homeowners to follow-up on additional testing and to review treatment options for any wells with safe drinking water concerns.
