FCHAP Board members maintain an open line of communication during monthly meetings and in-between. The continued support for the maintenance and repair of the volunteer water quality instruments helps supplement the CHAP budget, especially with the increasing costs of supplies. The FCHAP Board Members are interested in the current events and challenges facing the CHAP managed areas, and aquatic preserves throughout the state. The FCHAP board is collaborative with activity planning and report filing. Overall, the CHAP manager appreciates the continued support from FCHAP, and looks forward to another productive year of partnership.

**CSO President's Comments on the CSO & ORCP Relationship and Support:**

Recovery from Hurricane Ian impacts continued to be the focus of CHAP staff. The FCHAP Board provided fiscal support when needed to repair and /or replace equipment and supplies.

The Board added a new Director in 2023, Annisa Karim, who has extensive local and regional experience with resource management.

FCHAP assisted the CHAP staff with the preparation of a grant application for funds to support oyster reef restoration.

FCHAP collaborated with CHAP manager to develop an annual budget on 2023 expenses and anticipated 2024 projects. The funds in the FHCAP restricted accounts are sufficient to cover costs, and the unrestricted funds are sufficient to cover expenses not allocable to the restricted funds.

CHAP hired a new staff, FCHAP provided a stipend for the candidate who was hired to cover travel expenses for the in-person interview.

In 2023, the FCHAP website was updated, and project information provided by CHAP staff was uploaded. The Board decided to migrate responsibility for the website upkeep and security to vendor who is providing services on an as-needed basis. The Board appreciates the time, expertise and skills of Board member Maran Hilgendorf who has been our IT specialist.

John Aspeolea, the Charlotte Harbor Preserve State Park manager passed away. This was a blow to the Board, there was a long relationship with John dating back to when the buffer lands were under the stewardship of CHAP. Subsequently, Jay Garner, CHPSP staff, retired; Jay provided on-site restoration tours and presentations to FHCAP members.

CHAP staff has been extremely responsive to the Board's requests for updates about on-going research in the aquatic preserves and anticipated permit requests.
