- III. Water Conservation
- IV. Energy Efficiency
- V. Indoor Air Quality

All new environmental practices must be implemented prior to submitting the renewal application.

This application can be completed electronically. Input the required data into the fields and use the check boxes where applicable. Once completed, save a copy as a .pdf and submit it, along with any required documentation, to GreenLodging@floridadep.gov. The Florida *Green Lodging* Program will evaluate your application and documentation, and notify you of your renewal status.
