- V. Indoor Air Quality

All new environmental practices must be implemented prior to submitting the renewal application.

When completed, save a copy as a .pdf and submit it, along with the required documentation, to GreenLodging@FloridaDEP.gov. The Florida *Green Lodging* Program will evaluate your application and documentation and notify you of your renewal status.
