Dear Dr. Shirley,

This letter is a follow-up to the December 21, 2023, decision letter by the NOAA Office for Coastal Management approving changes to the Florida Coastal Management Program (FL-2023-1). In discussions with your staff regarding the decision letter, an inadvertent error in the Table of Approved Changes was brought to our attention.

In the state's associated program change submission, it requested approval of section 379.101, F.S., as amended, to clarify the definitions of "marine fish" and "saltwater fish" to reflect updates in the scientific classification. Clear, accurate definitions are essential in the enforcement of Florida's fishing regulations, however, the Office for Coastal Management inadvertently indicated on the Table of Approved Changes, that this provision was not an enforceable policy. We are hereby correcting this error and providing notice that this program change is approved as necessary detail in the applying the enforceable policies of the Florida Coastal Management Program. The Table of Approved Changes has been revised to designate section 379.101, F.S., as an enforceable policy and is attached to this letter.

NOAA's regulations require that the state post this letter for public notice. ¹ The public notice should state that the enforceable policies identified in the attached Table of Approved Changes shall be applicable in reviewing federal actions pursuant to the federal consistency requirements of the CZMA and its implementing regulations found at 15 CFR part 930.² Please send a copy of the public notice to the Office for Coastal Management for our records to close out this file.
