<b>QUESTION</b>	<b>ANSWER</b>
I am a seafood dealer and will be submitting an application. I also am a minority owner in a small marina property. I own 1/3 of the real estate but none of the business. Is that marina business eligible to apply for a grant? The ppty is in a Working Waterfronts community.	Yes.
<b>QUESTION</b>	<b>ANSWER</b>
It may be difficult to get two quotes for some projects. Do both have to be included with the application's submittal? Or is it possible to update the application with this information once available?	Quotes will need to be provided upon application submission.
<b>QUESTION</b>	<b>ANSWER</b>
How much funding is available this year?	250,000 per grant
<b>QUESTION</b>	<b>ANSWER</b>
Does Marti have an email address that I can send business info to?	smworkingwaterfrontsco@floridadep.gov
<b>QUESTION</b>	<b>ANSWER</b>
We use a business owned truck and trailer to transport seafood in large coolers to the seafood dealer, but it is not refrigerated. Can we replace our current vehicle and trailer with this grant?	Yes.
<b>QUESTION</b>	<b>ANSWER</b>
We submitted for the grant last year and said we were approved but out of funds and would let us know if funds be came available. Funding did not come available and we have proceeded in doing the work. We are just finishing some of the work and in the middle of some of other work, so am I correct to understand that we would not be eligible to get reimbursed for that work since we have already began the work?	That is correct. Unfortunately, work that has already begun or been completed prior to an executed grant agreement is not eligible for reimbursement under this grant program. Only expenses incurred after the execution of the grant agreement are allowable.
<b>QUESTION</b>	<b>ANSWER</b>
Is the fixed capital outlay grant used for water adjacent properties only?	No.

QUESTION	ANSWER
What dates are we supposed to use for the timeline of repairs? The execution period? September 1-15?	The dates of which you expect the work to be performed and completed.
QUESTION	ANSWER
Can I access the application before Aug 1 in order to give time to make sure everything is complete and ready to send? Is it a printable application I can fill out in order to review if need to?	No. The application will not be available until 5am on Friday, August 1, 2025.
QUESTION	ANSWER
If I have a processing and freezing facility that is not on the water-front, can funds be used for the processing facility as well? This facility is not on our waterfront facility due to size limitations of our bulkhead and waterfront property.	Yes.
QUESTION	ANSWER
So I can use an address that is not waterfront if it is a seafood processing and freezing facility that supports the unloading dock?	Yes.
QUESTION	ANSWER
If we are utilizing this for a boat motor/equipment what section/location information would we use? The marina we are docked at?	Based on the application process, the project location of where the work will be performed should be used.
QUESTION	ANSWER
Good morning when will this recording be posted/shared?	This recording will be shared after the webinar.
QUESTION	ANSWER
Good morning - I did not notice any differences between this year's grant and last year's. Are there any?	The 2025–2026 grant cycle follows the same core structure and eligibility criteria as the previous cycle, with only minor updates. These updates are fully outlined in the current Application Guidance, which we encourage you to review as it reflects the most accurate and up-to-date requirements.
QUESTION	ANSWER
I have two boats, each under a separate LLC. I have one general liability policy. Will the same policy be acceptable for both applications?	If the policy shows coverage for both, yes.

I do not have a Worker's Comp policy, as it doesn't pertain to me. What do I do?	If not applicable, then you are not required to provide this information. Case-by-Case basis

I have one question pertaining to the requirement of multiple quotes for any specific facet of the project	Please list your question specifically or follow-up via email for further assistance.
QUESTION	ANSWER
What if we are purchasing very specific equipment that is only manufactured by one company? Can we submit a quote for comparable equipment even if it is not exactly what we need?	Please do your best to complete comparative quotes, if you have further issues providing the additional quotes, please contact Marti Harsey for assistance.
