FLORIDA COMMUNITIES TRUST PROJECTS UNOPEN ASSESSMENT REPORT

During the summer of 2023, FCT Staff conducted a survey of 547 project sites – individual units acquired with the assistance of FCT grant funds. Some sites include multiple grant awards due to phased acquisition projects.

The purpose of this survey was to determine grantee compliance with the conditions of their management plans and special management conditions. Two indicators were evaluated using the survey, whether project sites were open to the public and the extent to which the project sites have been developed per the approved management plans.

The survey results were acquired via Alchemer Survey program, email, and direct phone call. During the course of the survey, Staff has updated contact information, provided technical assistance regarding post-completion stewardship responsibilities and identified additional resources for management plan completion and compliance needs.


The questions posed for this survey were as follows:

- 1. Is your project currently open to the public? (Yes/No)
- 2. On a scale from 0-100%, what percentage has been developed pursuant to your approved management plan?
- 3. (Optional) Provide any relevant comments on the completion of the project(s).

Results to the optional third question provided FCT Staff with a general idea of project compliance issues in meeting management requirements. This feedback allowed FCT Staff to better prioritize their time and efforts in responding to grantees. FCT Staff also received positive feedback regarding both project site success, as well as words of gratitude for FCT.

In the following charts, the term "Parks" refers to FCT project sites. Some sites include multiple grant awards due to phased acquisition projects.

This pie chart represents a summary of the responses with regard to FCT sites being open or unopen to the public.

Of the 547 sites: Approximately

91% have been stated Open to the public,

4% have been stated Unopen to the public.

5% of projects are not applicable due to the intent for conservation only status.

Of these sites that are not open, one is recorded as having sustained damage by Hurricane Idalia, and two are still recovering from Hurricane Michael.
