<u>ITEM 5</u>: Present the FCT 2022-2023 Annual Report

STAFF REMARKS:

Florida Communities Trust (FCT), created by Chapter 380, Florida Statutes is a state funded land acquisition program that assists communities in protecting natural resources, providing recreational opportunities and preserving Florida's traditional working waterfronts through the Parks and Open Space and the Stan Mayfield Working Waterfronts grant programs. Through a competitive application process, these programs provide funding to local governments and eligible nonprofit organizations to acquire land for parks, open space, greenways, and projects supporting Florida's seafood harvesting and aquaculture industries.

FCT's Parks and Open Space Program assists communities with challenges of growth, supports community development and protects natural resources. Projects funded under this program meet one or more of the following objectives to implement local government comprehensive plans. They include conservation lands, urban open spaces, public parks and greenways. After a project is acquired, FCT stewardship continues in perpetuity through a formal agreement to provide guidance on park development and management oversight.

The Stan Mayfield Working Waterfronts program provides grant funding for the acquisition of land for the restoration and preservation of working waterfronts that directly support the commercial harvest of marine organisms. Funding is also used to acquire land for exhibitions, demonstrations, educational venues, and other purposes that promote the economic, cultural and historic heritage of Florida traditional working waterfronts. Once acquired, the site will be preserved as a working waterfront and aquaculture support center in perpetuity.

The 2023 annual report includes 659 FCT project sites in 57 counties statewide for both Parks and Open Space and Stan Mayfield Working Waterfronts grant programs.

A copy of this year's final 2023 Annual Report was submitted to the Governor and Legislative leadership on September 25, 2023.

ITEM 6: Present the 2023 Projects Unopen Assessment Report

STAFF REMARKS:

During the summer of 2023, FCT Staff conducted a survey of 547 project sites – individual units acquired with the assistance of FCT grant funds. Some sites include multiple grant awards due to phased acquisition projects.

The purpose of this survey was to determine grantee compliance with the conditions of their management plans and special management conditions. Two indicators were evaluated using the survey, whether project sites were open to the public and the extent to which the project sites have been developed per the approved management plans.

The survey results were acquired via Alchemer Survey program, email, and direct phone call. During the course of the survey, Staff has updated contact information, provided technical assistance regarding post-completion stewardship responsibilities and identified additional resources for management plan completion and compliance needs.

Of the 547 sites surveyed, approximately 91% indicated open to the public, 4% have indicated unopen to the public, and 5% of projects were acquired with the intent for conservation only.

Of these sites that are unopen, one is recorded as having sustained damage by Hurricane Idalia, and two are still recovering from Hurricane Michael.

Two applications were received for the Stan Mayfield Working Waterfronts grant program during the October 1 through November 1, 2023, cycle. After a thorough review, the Spring Creek Revival Society, Inc application was deemed ineligible as the proposed project did not provide sufficient documentation as required per section 62-820.003, F.A.C. Staff reviewed the Business Summary along with comments received from the Department of Agriculture and Consumer Services. Based on this review, staff determined that the Business Summary is sufficient for the application. Site visits confirmed the conditions presented in the application.
