Dear President Passidomo and Speaker Renner:

I am pleased to submit the Annual Report on the Brownfields Redevelopment Act, as required by Section 376.85, Florida Statutes.

The Florida Brownfields Program facilitates redevelopment of properties and job creation within designated brownfield areas by providing incentives for voluntary environmental cleanup and protection of public health. The enclosed report is submitted each year to describe the Florida Department of Environmental Protection's (DEP) progress and level of activity in implementing the Florida Brownfields Redevelopment Act, established in 1997.

Highlights to date include the following:

- Since 1997, nearly \$454 million in confirmed investment and 16,099 confirmed net new direct jobs can be attributed to the program.
- Fifteen brownfield sites completed cleanup in 2022 and 10 brownfield sites have completed cleanup in the first six months of 2023. On average, since 1997, approximately nine brownfield sites complete cleanup each calendar year. There have been 219 brownfield sites that have completed cleanup since the inception of the program.
- There are 573 designated Brownfield Areas statewide, and as of June 30, 2023, there are 473 executed Brownfield Site Rehabilitation Agreements (BSRAs).
- DEP received 184 Voluntary Cleanup Tax Credit (VCTC) applications for 2022 calendar year expenses, and the approved tax credits totaled \$23.5 million. Of this total, \$22.7 million approximately 97 percent was allocated for tax credits for 171 brownfield sites.

#### **EXECUTIVE SUMMARY**

accordance with Florida's In Brownfields Redevelopment Act, a brownfield site is real property, the expansion, redevelopment or reuse of which may be complicated by actual or perceived environmental contamination. The Florida Department of Environmental Protection's (DEP) Brownfields Redevelopment Program, established 1997, empowers communities, in local governments and other stakeholders to work together to assess, clean up and reuse brownfields.

The two primary goals of the program are contaminated site cleanup and economic redevelopment. Since inception of the program in 1997, 219 contaminated sites have been cleaned up; approximately 89,976 confirmed and projected direct and indirect jobs have been created; and \$3.188 billion in capital investment is projected in designated brownfield areas.

Highlights and milestones for all of calendar year 2022 and the first six months of calendar year 2023 include:

- **Brownfield Areas:** Fifteen municipalities and county governments approved local resolutions that designated 21 additional brownfield areas in 2022, and four municipalities and county governments approved four additional brownfield areas in the first six months of 2023. The total number of brownfield areas in Florida has reached 573.
- **Brownfield Site Rehabilitation Agreements:** Thirty-five brownfield site rehabilitation agreements (BSRAs) were executed in 2022 and zero BSRAs have been executed in the first half of 2023, bringing the total number executed since program inception to 473.
- Site Rehabilitation Completion Orders: A total of 15 site rehabilitation completion orders (SRCOs) were issued in 2022 with 12 being conditional SRCOs (CSRCOs) and three being unconditional SRCOs. Ten SRCOs have been issued during the first six months of 2023. The SRCOs were issued for sites that completed cleanup of property to standards protective of human health and the environment. As stated earlier, since the inception of the program in 1997, the total number of SRCOs issued to date is 219, with 111 being issued as CSRCOs and 108 being unconditional SRCOs.
- Voluntary Cleanup Tax Credits (VCTC): DEP received 184 tax credit applications for 2022 calendar year expenses, and the approved tax credits totaled \$23.5 million. Of this total, \$22.7

million, approximately 97 percent, was allocated for tax credits for site rehabilitation work completed at 171 brownfield sites. Since 2008, the approved tax credits have exceeded the available authorization. The Legislature increased the annual tax credit authorization from the initial amount of \$2 million to \$5 million in 2011, and then to \$10 million in 2017. Additionally, there have been multiple one-time, supplemental authorizations to address the growing backlog of approved tax credits.

New Jobs: From Jan. 1 through Dec. 31, 2022, 75 projected new direct jobs, 212 projected new indirect jobs, and more than \$47.9 million in projected new capital investment were attributable to the Program. Between 1997 and end of calendar year 2022, nearly \$454 million in confirmed investment and 16,099 confirmed net new direct jobs can be attributed to the Program.<sup>1</sup>

#### **INTRODUCTION AND HISTORY**

Many areas in Florida contain sites with actual or perceived environmental contamination that may present a significant barrier to redevelopment. The Florida Brownfields Redevelopment Act, Sections 376.77-376.86, Florida Statutes, was adopted by the Florida Legislature in 1997 to provide incentives for local governments and individuals to voluntarily clean up and redevelop brownfield sites. Participation in the program results in environmental cleanup, protection of public health, reuse of infrastructure, and job creation.

#### Florida Brownfields Redevelopment Program Objectives

- Site rehabilitation.
- Job creation.
- Increased capital investment.
- Broadened tax base by raising property values.
- Better utilization of existing infrastructure and community resources.
- Improvements in quality of life and the environment.

Local governments play a key role in the program by designating brownfield areas by resolution. Upon designation, owners and/or responsible parties of properties within a brownfield area may seek eligibility for the various financial and regulatory incentives when entering into a BSRA. These financial and regulatory incentives enable local governments and state agencies to partner with the private sector to rehabilitate contaminated properties, create jobs, and promote sustainable reuse of properties within designated brownfield areas.

- A **brownfield area** is defined by statute as "a contiguous area of one or more brownfield sites, some of which may not be contaminated, and which has been designated by a local government by resolution."
- A **brownfield site** is defined by statute as "real property, the expansion, redevelopment, or reuse of which may be complicated by actual or perceived environmental contamination."


Since passage of the act, DEP has provided education and outreach to a variety of interest groups, including communities, environmental consultants, lenders, local governments, economic redevelopment boards, community redevelopment agencies, attorneys and real estate professionals. DEP has also provided technical assistance and streamlined regulatory services to program participants.

Data presented in this report were collected through June 30, 2023, the end of the state fiscal year. Because most of the data for brownfields and brownfields-related programs (i.e., VCTC and the brownfields redevelopment bonus) is collected on a calendar year basis, the information herein is presented for calendar year 2022 and for calendar year 2023 to date (i.e., through June 30, 2023).

### **BROWNFIELDS REDEVELOPMENT PROGRAM STATUS**

#### Florida Designated Brownfield Areas

Local governments continue to support the use of the tools and incentives provided by the program by designating brownfield areas for cleanup and revitalization. Upon designation, properties within a brownfield area have met the first requirement for participation in the program. These properties may participate in economic incentives that are linked to a BSRA, including the job bonus tax refund or refunds on sales and use tax paid on the purchase of building materials used in a mixed-use project or housing project.<sup>2</sup> If contamination is known or suspected, the local government may designate an area and identify the *person responsible for brownfield site rehabilitation* (PRFBSR). This entitles the identified person to negotiate a BSRA with DEP.



Note: Data for 2023 represents the period from January 1 through June 30, 2023.

In 2022, 15 local governments reported approval of resolutions designating 21 brownfield areas. During the first half of 2023, four local governments have designated five brownfield areas. Since the program's inception, Florida has amassed 573 designated brownfield areas in 158 communities across the state, averaging 22 newly designated brownfield areas each year (Figure 1). The 573 locally designated brownfield areas encompass approximately 292,074 acres representing a combination of contaminated and uncontaminated properties, including residential and viable business properties. **Appendix A** contains a "Brownfield Areas" table that lists the name, location, approximate size (acreage) and the resolution date of each brownfield area in the state. The resolution date is the date upon which the local government with jurisdiction over the area adopted its resolution designating the brownfield area pursuant to Section 376.80, F.S.

#### **Brownfield Site Rehabilitation Agreements**


Once a local government designates a brownfield area and a PRFBSR is identified, this entity may voluntarily execute a BSRA with DEP. The BSRA provides DEP and the public with assurance that site rehabilitation will be conducted in accordance with Florida Statutes and DEP's Contaminated Site Cleanup Criteria rule.<sup>3</sup> In addition, the BSRA provides limited liability protection for the voluntary responsible party. The BSRA contains various commitments by the voluntary responsible party, including milestones for completion of site rehabilitation tasks and submittal of technical reports and plans. It also contains a commitment by DEP to review technical reports according to an agreed-upon schedule. Through June 30, 2023, voluntary responsible parties have executed 473 agreements with DEP since inception of the program in 1997. Thirty-five BSRAs were executed in 2022 while none have been executed so far in 2023 (Figure 2).



Note: Data for 2023 is compiled from Jan. 1 through June 30, 2023. Historically, the majority of BSRAs are executed during the final quarter of each calendar year.

#### Site Rehabilitation Completion Orders Issued

SRCOs are issued for sites that have completed cleanup of property to standards protective of human health and the environment and for which no further action (NFA) is required at that time. In 2022, 15 SRCOs were issued for brownfield sites across the state. During the first half of 2023, 10 SRCOs have been issued (Figure 3), bringing the total number of SRCOs issued since 1997 to 219.


**Appendix B** contains a "Sites with Executed BSRAs" table that provides the name, location and approximate size of each brownfield site in the state with an executed BSRA. The table includes a completion date for sites that have received an unconditional SRCO or a CSRCO. A CSRCO is issued when DEP has approved alternate cleanup target levels (ACTLs) that are protective of human health, public safety and the environment for a site, and/or the voluntary responsible party has agreed to use institutional controls, and if appropriate, engineering controls to eliminate exposure to contaminants.

### Status of State Financial Incentives

#### Voluntary Cleanup Tax Credit

In 1998, the Florida Legislature established the VCTC program to provide an incentive for the voluntary cleanup of drycleaning solvent-contaminated sites and brownfield sites in designated brownfield areas (Section 376.30781, F.S.). Only those brownfield sites with an executed BSRA are eligible to apply for a VCTC incentive pursuant to Section 376.30781, F.S.

At these eligible sites, a tax credit of 50 percent is allowed for the cost of voluntary cleanup activity that is integral to site rehabilitation with a maximum of \$500,000 per site per year. Additionally, at brownfield sites with executed BSRAs in designated brownfield areas, a one-time 50-percent tax credit is allowed for solid waste removal with a maximum of \$500,000 per site. Tax credits may be applied to state corporate income tax and are eligible for a one-time transfer within a five-year period. The VCTC program has approved approximately \$178.5 million in tax credits since it began more than 20 years ago.



Note: Effective July 1, 2011, the annual authorization was increased from \$2 million to \$5 million. Effective July 1, 2017, the annual authorization was increased to \$10 million. There have also been multiple one-year, supplemental increases to address the growing backlog.

The brownfields and VCTC programs have been successful in promoting and realizing the cleanup and redevelopment of contaminated, underutilized properties throughout Florida. As a result, starting with applications for the 2007 calendar year, the approved tax credits have exceeded the available authorization (as shown on Figure 4). The Legislature increased the annual tax credit authorization from the initial amount of \$2 million to \$5 million in 2011, and then to \$10 million in 2017. Additionally, there have been multiple one-time, supplemental authorizations to address the growing backlog of approved tax credits. During the 2023 legislative session, the annual authorization was increased from \$10 million to \$35 million, effective July 1, 2023.

As of July 1, 2022, there was approximately \$18.2 million in approved tax credits; after the authorization was used to issue certificates, approximately \$8.2 million was carried over as the backlog. DEP received 184 VCTC applications for 2022 calendar year expenses, and the approved tax credits totaled \$23.5 million. Of this total, \$22.7 million – approximately 97 percent – was allocated for tax credits for 171 brownfield sites.

#### • Other State Financial Incentives – FloridaCommerce

The act also provides other financial and economic incentives administered by the Florida Department of Economic Opportunity (DEO), now known as FloridaCommerce, including the brownfields redevelopment job bonus tax refund.

For the brownfields redevelopment job bonus tax refund, FloridaCommerce enters into incentive agreements with eligible entities that plan to create new jobs in Florida brownfield areas. As a result of the passage of Senate Bill 406 (Chapter No. 2013-42, Laws of Florida), effective July 1, 2013, in order to be eligible to participate in the job bonus tax refund, an entity must be creating jobs on a property that is subject to a BSRA or on a property that abuts a property that is subject to a BSRA. A certified business may be eligible to receive up to \$2,500 in tax refunds for each new job created. To qualify, the business must be a qualified target industry (QTI) business as defined in Section 288.106, F.S., or make an eligible capital investment of at least \$2 million, create at least 10 jobs and provide benefits to its employees. The term of an incentive agreement is typically four or five years, with job creation or maintenance requirements in each year of the agreement. Payment of eligible tax refunds are subject to the satisfaction of the requirements set forth in the agreement.

For this report, FloridaCommerce has provided projections for job creation and capital investment associated with current agreements. In addition, FloridaCommerce has provided confirmed data for job creation and capital investment for projects with an executed agreement for the brownfields redevelopment job bonus tax refund program and the QTI with brownfield bonus tax refund program since the inception of the program (Table 1).

Note: \*\*Claims for job bonus tax refunds are submitted in January following the year the jobs were created. Claims for 2022 jobs were received in January 2023 and are currently being evaluated and confirmed. Therefore, the most recent confirmed jobs data is for the period ending December 31, 2021.

#### • Other State Financial Incentives - DOR

The Florida Department of Revenue (DOR) offers a refund on sales and use tax paid on building materials used in the construction of a qualified home, affordable housing or mixed-use affordable housing projects built on or abutting a site with a BSRA. Interested parties must complete an application for refund – sales and use tax (Form DR-26S) along with the Florida Neighborhood Revitalization Program application for sales and use tax (Form DR-26RP). These forms, along with any required attachments, must be filed within six months after the date the local building inspector determines the qualified home, housing or mixed-use project is substantially completed.

DEP's <u>Brownfields Redevelopment Program website</u> provides the latest program-specific information and links to websites for FloridaCommerce, DOR, local governments, the U.S. Environmental Protection Agency's Brownfields Program and other federal agencies involved in partnering for the redevelopment of brownfields.

#### **EPA** Memorandum of Agreement

The current memorandum of agreement (MOA) between DEP and EPA that specifies the criteria under which EPA will forego its oversight of cleanups in Florida was amended and executed on Nov. 28, 2005. Florida is one of approximately 25 states with an existing MOA with EPA. Through the MOA, certain sites subject to corrective action under federal Comprehensive Environmental Response Compensation and Liability Act (CERCLA) and Resource Conservation and Recovery Act (RCRA) authority are eligible for state brownfields incentives.

Additionally, to be eligible to receive CERCLA Section 128(a) grant funding authorized by the federal Small Business Liability Relief and Brownfields Revitalization Act of 2002, a state must be a party to a voluntary response program with EPA or demonstrate that its response program includes, or is taking steps to include, the elements of a response program. Florida receives Section 128(a) funding under the State and Tribal Response Program (SRP) and Bipartisan Infrastructure Law (BIL) Grant. In 2022, DEP received \$611,172 in SRP grant funding and \$800,000 in BIL grant funding from EPA.

#### Florida's Brownfields Staff

#### • DEP Tallahassee and Six DEP Districts

The Brownfields Redevelopment Program is managed by key staff within DEP's Brownfields & CERCLA Site Screening Section – a subsection of the Division of Waste Management in Tallahassee – who work very closely with the brownfields coordinators in the six DEP districts across the state as well as the three delegated local programs. Funding for the administration of the program by Tallahassee staff is provided by the annual CERCLA 128(a) SRP Grant. <u>DEP Tallahassee and DEP district brownfields staff contact information is provided online.</u>

#### Delegated Local Brownfield Programs

Three county governments – Broward, Hillsborough and Miami-Dade – have received delegation from DEP to administer the Brownfields Redevelopment Program locally. The original delegation agreements with Broward and Miami-Dade counties were signed in 2000 and renewed in 2010 and 2020. The agreement with Hillsborough County was signed in 2004 and renewed in 2012 and 2020 to allow for the same timeline as Broward and Miami-Dade counties going forward. Delegated county staff contact information is provided online.

The success of the Brownfields Redevelopment Program is directly attributable to the contributions by the six DEP districts (Northwest, Northeast, Central, Southwest, Southeast and South) and the three delegated local programs. DEP appreciates the continued support and important work they provide.

#### **Public Outreach and Education**

As an ongoing responsibility of the program, DEP Tallahassee and district staff participate in frequent outreach and educational speaking engagements with various city and county organizations, trade shows and industry groups in addition to the annual conferences and workshop. Outreach highlights are as follows.

# • Florida Brownfields Association (FBA) Annual Environmental Justice Workshop, August 2022

The FBA Annual Environmental Justice Workshop, titled "Environmental Justice: Mission Impossible," was held on Aug. 1 and 2, 2022, in Port St. Joe, Florida. Approximately 60 participants joined state and federal experts to learn about environmental justice in communities and the benefits of Florida's Brownfield Redevelopment Program. There was a keynote speech given by state Sen. Lorrane Ausley as well as a panel discussion with Port St. Joe community leaders on the environmental justice challenges the area is facing. Additional presentations covered topics of historical perspectives, equitable development, health fields, and environmental justice leaders in training. A meet and greet was scheduled the night before the conference with the opportunity of a Port St. Joe community tour.

#### • FBA Annual Florida Brownfields Conference, October 2022

The FBA hosted its Annual Brownfields Conference on Oct. 25 and 26, 2022, in Sarasota, Florida. Due to a recent hurricane, DEP was unable to attend in-person but attended and presented virtually. Over 75 participants from regional government and engineering and environmental consulting firms joined state and federal experts to learn about the benefits of brownfields redevelopment as well as available assistance. The conference featured

concurrent sessions over two days, with keynote addresses from Sarasota Mayor Erik Arroyo; Nichole Rodgers, EPA Region 4; and Dr. Carlton Waterhouse, Deputy Assistant Administrator, EPA Office of Land and Emergency Management. Highlights of the conference presentations and panel discussions included a workshop on the Florida Brownfields Redevelopment Atlas, brownfields jeopardy, institutional and engineering controls, risk management, VCTC, environmental justice, and legislative and technical updates.

#### • FBA Annual Strategic Planning Session, February 2023

DEP management and brownfields and VCTC staff participated in the FBA's Annual Strategic Planning Session on Feb. 6, 2023, as part of the scheduled activities and speakers. Addressing questions from the audience were Tim Bahr (Waste Management Division Director); Billy Hessman (Brownfields Program Manager); Scott Sweeney (VCTC Program Manager); and Ian Carnahan (Office of General Counsel).

#### • Florida Association of Environmental Professionals Annual Symposium, May 2023

DEP management and brownfields staff joined the Florida Association of Environmental Professionals for its annual symposium on May 11 and 12, 2023. Environmental professionals from across Florida gathered to learn about new projects, share technical knowledge, network, and engage with leaders in environmental technologies and practice. Speakers included Jennifer Farrell (Waste Cleanup Program Administrator), Leah Smith (District and Business Support Program Manager), and Billy Hessman (Brownfields Program Manager).

#### • FBA Annual Florida Brownfields Conference, June 2023

The FBA hosted the Annual Brownfields Conference from June 19-21, 2023, in Orlando, Florida. Over 100 participants from regional government and engineering and environmental consulting firms joined state and federal experts to learn about the opportunities and technical assistance available in brownfield redevelopment as well as case studies and capacity building. The conference featured concurrent sessions over three days, with keynote addresses from Paul Owens, President, 1000 Friends of Florida, and Nichole Rodgers, EPA Region 4. Highlights of the conference presentations and panel discussions included brownfield incentives, VCTC, environmental justice, food production as a strategy, solid waste and cleanup funding, and legislative and technical updates.

As a means of facilitating public outreach and education, DEP's Brownfields Redevelopment Program website is kept up to date with the latest program-specific information. Not only providing links to our partners, the website also contains map images of all designated brownfield areas and copies of local government resolutions and executed BSRAs. Program-specific information can also be found using <u>DEP's Contamination Locator Map (CLM) website</u> and <u>Map Direct website</u>. These tools allow users to locate all sites that are currently under DEP's cleanup oversight, and the CLM website enables users to subscribe to an online service that provides updates on cleanup milestones.

#### FEDERAL BROWNFIELDS UPDATE

# Small Business Liability Relief and Brownfields Revitalization Act of 2002 & the BUILD Act of 2018

Policies that EPA developed during the 1990s were incorporated into law through passage of the Small Business Liability Relief and Brownfields Revitalization Act 2002. The brownfields law expanded EPA's assistance to the public and private sectors by providing new tools for promoting sustainable cleanup and reuse. The Brownfields Utilization, Investment and Local Development (BUILD) Act was enacted on March 23, 2018, as part of the Consolidated Appropriations Act 2018. The BUILD Act reauthorized EPA's Brownfields Program and made amendments to the 2002 Small Business Liability Relief and Brownfields Revitalization Act. Authorized changes affect brownfields grants, ownership and liability provisions, and state and tribal response programs. EPA began implementing the BUILD Act in 2018 and has now incorporated nearly all the BUILD Act provisions into current policies.

#### **Bipartisan Infrastructure Law: A Historic Investment in Brownfields**

The passage of the Bipartisan Infrastructure Law in November 2021 delivered the single largest investment in U.S. brownfields history. The law invests more than \$1.5 billion in brownfields over the next five years. Of this \$1.5 billion, investments include \$150 million in multipurpose grants; \$600 million in assessment grants; \$160 million in cleanup grants; \$150 million in revolving loan fund grants; \$30 million in job training grants; \$110 million in technical assistance (including targeted brownfield assessments); and \$300 million in cooperative agreements to state and tribal response programs. This funding will be used to spur revitalization in communities and will leverage 154,000 jobs and \$30.2 billion in other public/private funding.

Brownfields grants continue to serve as the foundation of EPA's Brownfields Program. The following grants support revitalization efforts by providing seed money for environmental assessment, cleanup and job training.

- Site-Specific Assessment Grants provide funding for brownfield inventories, planning, environmental assessments (hazardous and/or petroleum), and community outreach at one specific site. Grant amounts can range up to \$200,000 but with a waiver may be as much as \$350,000. Site-Specific Assessment Grant applicants may also apply for Community-Wide Assessment Grants; however, they may not apply as a member of a coalition. It was announced that EPA will not solicit requests for new Site-Specific Assessment Grants in the Fiscal Year 2023 grant competition. However, the agency encouraged entities that planned to apply for a Site-Specific Assessment Grant to apply for a Community-Wide Assessment Grant.
- Community-Wide Assessment Grants provide funding for the same activities as the Site-Specific Assessment Grants but for a designated target area consisting of multiple brownfield sites. An applicant may request up to \$500,000 to assess sites contaminated by hazardous substances, pollutants, contaminants (including hazardous substances co-mingled with petroleum) and/or petroleum. Communities may also apply for Site-Specific Assessment Grants; however, they may not apply as a member of a coalition.

- Coalition Assessment Grants provided funding to a group of three or more applicants such as municipalities, regional planning councils, and counties for assessment work related to hazardous substances and/or petroleum. The maximum grant amount was \$1 million. Coalition grant applicants were not able to apply for any of the other assessment grants.
- <u>Revolving Loan Fund (RLF) Grants</u> provide funding to capitalize loans and provide subawards that are used to clean up brownfield sites. Grant amounts can range up to \$1 million. These grants are awarded to successful new applicants every other federal fiscal year. Beginning in the FY 2022, only those entities that do not have an open Brownfields RLF cooperative agreement will be eligible to apply for funding. When current high-performing RLF recipients are selected for non-competitive supplemental funding, EPA may choose to award a new grant rather than extend the period of performance of the current cooperative agreement.
- <u>Small Community Technical Assistance Grants for States</u> provide training, technical assistance and/or research for small communities (population of 15,000 or less) in rural or disadvantaged areas. The grant amount ranges up to \$20,000 per community. Work is conducted by the state. The first of these funding opportunities became available in federal FY 2019-20.
- <u>Cleanup Grants</u> provide direct funding for cleanup activities at an eligible brownfield site that the applicant owns. Previously limited to \$200,000, the revised grant amount is now \$500,000 and applicants may request a waiver to request up to \$1 million, or up to \$2 million.
- Multipurpose Brownfields Grants provide funding for assessment and cleanup activities at one or more brownfield sites in the proposed area in which the multipurpose grant will be used. Grant amounts can be requested up to \$800,000, and the applicant should demonstrate how grant funds will be used to conduct a range of eligible activities.

#### 2023 Brownfield Competitive Grants Awarded to Florida

In May 2023, Brownfield Competitive Grants (totaling \$2.5 million) were awarded to eligible Florida recipients:

- 79<sup>th</sup> Street Corridor Neighborhood Initiative Inc., Miami, FL \$500,000 Community-Wide Assessment
- Palm Beach County, FL \$500,000 Community-Wide Assessment
- South Florida Regional Planning Council \$500,000 Community-Wide Assessment \$1,000,000 Revolving Loan Fund

EPA also provides Environmental Workforce Development and Job Training (JT) grants to provide a core training program that can include instruction in disaster site work; emergency response; asbestos work; lead renovation, repair and painting; confined space entry; integrated pest

management; blood-borne pathogens; Occupational Safety and Health Administration construction safety; oil spill supervision; hazardous material technician; hazardous waste operator; and Florida stormwater, erosion and sedimentation control inspection. The maximum grant amount was previously \$200,000; however, eligible entities are now able to request up to \$500,000. The Pioneer Bay Community Development Corp., Port St. Joe, Florida, received this grant in 2022 for \$199,790.

In addition to the grants described above, DEP received an SRP grant under CERCLA 128(a) in the amount of \$611,172. This is the 20<sup>th</sup> year in which DEP has received a SRP grant, with the amount awarded totaling over \$14.2 million. DEP also received an additional SRP cooperative agreement to be funded under the BIL in the amount of \$800,000. This BIL grant should last for five years and will total \$4 million. DEP also received a Small Community Technical Assistance Grant to provide reuse planning and technical assistance to the community of Tallevast, Florida, in 2022.

Since inception of the SRP grant and its predecessor program, and the BIL grant, DEP has assisted 107 applicants with 126 projects on contaminated (or potentially contaminated) sites. DEP uses the grants to pay for staff and contractors that provide brownfields services at eligible sites for local governments, nonprofit organizations and other eligible applicants. These services include assessment and cleanup activities. DEP also uses the grants to fund staff in Tallahassee who lead coordination of the Florida Brownfields Redevelopment Program. These staff produce and maintain information about the program, conduct outreach and education, coordinate with district and delegated brownfield program coordinators, review BSRAs and SRCOs, and proactively engage with the brownfields community.

In response to stakeholder input, starting in spring 2018, DEP also used SRP grant funding to initiate a project with the goal of better understanding the impacts of SRP funding in communities through brownfields redevelopment as well as through targeted brownfields assessment/site-specific assessments that may lead into future redevelopment. DEP has contracted with USF to lead a project that developed an online tool that will evaluate social and economic impacts. That online tool is now known as the Brownfields Redevelopment Atlas, an interactive GIS based tool available to the public on an online platform. Refinement and additional data are continuously being added to this tool, with new features being added, ground truthing of the spatial data analysis and modeling being done, and results being disseminated. The Brownfields Redevelopment Atlas is available online.

# FLORIDA BROWNFIELDS SUCCESS STORIES

#### **Brownfield Success Stories**

The success of the Florida Brownfields Redevelopment Program can be demonstrated by the completed projects – those that have gone through cleanup and reuse of previously underutilized properties and/or those that have achieved NFA status. The projects highlighted below have achieved NFA status and have been issued SRCOs between the period of July 1, 2022, through June 30, 2023. Cleanup was completed in accordance with DEP's Contaminated Site Cleanup Criteria rule (Chapter 62-780, F.A.C.).

Following the more recent successes is a historical table listing all completed projects from the program's inception through June 30, 2022 (**Appendix C**). <u>Full summaries for these projects</u> can be found on the DEP website.

## **Closure Success - Completed Projects**

#### Former Palm Aire Golf Course III

Location: Pompano Beach, Broward County Historical Use: Golf course Contaminants: Arsenic Reuse: Residential

On Dec. 30, 2016, Home Dynamics Vantage LLC executed a BSRA for the Former Palm Aire Golf Course III Brownfield Site. The site consists of 36.29 acres located on the northwest



corner of Atlantic Boulevard and Northwest 31st Avenue in Pompano Beach. The site adjoins the Former Palm Aire Golf Course Brownfield Site (BF061601001) to the south and the West Atlantic Boulevard Apartments Investors Brownfield Site to the east (BF061503001).

Comparable with the remainder of the former Palm Aire Golf Course redevelopment complex, site soils and groundwater are contaminated with arsenic from the application of arsenic-based herbicides. On April 13, 2017, a Soil Management Remedial Action Plan was approved. Presently, site rehabilitation has been completed with the construction of an engineering control, and redevelopment is ongoing. A Declaration of Restrictive Covenant was executed on June 30, 2020, and includes institutional and engineering controls to address remaining soil and groundwater impacts. A conditional SRCO was granted Nov. 30, 2022. Through the VCTC program, almost \$792,584 in corporate income tax credits has been granted to date for assessment and cleanup work.

The city of Pompano Beach has approved development of the site for 150 new single-family patio homes, a pool, cabana gazebos, tot lot, bicycle lane, and associated landscaping. The development will be known as Vantage at Palm Aire.



**Poinciana Crossing Green Reuse** 

Location: Fort Lauderdale, Broward County Historical Use: Railyard Contaminants: Arsenic, PAHs Reuse: Residential

The BSRA for the Poinciana Crossing Green Reuse Site, located at 1801 S.W. First Avenue in Fort Lauderdale, was executed on June 17, 2020, with Poinciana Crossing Ltd. The site was

historically used as a railyard, resulting in arsenic and polycyclic aromatic hydrocarbon contamination in soil and groundwater. The previous property owner rehabilitated the site to commercial/industrial standards for use as a proposed light rail maintenance facility until the project was canceled in 2018. Since then, the Housing Authority of the City of Fort Lauderdale acquired the property and worked with Poinciana Crossing to rehabilitate the site for residential use with an approximately \$37 million, 113-unit affordable and workforce housing development. Residential amenities for the project include a community/recreation room, a business center with computers and high-speed internet access, a fitness center, on-site laundry facilities and lush landscaping.

Poinciana Crossing started vertical construction of the development in late 2020 with additional contaminated soil management work and engineering control construction continuing through 2022, when Poinciana Crossing completed development. The residences are now occupied. A Declaration of Restrictive Covenant was recorded on Jan. 10, 2023, which includes a groundwater use restriction, maintenance of capped contaminated soils via engineering controls, and 2 feet of clean fill in landscaped areas. A conditional SRCO was granted March 2, 2023. Through the VCTC program, \$174,181 in corporate income tax credits were awarded for site rehabilitation work.

#### San Marco Crossing

Location: Jacksonville, Duval County Historical Use: Lumber yard, car dealership, manufacturing Contaminants: Arsenic, benzo(a)pyrene Reuse: Residential

The San Marco Crossing Brownfield Site is in a mixed commercial/industrial corridor to the



eastern side of Historic San Marco, south of downtown Jacksonville near the intersection of Philips Highway and Atlantic Boulevard. The property originally hosted a lumber company in the 1920s, a manufacturing site in the 1940s, a car dealership in the 1950s, and in the 1970s the property was converted to a church.

The city of Jacksonville approved a brownfield area designation on Nov. 20, 2017, and a Brownfield Site Rehabilitation Agreement (BSRA) was subsequently executed with DEP's Northeast District on Dec. 18, 2017. The development plan for the site was to redevelop it into a high-end residential apartment community with its architecture evoking some of its historical tie-ins to the railroad. Site assessment of the buildings revealed asbestos materials and areas of arsenic and benzo(a)pyrene equivalents (BAP) in the soil above Cleanup Target Levels. The area is seeing a lot of redevelopment activity and was designated an Opportunity Zone area in 2018 after the site work was underway.

Demolition and groundbreaking occurred in June of 2019. During site activities, underground storage tanks and hydraulic lifts were found buried on-site. At the completion of the excavation, contaminated soil was removed from the property and properly disposed of off-site. In certain areas, some of the contaminated soil was left in place and capped, utilizing engineering controls. Post remedial groundwater monitoring was conducted concurrently with site construction from June 2019 through February 2022. The construction activities faced external issues with named hurricane events and Covid shutdowns making the effort more challenging. The removal of contaminated soils, underground tanks and hydraulic lifts had a significant positive impact on the original groundwater contamination with all contaminant concentrations in groundwater showing a steady decrease and ultimately results below the Groundwater Cleanup Target Levels. The San Marco Crossing site (renamed Barlow) opened its doors to residents in July 2021. A CSRCO was issued on March 9, 2023.



#### **Peoples Gas – Gas Distribution Center**

Location: Tampa, Hillsborough County Historical Use: Gas distribution center Contaminants: Creosote (PAHs and VOCs) Reuse: Multipurpose

Peoples Gas System (PGS) owns the 50-acre property located between Ybor City and the Lee Roy Selmon Expressway in Tampa, Florida. The

property was operated as a gas distribution center beginning in 1895. Gas manufacturing ceased in 1959, and the plant was dismantled. Site assessment activities began in 1986 following a complaint of a strong odor originating from a ditch on-site that was being dug to install a water main. The sampling event that followed revealed a high concentration of creosote was present. By 1996, 11,456+ tons of byproduct coal-impacted soil were excavated and about 97,000 gallons of impacted groundwater/non-aqueous phase liquids were removed from the excavation. On Dec. 30, 2014, the DEP and PGS entered into a Brownfield Site Rehabilitation Agreement to "prep" the property for redevelopment. The contaminants of concern (COC) at this site include volatile organic compounds and polycyclic aromatic hydrocarbons, the major chemicals in coal-tar creosote. The rehabilitation of the site was split in to three phases. Currently, there is only one phase remaining for rehabilitation activities. The master redevelopment plan was approved in August of 2022. This plan includes a repurposed warehouse, up to 140,000 square feet of retail space, 500,000 square feet of office space, and almost 5,000 residences (over 300 residences will be affordable housing). Ground officially broke on this project March 6, 2023. The first apartment complex is scheduled to be completed sometime in 2024. The development is intended to be a pedestrian- and bicycle-friendly community with greenspace and walkability.

### Former TECO/Hendry Marine

Location: Tampa, Hillsborough, County Historical Use: Power plant Contaminants: Metals, PCBs, petroleum Reuse: Industrial

This brownfield site was formerly the power plant for Tampa Electric Company, TECO. TECO operated the power plant from 1938 to



2002. In addition to the power generation station, there was bulk fuel tank storage and associated pipelines at the site. Hendry Marine Industries Inc. bought the site from TECO for ship maintenance and repair. One condition of the sale was for Hendry Marine to enter the Brownfields Program to remediate site impacts. This ensured the cleanup of the site and reduced pollution liability for both TECO and Hendry Marine Industries.

The site is located along the Ybor Ship Channel at the Port of Tampa, with 3,200 feet of bulkhead along the property. Soil at the site was impacted by various metals, polychlorinated biphenyls (PCBs) and petroleum compounds above the Soil Cleanup Target Levels. Vanadium and petroleum compounds were present in groundwater above the Groundwater Cleanup Target Levels. Soils were placed under an engineering control of 2 to 4 feet of clean soil. Groundwater was monitored until the impacted area was reduced to a small, stable area. The site will be used for ship repair services, and the inland portion of the site may be leased for future industrial use.



## AHS at Biscayne Village

Location: Miami, Miami-Dade County Historical Use: Agricultural Contaminants: Arsenic Reuse: Residential

AHS at Biscayne Village LLC entered into a BSRA with Miami-Dade County for the development of a 216-unit, five-building, workforce housing apartment complex at Southwest 142nd Avenue and Southwest 288th Street (Folio # 30-7903-000-0300). The subject property was a vacant lot adjacent to the Florida Turnpike previously utilized for agricultural purposes. Site assessment activities documented arsenic above cleanup target levels in soil, but a site-specific background study demonstrated that arsenic in soil was consistent with background. An SRCO was issued on July 19, 2022.

Hawkins Park Green Reuse Site 2

Location: Miami, Miami-Dade County Historical Use: Auto repair, commercial Contaminants: Nickel Reuse: Manufacturing

A BSRA was executed by Hawkins Park Land LLC on March 16, 2017, for the property located at 1021 N.W. 21st St. in Miami. Previous site uses included retail, commercial, and automobile repair. Contaminants of concern include arsenic and nickel in the groundwater; however, the source of the nickel is the adjacent site to



the north, Former Alert Plating. A Site Assessment Report and Monitoring Only Plan were approved for the site on Oct. 14, 2016, and groundwater monitoring was completed. The site redevelopment consists of expansion of the existing Florida Bottling manufacturing facility. A restrictive covenant was recorded on March 14, 2022, and a conditional SRCO was issued on Jan. 9, 2023.



# **Diamedix Project**

Location: Miami, Miami-Dade County Historical Use: Industrial Contaminants: Metals, PAHs Reuse: Residential

PRH N Miami LLC entered a BSRA on Dec. 21, 2021, for the rehabilitation and redevelopment of the approximately 2.29-acre property. The historical use of the subject property has involved use as a cleaner (2162 N. Miami Ave.), a lumber/milling yard (2141 N. Miami Ave. and 30 N.E. 22nd St.), and paint warehouses (2127 & 2164 N. Miami Ave.), with development portions of the site beginning prior to

1918. In January of 2022, 664.82 tons of metals and/or polycyclic aromatic hydrocarbon-impacted soils were excavated and disposed of. On Nov. 14, 2022, additional source removal was conducted, successfully satisfying the site rehabilitation requirements. The site is planned for redevelopment for residential use as apartment buildings, and it received an SRCO on Jan.10, 2023.

#### Hawkins Park Green Reuse Site 1

Location: Miami, Miami-Dade County Historical Use: Auto maintenance Contaminants: Arsenic and isopropyl benzene Reuse: Manufacturing

On Oct. 3, 2016, Hawkins Park Properties LLC entered into a BSRA for renovations of an existing industrial site consisting of two parcels.



The parcel at 2125 N.W. 10th Court documented isopropyl benzene groundwater contamination, and the parcel at 2133 N.W. 11th Ave. documented arsenic groundwater contamination. The site formerly operated as a repair and maintenance facility for Waste Management trucks. A Natural Attenuation Monitoring Plan was approved on March 29, 2017, and completed on Aug. 16, 2021, for the arsenic groundwater contamination. The Remedial Action Plan addressing the isopropyl benzene groundwater plume via injection of Klozur was approved on Dec. 19, 2018, and implemented on March 15, 2019. A Post Active Remediation Monitoring Plan was approved on Sept. 17, 2019, and completed on March 29, 2022. Documentation submitted with the SARs/NFAP confirmed that the only remaining contaminant (isopropyl benzene) exceeds the nuisance, organoleptic or aesthetic consideration criteria set forth in 62-780, F.A.C. An SRCO was issued on Feb. 9, 2023.



#### Walmart Neighborhood Market

Location: Homestead, Miami-Dade County Historical Use: Automotive dealership Contaminants: VOCs, PAHs Reuse: Retail

Walmart Stores East LP executed a BSRA for the property located at 1499 Homestead Blvd. The site operated as an automotive dealership and mechanical repair shop until 1996. Oil water separators, hydraulic lifts and underground storage tanks were removed from the site. The site assessment was completed and approved on Dec. 6, 2012, and documented volatile organic compounds and polycyclic aromatic hydrocarbon groundwater contamination. A Source Removal Report dated Nov. 8, 2013, which included post-excavation soil and groundwater assessment, documented that no impacted soil remained on-site. Groundwater monitoring was conducted and completed for a No Further Action site closure. An SRCO was issued on May 8, 2023. The Walmart Neighborhood Market opened in January of 2014 and created up to 95 full- and part-time jobs.



7777 NW 41st Street Green Reuse

Location: Miami, Miami-Dade County Historical Use: Pastureland and industrial Contaminants: Petroleum, benzene, isopropyl benzene, and iron Reuse: Industrial

Park 7777 NW 41st Street Owner LLC entered into a BSRA with Miami-Dade County for rehabilitation and redevelopment of the property located at 7777 N.W. 41 St. The site historically was pastureland from 1938 to 1953 then was developed by Pepsi Bottling Company in 1964 with multiple buildings, underground and above ground storage tanks (petroleum, waste oil, etc.), a vehicle repair area, petroleum dispenser areas, a truck wash area, stormwater collection area, and a pump station. The site received No Further Action without conditions for petroleum discharges discovered on May 22, 1987 (on June 1, 1989) and Aug. 16, 1988 (on Oct. 26, 1995) and waste oil dated Feb. 15, 1991 (on Jan. 15, 1993). However, groundwater contamination was discovered during due diligence activities for demolition and site development activities on Nov. 11, 2017. Site rehabilitation activities (source removal) were conducted. A monitoring only plan was approved on Oct. 25, 2021. The contaminants of concern (COCs) remaining on-site are benzene, isopropyl benzene, and iron in the groundwater. The site received closure on March 7, 2023, using the organoleptic provisions of Chapter 62-780, Florida Administrative Code. The transformation of the site into industrial warehouses is currently being completed.

#### Wynwood Hotel

Location: Miami, Miami-Dade County Historical Use: Industrial Contaminants: Benzene, isopropylbenzene, sulfate, TDS Reuse: Hotel

On Oct. 3, 2016, Hawkins Park Properties LLC entered into a BSRA for renovations of an existing industrial site consisting of two parcels. The parcel at 2125 N.W. 10th Court documented isopropyl benzene groundwater



contamination, and the parcel at 2133 N.W. 11th Ave. documented arsenic groundwater contamination. The site formerly operated as a repair and maintenance facility for Waste Management trucks. A Natural Attenuation Monitoring Plan was approved on March 29, 2017, and completed on Aug. 16, 2021, for the arsenic groundwater contamination. The Remedial Action Plan addressing the isopropyl benzene groundwater plume via injection of Klozur was approved on Dec.19, 2018, and implemented on March 15, 2019. A Post Active Remediation Monitoring

Plan was approved on Sept. 17, 2019, and completed on March 29, 2022. Documentation submitted with the SARs/NFAP confirmed that the only remaining contaminant (isopropyl benzene) exceeds the nuisance, organoleptic or aesthetic consideration criteria set forth in 62-780, F.A.C. An SRCO was issued on Feb. 9, 2023.



### Village at Old Cutler

Location: Miami, Miami-Dade County Historical Use: Agriculture Contaminants: Arsenic, iron Reuse: Residential

Village at Old Cutler LLC entered into a BSRA with Miami-Dade County for the proposed development of Village at Old Cutler (Folio #s

30-6017-001-0010 and 30-6017-000-0012). The site was formerly used for agricultural purposes. Site assessment activities documented arsenic in soil, and ammonia and iron in groundwater. The arsenic in soil and iron in groundwater were determined to be consistent with background concentrations, while an alternative cleanup target level (ACTL) was derived for the ammonia in groundwater. Based on the ACTL utilized, a conditional SRCO was issued on May 24, 2023. The site is being developed as an apartment complex to include workforce housing units. Upon completion, the development will offer 390 homes across eight three-story buildings.

#### **Former Servico Landfill**

Location: West Palm Beach, Palm Beach County Historical Use: Landfill Contaminants: Metals, PAHs Reuse: Commercial, Retail



On Dec. 16, 2015, BW Australian Belvedere LLC executed the BSRA for the former Servico Landfill brownfield site. The site consists of four parcels totaling 8.94 acres located at 1520 Belvedere Road in West Palm Beach. The redevelopment plan for this property involves constructing a Wawa convenience store/gas station on Parcel 1, a car wash on Parcel 2, a Mitsubishi dealership on Parcel 3, and a self-storage facility on Parcel 4.

The former Serivco Landfill brownfield site has documented soil and groundwater metal and polynuclear aromatic hydrocarbon impacts that occurred during its operation as a municipal waste incinerator and/or landfill. Buried waste still exists at the site. In July 2016, a Site Assessment Report combined with a Remedial Action Plan for the site was approved by the DEP Southeast District Office. The parcels were closed with land use restrictions in January 2023, and a conditional SRCO was issued on Jan. 26, 2023. Soil and groundwater impacts are being addressed

with institutional controls. Through the VCTC Program, over \$1,529,000 in corporate income tax credit has been granted to date for assessment and cleanup work.



#### **Central Avenue Redevelopment Site**

Location: St. Petersburg, Pinellas County Historical Use: Industrial Contaminants: Benzo(a)pyrene, TRPH, arsenic Reuse: Residential

Contamination of this site, located at 3100 Central Ave., St. Petersburg, Florida, was discovered in October 2019 and consisted of petroleum products

and arsenic in soil and petroleum products in groundwater. The Central Avenue Redevelopment Site entered into Brownfield Site Rehabilitation Agreement with DEP on Dec. 23, 2019. Demolition activities were completed during March 2020 providing access to perform site assessment activities for benzo(a)pyrene (BaP) and total recoverable petroleum hydrocarbons (TRPH), and arsenic. All contaminants in soil were removed accordingly to the Soil Management Completion Report and No Further Action with Conditions Proposal dated Sept. 24, 2021, and a conditional SRCO with institutional controls was issued on Oct. 5, 2022. Exposure to contamination has been restricted with engineering controls that were set forth in a Declaration of Restrictive Covenant between the owner and DEP. This area designated by the city of St. Petersburg has been redeveloped by Mosaic at Grand Central LLC as a residential apartment complex, Gallery 3100, offering one- or two-bedroom floorplans in downtown St. Petersburg. Amenities include a residential clubhouse, fenced-in paw park, pet spa and grooming, coffee bar, business center, indoor fitness, heated resort-style pool, bike storage, and a bike repair station. The redevelopment of this brownfield has created luxury apartments for the community of St. Petersburg.

#### Lake Wire Multifamily

Location: Lakeland, Polk County Historical Use: Industrial Contaminants: Arsenic, BTEX Reuse: Multifamily Residential

The former Florida Tile property was occupied by residences and industrial businesses from at least 1913 until the early 1950s. Two foundries with fuel storage tanks were located in the southwestern portion of the site, and the Lakeland Ice Company facility (ice manufacturing) was located in the southeastern portion of the site and had a 15,000-gallon crude



oil tank. By 1929, one of the foundries had been replaced with a junk yard, and the other foundry had been replaced with Texas Oil Company with an oil warehouse and three large gasoline tanks.

In addition, the ice company had been replaced with Peacock Brothers Machine and a citrus processing company.

By the early 1950s, most of the residences had been removed from the southern portion of the brownfields site, and Florida Tile Industries Inc. (a manufacturer of ceramic wall and floor tile) occupied the site. Texas Oil Company remained in the southwestern portion of the site until sometime between 1965 and 1968, when it was replaced with buildings related to Florida Tile. Florida Tile continued operating at the site until 2004, when operations ceased and buildings were demolished.

The Former Borden Dairy property (east-central portion of the brownfields site) began operating as Poinsettia Ice Cream warehouse in the mid-1920s (a gas tank was depicted at the facility in the 1929 Sanborn). The facility was purchased in the mid-1940s by Borden Dairy, which operated the property as a distribution warehouse until the mid-1990s, when the facility was demolished.

Contaminants of concern at the site were total recoverable petroleum hydrocarbons (TRPH), arsenic and barium in soils. These contaminants were addressed through a source removal consisting of excavation and proper disposal. An unconditional SRCO was issued by the department on Feb. 24, 2023. Petroleum-related contaminants present in soils and groundwater on the east-central portion of the site have been determined to be associated with a petroleum release from USTs on the former Borden Dairy property and are being addressed through the department's Abandoned Tanks Restoration Program (reference: Facility ID 538628524).



# **Bonnet Springs Park**

Location: Lakeland, Polk County Historical Use: Railyard Contaminants: Arsenic Reuse: Municipal Park

Following its closure in the early 1980s, Lakeland's nearly century-old railyard operation, once the largest in Florida, left a deep environmental footprint. The property, located

between West Memorial Boulevard and George Jenkins Boulevard on the east side of Lake Bonnet, languished for nearly 40 years until a group of community investors and developers united to repurpose the historic site. Through the collaboration of local developer David Bunch, retired Lakeland Parks and Recreation Director Bill Tinsley, and Carol and Barney Barnett, the purchase of the railyard and more than a dozen adjoining properties was finalized, and master planning and design began in 2016 to create the 168-acre park.


Assessment identified arsenic in soil as the primary contaminant to be managed at the site. More than 1,000 sample locations characterized soil across 80 acres of the former rail yard. The site was divided into seven exposure areas that each had source removal of soil conducted to meet

recreational exposure criteria. The excavated soils were staged in the central portion of the park, creating two large hills that were capped with fill material to form an engineering control. The hills form a gateway entrance to the family lawn/concert venue fronted by the Children's Museum. Site rehabilitation was completed in 2020, and the site closed with conditions restricting soil and groundwater use in April 2023.

Bonnet Springs Park officially opened its doors in October 2022 within walking distance of downtown Lakeland.
