Dear Planning Board for Florida State Parks:

Gilchrist Blue Springs is now a state park! It has been a long process, and a wonderful outcome for the people of Florida who so love this beautiful spring. Thank you for all your work to help the spring. I have been there several times recently, and I've seen changes already that will help the springs.

I'm concerned about recreational usage--specifically *wading*--destroying the beautiful Blue Springs and Naked Springs runs. Nope, no one ever had a eureka moment about the springs from wading in them. The rapture of experiencing the springs is from being immersed in the waters, brought to revelation by seeing the beautiful world of water, aquatic life, and plants, in a magical underwater world. And this opportunity is ( only) possible here in North Florida, in a healthy spring. *There is no immersion in wading*.

The beautiful springs runs at Blue springs and Naked Springs, are a world treasure. They need to be protected from wading, to safeguard the delicate beauty of these underwater gardens. Snorkeling tours could be a great way to appreciate this landscape, as with Rainbow Springs. A good boardwalk, with belvederes like at Volusia Blue Springs park, could encourage people to study and learn the underwater world. An educational program, with snorkeling instruction, and information about the wide array of underwater plants and species, could give folks a coveted "Underwater Springs Ambassador" award, or even, "Underwater Master Gardener"status. As with the snorkeling tours at Rainbow springs, expert volunteers could share information about the life in the different springs world that swimmers are about to enter. Steps at the far end of the boardwalk, at the confluence of the Santa Fe River, would protect the runs from those who can't swim back up, but would be trampling on plant life and snails, both of which are crucial to the health of the springs. Without these plants and creatures, the water quality would degrade and no longer be inviting for swimmers or tourists.

I've heard many complaints about "No float lines!" But underwater, none of us really see the float lines. We just see the beauties that they protect.

I hope the state considers the aesthetic inspiration they provide many of us, *beyond* recreation. Gilchrist Blue Springs and its runs have inspired my paintings for decades, and even video narratives—see attached. These films have inadvertently provided documentation of the SAV at Gilchrist Blue.

The world has seen the richness of these underwater gardens through art and film, and it's an inspiration we need to protect. These images are a beacon for tourists who come to Florida to see the springs. On the boardwalk at Volusia Blue, I've heard five different languages being spoken while families study the wildlife in the waters below.

The headspring at Blue, with the jumping dock, and wading areas, generally serves a purely recreational function. It has long been stripped of vegetation. With the new park entrance fee (less than the previous fee) people will pour in in the summer to enjoy the cool waters and the excitement of jumping into these springs. A wonderful experience! But the increase in visitors will be exponential.

*But the springs runs should be inviolate*. These are the richest, and most diverse springs runs on the Santa Fe, per biologist Tom Morris who did the survey. Swimming and wading take a toll on the vegetation in the springs. Rainbow springs' swimming area is stripped bare of vegetation, even though it is too deep to wade. Ichetucknee River, on the top half, suffers major damage during the season from tubers wading down the run. The eel grasses and submerged aquatic vegetation are essential in helping the river de-nitrify itself, as you may have read in Matt Cohen's chapter in AQUIFERious.

Many state parks limit access for kayaking, as in Fanning, or Volusia Blue. We can always find safe ways to explore the springs runs over time, but for now we need to protect them, as they are irreplaceable treasures. They provide a haven for wildlife and guarantee biodiversity. Those beautiful "underwater gardens" are the last line of defense for the springs to fight water pollution, along with snails and creatures that eat the algae and help control it. Instead of a concessionaire for kayaks and floats, why not hire them to handle an education program and guided snorkeling tours? These "gardens" of SAV are one of the few sources of food on the Santa Fe for the dozens —sometimes hundreds—of turtles that we regularly see there, as most of the other springs and the river bottom, are denuded of vegetation, with strands of algae covering the river bottom. On occasion Gilchrist Blue provides manatee refuge for this very reason...in many other riverine areas, there is nothing for them to eat.

The sparkling and healthy underwater gardens at Fanning, Manatee, Peacock, much of Ichetucknee, and so many springs in Florida, that I was so privileged to see and be transformed by, are gone. They have given way to clotted ropes of algae and cloudy waters. *One Spring*. Please help us preserve **One Spring** to show our citizens and the world what a beautiful healthy spring can be like. Please let me know how I and others who love the springs runs can help you in this effort.

Let's keep the unspoiled wild places in Gilchrist Blue Springs! Protect the springs runs!

Dear Planning Board for Florida State Parks:

Gilchrist Blue Springs is now a state park! It has been a long process, and a wonderful outcome for the people of Florida, and beyond, who so love this beautiful spring. Thank you for all your work to help the spring!

The beautiful springs runs at Blue springs and Naked Springs, are a world treasure. They need to be protected from wading, to safeguard the delicate beauty of these underwater gardens. Snorkeling tours could be a great way to appreciate this landscape, as with Rainbow Springs. A good boardwalk, with belvederes like at Volusia Blue Springs park, could encourage people to study and learn the underwater world. An educational program, with snorkeling instruction, and information about the wide array of underwater plants and species, could give folks a coveted "Underwater Springs Ambassador" status. As with the snorkeling tours at Rainbow springs, expert volunteers could share information about the life in the different springs world that swimmers are about to enter. Steps at the far end of the boardwalk, at the confluence of the Santa Fe River, would protect the runs from those who can't swim back up, but would be trampling on plant life and snails, both of which are crucial to the health of the springs. Without these plants and creatures, the water quality would degrade and no longer be inviting for swimmers or tourists.

The headspring at Blue, with the jumping dock, and wading areas, generally serves a purely recreational function. It has long been stripped of vegetation. With the new park entrance fee( less than the previous fee) people will pour in in the summer to enjoy the cool waters and the excitement of jumping into these springs. Yes—it's a wonderful experience!

*But the springs runs should be inviolate.* These are the richest, and most diverse springs runs on the Santa Fe, per biologist Tom Morris who did the survey. Swimming and wading take a toll on the vegetation in the springs. Rainbow springs' swimming area is stripped bare of vegetation, even though it is too deep to wade. Ichetucknee River, on the top half, suffers major damage during the season from tubers wading down the run. The eel grasses and submerged aquatic vegetation are essential in helping the river de-nitrify itself.

Many state parks limit access for kayaking, as in Fanning, or Volusia Blue. We can always find safe ways to explore the springs runs over time, but for now we need to protect them, as they are irreplaceable treasures. They provide a haven for wildlife and guarantee biodiversity. Those beautiful "underwater gardens" are the last line of defense for the springs with water pollution, along with snails and creatures that eat the algae and help control it.

They are one of the few sources of food on the Santa Fe for the dozens —sometimes hundreds—of turtles that we regularly see there, as most of the other springs and the river bottom, are denuded of vegetation, with strands of algae covering the river bottom. On occasion Gilchrist Blue provides manatee refuge for this very reason...in many other riverine areas, there is nothing for them to eat.

The sparkling and healthy underwater gardens at Fanning, Manatee, Peacock, much of Ichetucknee, and so many springs in Florida are gone. They have given way to ropes of algae and cloudy waters. *One Spring*. Please help us preserve **even One Spring** to show our citizens and the world what a beautiful healthy spring can be like. Please let me know how I and so many others who love the springs runs can help you in this effort.

Let's keep the unspoiled wild places in Gilchrist Blue Springs! Protect the springs runs!

To Whom it May Concern,

My name is Michael Riffle and I'm a frequent visitor to the newest state park in the great state of Florida. I've visited this park many times over the last few years. My passions are two-fold, Florida springs and photography. I marry these passions when I visit the springs in our state. I've photographed this new state park from above and below the waterline, both during the day and at night. It is a natural wonder to behold.

I wasn't able to make the meeting Tuesday night, nor will I be able to be present at the meeting tomorrow night, so I'm writing this email to add my comments to the public record.

Since you will be hearing so many points of view, I'm only going to make two suggestions.

1) I think the spring runs from both Blue Spring and Naked Springs should be closed for swimming between Memorial Day and Labor Day. This is the time when the spring runs suffer the most from traffic due to large crowds. During fall, winter and early spring months, there is far less traffic in the spring runs and native vegetation is able to not only recover, but thrive. I've watched the eelgrass in the Naked spring run recover completely during the last two winters. In fact, the eelgrass almost completely grew across and filled the run last winter. The same is true for the red ludwigia in the Naked headspring. I watched it almost take over the far side of the spring last winter. It was beautiful!

2) For those times when the runs are open, consider an educational sign at each headspring. It could be very simple and say something like "The submersed aquatic vegetation in this spring run is both unique and sensitive. Please consider floating down the run without touching bottom as much as possible to preserve the beauty of this natural spring run."

I am presently a volunteer at the Natural Bridge State Park which includes the new Horn Springs acquisition. In my application, I also listed Gilchrist Blue Springs State Park. I have a plant biology background and would be happy to help in any way I can.

Good afternoon,

I am writing to share my concerns regarding Blue Springs and its future.

I am the Federation Chief of the Native Sons and Daughters Program in Jacksonville, <u>http://www.nsdjax.org</u> and Blue Springs has been a great resource for our program. The ability to camp near the spring and let our kids play in it all day is an easy activity to sponsor and the park has not been as wild as Ginny Springs has become.

The park staff have been great. They have shared their archeological finds with our kids as part of our "Archeological Digs" in the volleyball court. Unlike most of the state parks, we have been allowed to setup BB Gun stands, Archery and a zip-line. Also, unlike the state park system, Blue Springs has allowed us to reserve sections of the campground for our group, without having each family pay on-line, first come, first serve. The first come, first serve method does not work because other families wind up being surrounded by our kids and eventually complain the they are surrounded by the craziness of kid's activities.

While it certainly would be nice to be able to have a drop off or pickup up or down-stream from the park for canoes and tubes, the thing the campground needs the most is posted lifeguard hours. Members of our program have twice saved other people's kids from drowning. While the campground should still allow late-night plunges into the spring at camper's own risk, there should be a lifeguard during the time the day-visitors are there.

Some other additions that could be helpful would be a few cabins for rent, and small camp store.

Something that is of great importance to our program is our fire ceremony. While we occasionally have had to be creative during fire bans, our main performance for the kids during our fall and spring campouts is the Sacred Fire Ceremony and is at the very heart of our program. It would be great to have a dedicated fire pit for group fires, especially if we could reserve it. While or program welcomes any campers to witness this amazing performance, it takes a few hours to setup for.

While I am excited that developers did not purchase the park and that it may still exist as a usable resource, I am nervous as to what the State Park system may turn it into. I am hoping that my concerns are nothing and that the park will become an even better resource than before. I look forward to transitioning this partnership to the FL Park System for generations to come.

Dear Florida State Park Planners,

As a longtime visitor to Gilchrist Blue Springs Park, I'm writing to share my thoughts on the management plan for your most recent acquisition.

My first and foremost wish is for the protection of Gilchrist Blue's unparalleled natural beauty and ecological productivity, particularly the abundance and healthy diversity of underwater flora and fauna in its runs.

Today, Blue's diverse plant and animal life is rarely glimpsed in other springs, with perhaps the exception of Rainbow Springs' restricted sections of run and the small area just beyond Ichetucknee's Head Spring. Far beyond recreation value, Gilchrist Blue is peerless as a site for artistic and spiritual inspiration, scientific research, and crucial "ecosystem services" that include food and habitat for a wide range of plants and animals, denitrification and carbon sequestering.

Looking back, Blue is the only remaining example of a mid-20<sup>th</sup> century family-run Florida tourist spring, offering a unique potential for historic preservation.

Looking ahead, Blue is a premier site for springs and aquifer research and education. I know this firsthand, from the week-long Springs Ambassadors Camp for middle schoolers I created in partnership with Alachua Conservation Trust in 2016. Here's a link: <a href="http://springseternalproject.org/camp/">http://springseternalproject.org/camp/</a>

A frequent visitor over many years, I've spent hundreds of hours snorkeling and documenting Gilchrist Blue's springs and runs. As a videographer and director of the Springs Eternal Project (along with my partners John Moran and Rick Kilby) I'm familiar with most of Florida's larger springs as well as many of the smaller, more obscure ones *from an underwater perspective*.

Although I'm not a scientist, I can tell you, from visual and educational experience, that Gilchrist Blue is the best "preserved" (when in recovery) and most beautiful of Florida's springs. Here's why: It offers one of the most "natural" settings (no concrete walls, no paved trails, no paved parking lots); an abundance of "healthy" vegetation and fauna as well as consistent color and clarity (when not overly impacted by recreational users or storm events like Irma); and is the least defiled by algal domination, probably due to its flow and the fact that it often harbors a diverse range of flora and fauna. It is clearly in our own best interests to acknowledge, preserve and protect this magnificent yet fragile ecosystem.

I don't think it's hyperbole to say that Gilchrist Blue is the crown jewel of Florida's once magnificent array of artesian springs. As most of our springs are now highly degraded, suffering visibly and biologically from reduced flows and increased pollution, Blue is one of the last Florida springs to offer glimpses, at various moments, into what a relatively healthy (or at least functioning) springs ecosystem might look like. In a very real sense, Blue is a rare and endangered species. Like her siblings across the state, many of which have disappeared or are so degraded as to be unrecognizable, she won't survive if we don't take intelligent, committed and decisive measures to protect her.

Gilchrist Blue has been a crucial site for scientific research and artistic output. Many local as well as international painters, photographers, writers and filmmakers (i.e. Margaret Ross Tolbert, David Moynahan, Jenny Adler, Tom Morris, Mark Long, John Moran) have found inspiration in Blue, and most of my underwater video footage has been shot there. My video "Swimming Through Air" (link: <u>https://vimeo.com/108267111</u>) is on permanent display in the Florida Museum of Natural History's Discovery Room. Sharing the underwater wonders of our springs with generations of Floridians and visitors, young and old, inspires new springs enthusiasts and a rigorous commitment to our state parks, our best emissaries for "the Real Florida."

My biggest immediate concern for the management of Blue is recreational usage, specifically wading in Blue Spring and Naked Spring runs. I have watched helplessly and aghast as visitors wade up and down the runs, oblivious to the creatures that live there and the fragile plants and grasses they trample. Waders destroy the runs, which take months or sometimes years to grow back. Without protection, the runs will reach a point where they cannot recover.

Let's start by protecting Blue's beautiful and unique spring runs from waders. There are already several promising models offered by other springs parks. At Rainbow Springs the run is closed to regular visitors. However, snorkeling has been available by reservation, which offers a way to experience and appreciate the delicate underwater vegetation while also protecting it. Guides make sure that visitors know how to snorkel properly, have plenty of time to explore on their own but don't touch the plants or animals, and are given informed, ecologically sound answers to questions. At Crystal River, it's mandatory for visitors to watch educational videos about manatee biology, habitat and endangerment, as well as guidelines for interaction before they head out to Three Sisters Springs.

A similar model could be offered at Blue, focusing on our mutually interdependent relationship with the springs and Floridan aquifer. Information could include introductions to Blue's springshed, hydrogeology, flora and fauna, our dependence on the aquifer for our drinking water (and so much more), and threats to Blue's health, such as overpumping and pollution from septic tanks, manure, fertilizers and pesticides. More directly, the importance of protecting the plants and animals in the runs by not wading or touching them needs to be emphasized. Innovative forms of positive visitor engagement and "stewardship" could also be created.

I'm confident that if the Florida Park Service works with local springs lovers, experts, scientists, artists, educators and users, we can create a win-win management plan. We can retain the recreational thrill of leaping off the dock, swimming in the headspring, walking the boardwalk and hiking the nature trails while, at the same time, protecting Blue's unique runs.

Blue could be the test case, icon and success story of Florida's ability to fully restore and protect a living (healthy and fully functioning) spring ecosystem. By offering the public not just recreation but additional immersive and exploratory springs educational experiences, we can protect Gilchrist Blue now and inspire future springs conservationists. As a videographer, university professor and Springs Ambassadors Camp producer, I'm happy to offer my assistance with developing creative, fun and innovative forms of immersive springs education at Blue.

At present, Gilchrist Blue is a last glance into what a Florida spring once was. Let's make it the first *realized* vision, the first success story, for restoring the wondrous and thriving "bowls of liquid light" that Florida's springs could be again.

I write to you today to encourage you to continue their legacy of stewardship so that one day my grandchildren can experience the same magnificent underwater worlds that I have been so lucky to explore.

Subject:	Protect the Springs Runs at Gilchrist Blue Springs !

Dear Planning Board for Florida State Parks:

Gilchrist Blue Springs is now a state park! It has been a long process, and a wonderful outcome for the people of Florida who so love this beautiful spring. Thank you for all your work to help the spring. I have been there several times recently, and I've seen changes already that will help the springs.

I'm concerned about recreational usage--specifically *wading*--destroying the beautiful Blue Springs and Naked Springs runs. Nope, no one ever had a eureka moment about the springs from wading in them. The rapture of experiencing the springs is from being immersed in the waters, brought to revelation by seeing the beautiful world of water, aquatic life, and plants, in a magical underwater world. And this opportunity is

(only) possible here in North Florida, in a healthy spring. *There is no immersion in wading*.

*The beautiful springs runs at Blue springs and Naked Springs, are a world treasure.* They need to be protected from wading, to safeguard the delicate beauty of these underwater gardens. Snorkeling tours could be a great way to appreciate this landscape, as with Rainbow Springs. A good boardwalk, with belvederes like at Volusia Blue Springs park, could encourage people to study and learn the underwater world. An educational program, with snorkeling instruction, and information about the wide array of underwater plants and species, could give folks a coveted "Underwater Springs Ambassador" status. As with the snorkeling tours at Rainbow springs, expert volunteers could share information about the life in the different springs world that swimmers are about to enter. Steps at the far end of the boardwalk, at the confluence of the Santa Fe River, would protect the runs from those who can't swim back up, but would be trampling on plant life and snails, both of which are crucial to the health of the springs. Without these plants and creatures, the water quality would degrade and no longer be inviting for swimmers or tourists.

I've heard many complaints about "No float lines!" But underwater, none of us really see the float lines. We just see the beauties that they protect.

I hope the state considers the aesthetic inspiration they provide many of us, *beyond* recreation. Gilchrist Blue Springs and its runs have inspired my paintings for decades, and even video narratives—see attached. These films have inadvertently provided documentation of the SAV at Gilchrist Blue. The world has seen the richness of these underwater gardens through art and film, and it's an inspiration we need to protect. These images are a beacon for tourists who come to Florida to see the springs. On the boardwalk at Volusia Blue, I've heard five different languages being spoken while families study the wildlife in the waters below.

The headspring at Blue, with the jumping dock, and wading areas, generally serves a purely recreational function. It has long been stripped of vegetation. With the new park entrance fee( less than the previous

fee) people will pour in in the summer to enjoy the cool waters and the excitement of jumping into these springs. Yes—it's a wonderful experience!

*But the springs runs should be inviolate.* These are the richest, and most diverse springs runs on the Santa Fe, per biologist Tom Morris who did the survey. Swimming and wading take a toll on the vegetation in the springs. Rainbow springs' swimming area is stripped bare of vegetation, even though it is too deep to wade. Ichetucknee River, on the top half, suffers major damage during the season from tubers wading down the run. The eel grasses and submerged aquatic vegetation are essential in helping the river denitrify itself, as you may have read in Matt Cohen's chapter in AQUIFERious.

Many state parks limit access for kayaking, as in Fanning, or Volusia Blue. We can always find safe ways to explore the springs runs over time, but for now we need to protect them, as they are irreplaceable treasures. They provide a haven for wildlife and guarantee biodiversity. Those beautiful "underwater gardens" are the last line of defense for the springs with water pollution, along with snails and creatures that eat the algae and help control it.

They are one of the few sources of food on the Santa Fe for the dozens —sometimes hundreds—of turtles that we regularly see there, as most of the other springs and the river bottom, are denuded of vegetation, with strands of algae covering the river bottom. On occasion Gilchrist Blue provides manatee refuge for this very reason…in many other riverine areas, there is nothing for them to eat.

The sparkling and healthy underwater gardens at Fanning, Manatee, Peacock, much of Ichetucknee, and so many springs in Florida, that I was so privileged to see and be transformed by, are gone. They have given way to ropes of algae and cloudy waters. *One Spring*. Please help us preserve **even One Spring** to show our citizens and the world what a beautiful healthy spring can be like. Please let me know how I and so many others who love the springs runs can help you in this effort.


Let's keep the unspoiled wild places in Gilchrist Blue Springs! Protect the springs runs!





To whom it may concern,

I was introduced to Gilchrist Blue when I first arrived in Gainesville, fourteen years ago, for my initial interview with the University of Florida, where I am currently a Professor of English. Blue Springs was one of the factors in my decision to live and teach here. I am delighted that it is now under the protection of Florida's state parks.

I have been snorkeling at Blue ever since. Now that the spring is under the state's control, I would like to propose a way of protecting its fragile run. As a diver, I have seen how different communities in the Caribbean protect their reefs. Each marine preserve includes vital information on signs near entry points along the beach. The signs explain how touching the coral kills it. Why not include signs at Blue Springs that explain to swimmers that the run is fragile, that wading will destroy it, and that swimmers may only enter the run if they agree to not wade, or touch anything.

It seems like an inexpensive way to protect such a glorious resource.

Hello Planners,

As the author of "The Springs of Florida", Pineapple Press, Sarasota, I feel compelled to comment on the future of Gilchrist Blue.

For several years I travelled springs throughout Florida photographing their inhabitants, vegetation and terrain both day and night and in all seasons of the year. I was given the opportunity to dive Wakulla, Silver and the Rainbow River headsprings to complete that task. Though small in comparison to these giant first magnitude springs, I found no other spring in the state was more indicative of the springs ecosystem than Gilchrist Blue. I in fact lived in a tent at Gilchrist Blue for two winters and was permitted to use SCUBA day and night there to search for and photograph springs inhabitants.

Gilchrist Blue "had" a population of spotted bullheads I found in no other spring in the state. The crayfish, Procambarus speculifer was visible in its headspring and run, Suwannee Bass were plentiful, Naked "had" immature troglobitic crayfish in its water column. As was my purpose to document the life found in Florida's springs, many inhabitants were photographed for use in my book at Gilchrist Blue. With final direction by Archie Carr, the book was first published in 1993 and is now in its 3rd edition.

I realized while spending time at Gilchrist Blue that visitors found the spring, the run and boardwalk to be a living museum of natural history. No pamphlet, book or lecture could do more to foster an appreciation of the unique springs environment than a snorkel trip in the headspring, a snorkel float down the run or a walk down the boardwalk. These experiences made visitors advocates for springs protection. I think if protection with education and appreciation are your goals then a few things should happen at Gilchrist Blue.

Snorkeling should be allowed in the headspring and down the run but no standing or wading in the run. A small platform halfway to the river similar to Juniper would offer a respite for snorkelers. If you don't have a mask you should not be in the run out of a canoe or kayak. A short snorkel float down the run is both beautiful and educational for the vistas and wildlife viewing it offers.

The boardwalk should be rebuilt with a viewing/seating area at the confluence the run and river with a stairs for snorkelers to enter the boardwalk. That's quite a place to be day or night as much happens there.

The diving platform in my opinion could be removed as it does not offer the educational experiences snorkelers would have in the same area. If you happen to look in my book you'll see the platform did offer exceptional cover to a variety of fish species. Perhaps a snorkel enter platform could be constructed there that would offer the same shade cover.

Gilchrist Blue is a beautiful little spring with a lot to offer its visitors in and out of the water. Those who see it with a face mask are most fortunate, and its small headspring and run offer a rare and unintimidating opportunity to see what really is unique about the springs of Florida - the fascinating and crystal clear world found below their surface.

Dear Florida State Park Planning Team,

As a Florida native and admirer of our wonderful state parks, I applaud the acquisition of Gilchrist Blue Springs as our newest Florida State Park. It is reassuring to count this magnificent natural resource as a protected area within the broader network of inseparable springs, rivers, sinks, and lakes which together compose the Floridan Aquifer that sustains the existence of all life throughout our region. Your careful consideration of ways to counteract the inevitability of ecological disruption resulting from our human presence and activity in this fragile ecosystem can help set examples for us all to follow. Along with the options you are already exploring, may I take this opportunity to present ideas for park management as we welcome Gilchrist Blue Springs into our state park community.

### Parking and Walking

The absence of asphalt and concrete paving at Gilchrist Blue Springs is one of its charming aspects. As the entry drive and parking area are likely to be renovated, may they remain permeable to rainfall and well distant from the water's edge. Please plant native trees to shade parking areas.

The installation of well-marked interpretive trails, pathways between facilities, and elevated boardwalks would help protect the many small creatures and vegetation underfoot. Visitors would be asked to remain on the designated walkways. At the same time, such traffic-control structures should be ADA accessible and, where pertinent, should accommodate the transport of paddle craft between a designated loading/unloading and launch area.

Park Fees and Springs Usage

The reduction in the Gilchrist Blue Springs entry fee (now \$6 per vehicle down from \$10 per person) may greatly increase park usage and place added stress on this delicate ecosystem. Wading should therefore be limited to a designated roped-off swimming area at the main spring head.

To keep the numbers of spring run users in check, an additional extra-use fee could be implemented for all visitors wishing to tube or paddle the main run to the Santa Fe River. Staggered entry into the spring run during peak hours would control crowding on this fragile waterway. To further protect the vitality of this aquatic habitat, a limit should be placed on the total number of swimmers, tubers, and paddlers in the spring run at any given time.

Swimmers, tubers, and paddlers utilizing the spring run should be required to maintain a one-way-only flow with the current from the spring head to the Santa Fe River. This could be achieved by providing a staircase at the river end of the existing boardwalk that would enable visitors to safely exit the water and conveniently return watercraft to the launch/storage area. The boardwalk could be renovated with split-level construction to enable closer viewing of the floodplain surface, and for ease of channeling the return of watercraft to the spring head. Wheeled trolleys to facilitate this purpose could be made available. Small platforms attached to the boardwalk superstructure, able to rise and fall with changing water levels, would provide floaters the opportunity to safely stop without disturbing delicate aquatic flora and fauna.

One-way-only float traffic in the spring run may preclude paddle craft entry from the Santa Fe River. Alternatively, an auxiliary fee station at the river end of the boardwalk could manage such visitor entries and guide them through the haul-out procedure for re-launch at the spring head.

# Naked Springs

I encourage the closure of Naked Springs and its run to all recreational use so as to facilitate the regeneration of the amphibious and aquatic flora and fauna native to this fragile habitat. Naked Springs offers an outstanding location for springs restoration, and for visitor education, observation, and repose. A small, well-designed pavilion and deck near the springhead could offer a pleasant sitting and interpretive venue. The installation of underwater video cameras at various points in Naked Springs and along its run, coupled with viewing screens at the pavilion, would offer visitors a close-up vista of this magical underwater realm without getting their feet wet! If possible, all the better to project images in real-time. Such an amenity could be particularly meaningful for visitors who may be unable to float, swim, or paddle.

Appropriate signage and displays would serve multiple purposes of education, restoration monitoring, and public awareness. The pavilion would also serve as a meeting place for ranger talks, guest speakers, workshops, and a place for visitors to post and display their photos and observations.

### Visitor Engagement and Participation

Well-crafted programs enable park visitors of all ages to become actively engaged participants in ecosystem protection. These can take the form of nature walks and talks, citizen scientist projects, school outings, and contests. Along with engaging the public, contests can raise funds required to support such programming through modest registration fees. Imagine the enthusiasm to be generated, for example, by an annual contest for best Naked Springs T-shirt design. In addition to a prize, the winner's name would be emblazoned on the shirt for posterity and the Park would earn a tidy sum from the sale of these unique collector's items.

# Springs Studies Scholarships

From A to Z, there are few academic topics unsuited to springs studies. I would therefore like to encourage the Florida State Park Service to partner with the Florida Department of Education in the establishment of a Springs Studies Scholarship program directed toward senior-year high school advanced placement students statewide. Interested scholars would submit research proposals for studies of interest both to themselves and the Park Service that are applicable to issues of springs conservation. In a nutshell, the scholarship winners would work under the guidance of compatible academic departments within our state university system and earn college credit toward their university-level education. The goals are to stimulate areas of springs research that may otherwise be unattended, to broaden existing programs of investigation, to apply research findings as appropriate, and to cultivate future generations of knowledgeable springs ambassadors. The benefits would be too numerous to list.

I believe I speak for many park visitors by stating that we place great trust in the award-winning Florida State Park Service to develop and implement state-of-the-art infrastructure design, materials, and programming that enable the invaluable wildlife and hydro-geological features of Gilchrist Blue Springs and all our State Parks to thrive in perpetuity, and to serve as models for sustainable nature-based recreation in tandem with the re-creation of the natural serenity of our unparalleled Real Florida ecosystems. Thank you for your kind attention.



I would like to offer some of my suggestions for the future planning of the newest state park Gilchrist Blue. It gives me great pleasure that the state is the new steward of Gilchrist Blue Springs. Blue, Little Blue, Naked and Johnson Springs are a great addition to our state park system

The following are my comments and input:

1. Replace the boardwalk part way along Blue Run and as it crosses Naked Run have it run along the land towards Santa Fe River, but where people can not access the boardwalk from the river. This will allow a combination of viewing different habitats.

2. Change the fee collection area and vehicular parking at least 300+ feet from Blue Springs. Create a handicapped walkway and primitive dirt walkway to Blue Springs.

3. Picnic tables 200+ feet from Blue Spring.

4. Create a more natural landscape setting specifically designed to reduce erosion.

5. Allow for Primitive and Cabin campsites.

6. RV's take away from the natural beauty of the park.

7. Allow for swimming in Blue and Naked Runs during the winter months when less people are using the park and most people stay out of the water.

Other months swimming in the Runs should be limited and at the discretion of the Park Ranger or staff. In all cases: NO WALKING OR TUBING IN RUNS!!!

8. Kayaker's do no harm.

Since Hurricane Irma the springs have been rebounding quite impressively with new growth from eel grass in Blue Run. Snails, turtles and Suwannee bass everywhere. The springs will change from time to time with storms and hurricanes. In my opinion this is always good. It freshens up the springs.

For nearly 50 years I have been swimming different Florida Springs year round, but I have been swimming Blue and Naked and their Runs to Santa Fe River nearly everyday sometimes 2 or 3 times, because I am concerned the Runs may be off limits to swimmers in the future. Please leave a small window open.

Dear Park Management,

I have been a frequent camper at Blue Springs Park in Gilchrist County for many years, and I just love it. In fact, I first camped there about 40 years ago. Having car camped in campsites all over the country, I can attest that Blue Springs is quite unique in the experience it offers, even if you ignore for a moment what most people are first drawn to: the springs.

For people who wish to have the simplicity of car camping -- instead of backpacking or other more involved levels of camping -- but who wish to be immersed in a natural setting to enjoy the wildlife, instead of being surrounded by the sounds and sights of many other adjacent campers close by, I have never found another location like Blue Springs. Some of the campsites in the back of the park are so far removed from the rest of the park that I have often camped there and not seen or heard another person, other than those in my group, for our entire trip!

That is an amazing experience considering how much wildlife I have seen and heard at Blue Springs. I have seen many wild turkeys, many deer (even very small fawns), a bobcat, rabbits, and a whole host of birds and other wildlife which have become somewhat more reclusive in Florida in recent years.

I was very pleased to hear a Chuck-will's-widow while camping there last spring. This is a bird I had heard often in Gainesville during my childhood, but it has been more than 20 years since I remember hearing another one anywhere else but at Blue Springs.

This wildlife experience is dramatically enhanced because there are not so many sounds and sights of multiple other campers right next to these more private primitive camping sites in the back of the park.

I think it would be a great loss if these somewhat private sites in the back of the park, such as Lois Lane and East Log Road, were closed to camping or if many other additional campsites were added to these same areas so they are less private.

I hope I will still be able to share these types of experiences with my family and friends in the future.

I have been visiting Gilchrist Blue springs since the 1970's and have really appreciated the care, that this family gave to the land and water under their care. We are all hoping that, as a part of the state park system, this quality care will continue. I have decided to give my opinion about certain changes to the park in bullet points. I was told that the park service welcomes and considers all concerns and will use this information, when making their plan.

### Swimming, snorkeling in the run

- one of the primary source of enjoyment, for many people, has been this activity
- common sense measures, such as a way out at the end to prevent arduous swims back up the run, instead of total restriction
- documenting the plant growth is important to make sure that the rules or restriction matches the actual situation, for example, saying human traffic this summer destroyed the plant life is not supported by photos taken late Aug 2017 after a summer of heavy use. Yesterday, I observed and happily photographed new plant growing in both runs yesterday (Dec 12, 2017)

### Board walk (to be as close to the old one as possible)

- it protected the left bank from swimmers getting out on this bank
- it protected the left bank from getting trampled by boater landing their vessels
- it protected the underwater plants, below it, from traffic
- it allowed people to view the run without impacting the land or water
- it should be make of wood and natural materials
- it was a unique, iconic boardwalk and its replacement should be as beautiful
- it made you feel like you were in the trees and you got to see nature from a new prospective

– looking at and photographing the reflection of this boardwalk on the water and the beautiful curves, made many realize it's beauty

- making a way back from the end would be a great improvement
- extreme care when putting in the new boardwalk... please



### Plastic swimming pool ropes

- both ropes are ugly and unnatural eyesores
- they are now getting covered with a brown film, algae?
- do we really need more plastic in a natural spring?

- if we're told it's needed to prevent swimmers from injury, we need evidence to support this claim

- if this is it's purpose (above), then it is not needed in the off season because so few are in the water

– if it is deemed necessary, shouldn't it be made of natural materials, such as natural wood buoys and natural fibers?

### Camping

– limited number of sites and half set up so people who are on site get them, so people don't have to reserve months ahead

### <u>Asphalt</u>

- this spring has not had asphalt, so please, we don't need it now

- the impacts from the run off ? Unknown

### Signs

- why do we need 3 no motors signs, isn't one at the Santa Fe river enough?

– why all the pet signs and where are the.. pick up your dogs poop sign? Doesn't dog poop have an effect on the spring?

### Jumping Dock

- please, please keep it! Many people love and enjoy it so much

### Tree cutting

– noticed many healthy trees being cut down. Why? Logs cut in the run.. decaying logs. aren't they good for the health of the spring

### Lesser springs

– too much attention and development of these springs could lead to their demise. Can't they be left alone?
