**Statutory Authority:**

**Section 20.2551, F.S., Citizen support organizations; use of property; audit; public records; partnerships.** In summary, the statute specifies the organizational requirements, operational parameters, duties of a CSO to support the Department of Environmental Protection (Department), or individual units of the Department, use of Department property, audit requirements, public records requirements, and authorizes public-private partnerships to enhance lands managed by the Department.

**Section 258.015, F.S., Citizen support organizations; use of property; audit.** In summary, the statute defines a CSO, requires authorization by the Division of Recreation and Parks, and specifies the use of property. This statute authorizes the Partnerships in Parks (PIP) program for state parks, the program's operational parameters, CSO's operational parameters, and donor recognition.

**CSO's Mission:**

Our mission is to provide financial and volunteer resources in furtherance of the mission and needs of Honeymoon Island State Park and Caladesi island State Park.

**Description of the CSO's Results Obtained:**

During 2018 we contributed 2,905 volunteer hours to the parks as well as \$43,120.00 in financial support including \$32,000.00 in support of a Ranger Position for Honeymoon Island's Rotary Centennial Nature Center (RCNC) through the H.O.S.P. program, \$2,730.00 for the L.I.F.E. Program and \$1,417.00 for audio visual equipment for the RCNC.

We raised over \$573,756.00 for our Caladesi Discovery Center Capital Campaign by virtue of raising \$29,756.00 from events and donations throughout the year, obtaining a donation of \$189,000.00 from the Francis and Gertrude Levett Foundation, a pledge of \$35,000.00 from our local Rotary Club and an award of \$320,000.00 from the state P.I.P. fund.

**Description of the CSO's Plans for the Next Three Fiscal Years:**

We plan to focus on the construction of the Caladesi Discovery Center, in order to have it completed and operational by 2020, including all displays, exhibits, programs and a maintenance plan to ensure the elevator is operational for all times the center is open.

We plan to continue to sponsor and or conduct activities in the parks that promote the parks' mission as well as raise funds for further support of both parks. Examples include an annual Earth Day celebration, a Halloween event and several running events in partnership with various other local civic groups such as the Kiwanis and Rotary clubs.

We will continue our small retail operation, our "Tour" programs and we will seek to expand our membership (currently over 600).

Friends provide support exclusively for Honeymoon and Caladesi Islands state parks for both daily operations and long-term

4a (Code: ) (Expenses \$ 40,856 including grants of \$ 36,069 ) (Revenue \$ ) The Friends of the Island Parks Inc main focus is the support of Caladesi Island State Park and Honeymoon Island State Park through grants, general park promotion, sponsoring specific activities (Island Earth Days, Rotary Centennial Nature Center (RCNC), etc), promoting park usage, nature preservation within the park, etc. Friends contributed \$32,159 to the Florida Park Service through the H.O.S.P. (Help Our State Parks) program to defray the cost for the RCNC training coordinator for calendar year 2018; paid \$657 for costs to maintain a Native Plant Garden; paid \$2,730 for the Dunedin Middle School LIFE Program; Audobon program costs \$1,180 paid for other projects for \$4130.

4b (Code: ) (Expenses \$ 6,807 including grants of \$ ) (Revenue \$ ) Island Earth Days. Visitors have the opportunity to learn about the ecology of the islands, methods to protect the environment, enjoy nature and the Honeymoon Island Park, and have a taste of Florida's original coast, to see many types of wildlife that depend on these ecosystems and to learn about these islands that need to be protected.

4c (Code: ) (Expenses \$ 2,264 including grants of \$ ) (Revenue \$ ) The Rotary Centennial Nature Center (RCNC) at Honeymoon Island State Park offers a variety of public ecology exhibits and educational nature tours. The Nature Center will educate visitors about Honeymoon and Caladesi Islands and the Gulf barrier islands' environment and ecology. The RCNC is acts as a visitor and information center for the park. It includes a gift shop. "Friends" members volunteered over 8,000 hours at the RCNC during 2018. Purchased 3 flat screen TVs, \$1,417; repaired the weather station, \$187; and paid \$660 for Web Access at RCNC.
