ITEM 6:

Vote on whether to add six 2023 Cycle 1 Florida Forever proposals to the 2024 Florida Forever Priority List.

DSL STAFF REMARKS:

In October 2022, the Division of State Lands (DSL) received Florida Forever project proposals for Avalon Phase II, Carter Quail Ranch, Creek Ranch, Floyd's Mound, Owen Creek Highlands, Quail Creek Ranch, and Williamson Cattle Company. Council members and staff reviewed the applications and the Florida Natural Areas Inventory (FNAI) preliminary resource evaluation and heard public testimony at the December 8, 2022, public hearing. ARC voted to move all seven proposals to full review on December 9, 2022. The Owen Creek Highlands landowner subsequently requested that the project be deferred.

The Florida Forever assessment team visited each of the proposals in January and February of 2023. The DSL staff then prepared project evaluation reports based on the information provided by the ARC member agencies, FNAI and other agency contributors. Regional public hearings on the proposals were held on March 13, March 14, and April 14, 2023. The meeting summaries for the March regional hearings are provided in Item 2.
