DEP Recognizes JM Family Enterprises for 64 Percent Recycling Rate

On May 20, 2015, the Florida Department of Environmental Protection recognized <u>JM Family</u> <u>Enterprises</u>, a diversified automotive company, for their outstanding recycling efforts in 2014.

To be recognized, an organization must demonstrate a recycling rate at or above the state recycling goal of 50 percent. JM Family achieved a 64 percent recycling rate between its Deerfield Beach headquarters, JM Lexus dealership in Margate, and its Jacksonville vehicle processing and distribution facilities.

The company recycles everything from traditional consumer commodities such as aluminum, glass, paper and plastic to miscellaneous metals, textiles and wood. This equates to over 4.48 million pounds of recycled material including used oil, anti-freeze, construction and demolition debris, tires, and soft and rigid plastics such as rim and spare tire wheel covers. Diverting these materials from the landfill prevents 6,198 metric tons of carbon dioxide equivalents from being released into the atmosphere.

"JM family has consistently been a steward of conservation efforts in the community, and we commend them for taking significant strides toward reducing the carbon footprint and environmental impact of their business practices," said Florida House Representative Kristin Jacobs, who attended the award presentation at JM Family headquarters in Deerfield Beach.
