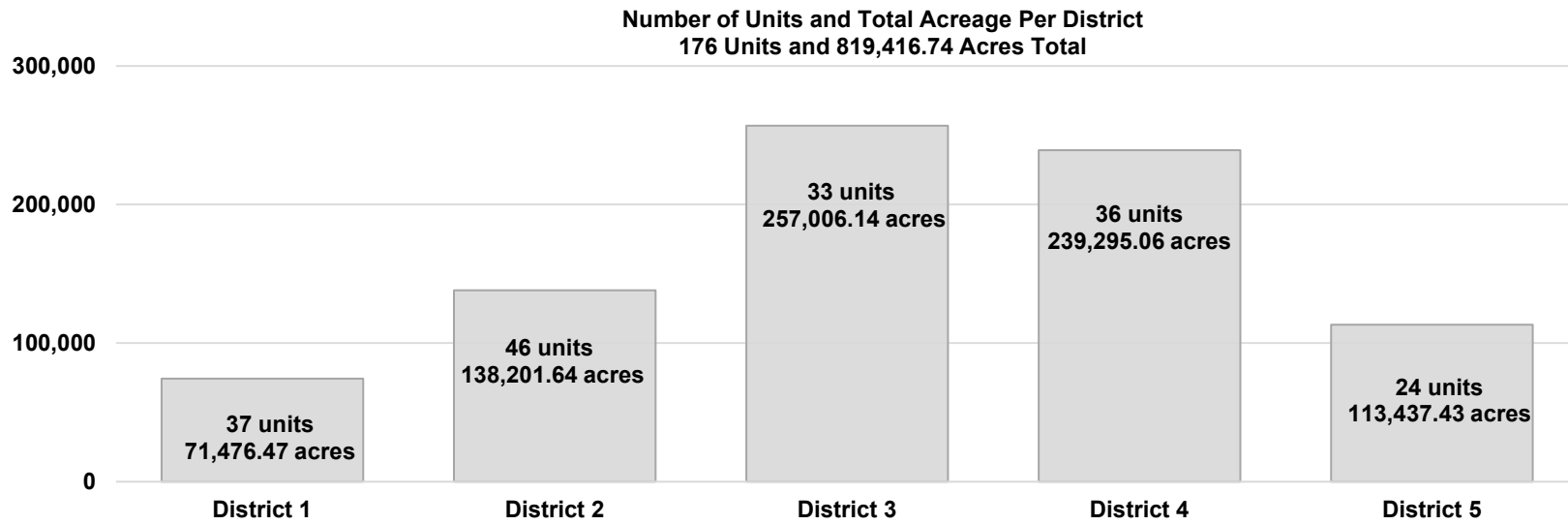

Jurisdiction Report Glossary
As of July 1, 2026

Site Name - The official designation of a state park unit or the name by which the unit is officially called.

Inception - The data on which the parcel that constitutes the initial area of the unit was acquired by the State of Florida.

District - The Division of Recreation and Parks administrative region in which the unit is located.

County - The Florida county in which the unit is located.

Acreage - Area of the unit in acres.

Owner - The entity that has fee simple title to the unit or a portion of the unit.

BTIITF - Board of Trustees of the Internal Improvement Trust Fund

COUNTY - Specific Florida county with fee title interest in the unit

FDOT - Florida Department of Transportation

FIND - Florida Inland Navigation District

PRIVATE - Non governmental organization or private individual with fee title interest in the unit

SFWMD - South Florida Water Management District

SJRWMD - St. Johns River Water Management District

SRWMD - Suwannee River Water Management District

SFWFMD - Southwest Florida Water Management District

USACOE - United States Army Corps of Engineers

USCG - United States Coast Guard

USDA - United States Department of Agriculture

USFWS - United States Fish and Wildlife Service

DRP Interest - The legal authority under which the Division of Recreation and Parks manages the unit.

Lease - Legal instrument issued by the land owner to the land manager outlining statutory requirements for use of BTIITF owned lands.

Management Agreement (MA) - An agreement between the owner and DRP to establish legal authority to manage the property as a state park unit. **Dedication** - The conveyance of private land in fee simple for public use.

Letter of Consent (LOC) - Approval from specific permitting District for underwater activity.

Submerged Lands Lease (SLL)-Legal instrument issued by owner to manager outlining statutory requirements for use of BTIITF owned submerged lands. **Use**

Agreement (UA) - Legal instrument issued between the owner and DRP granting temporary permission to use property, facilities, or land.

Memorandum of Understanding (MOU) - An agreement between the USFWS and DRP to cooperatively manage the unit.

Expiration Date - The date the Division of Recreation and Parks leasehold interest in the unit expires.

Classification - The official classification of the unit based on the purpose for which the property was acquired or the function it is supposed to serve Public Access.

Status - The condition of the unit relative to public access.

Open Fee Required - Available for public use and fee is required at an entrance station or honor box

Open No Fee Required - Available for public use and no fee is required

Open Prior Arrangement Required - Limited public use is permitted after making prior arrangements with appropriate staff.
