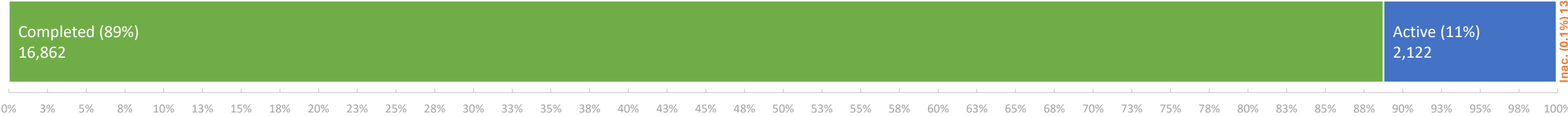

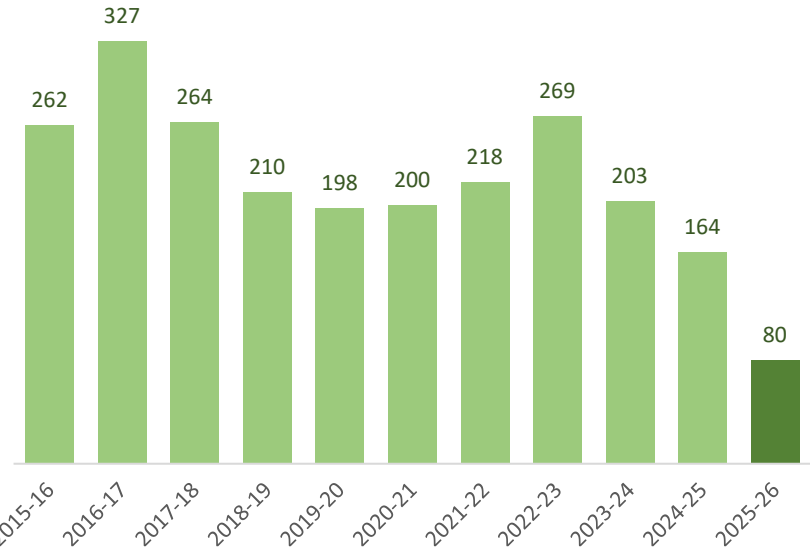

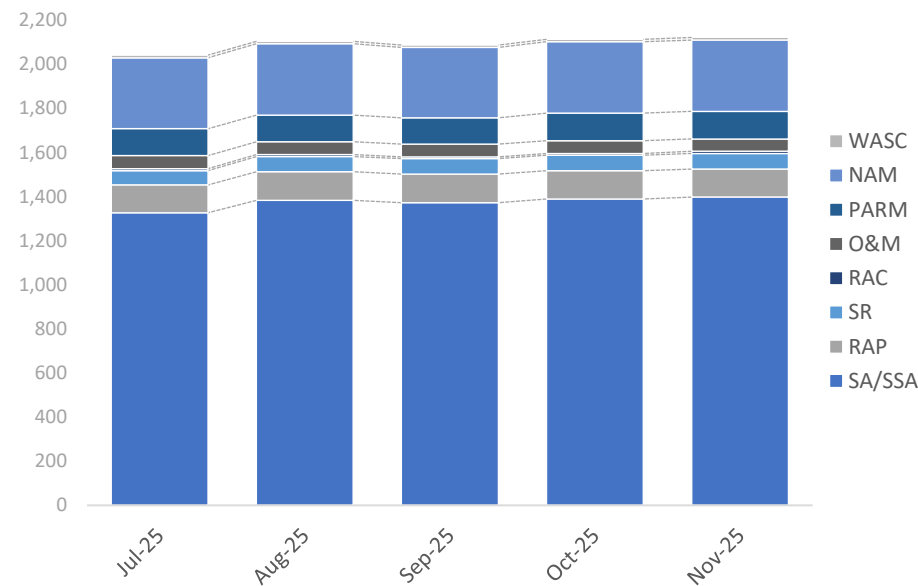
## FY25-26 Non-Program Closures by Lead Agency

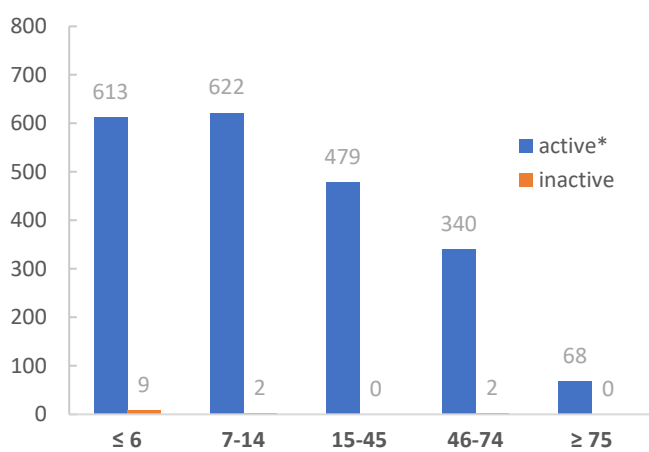

## Non-Program Discharges by Score

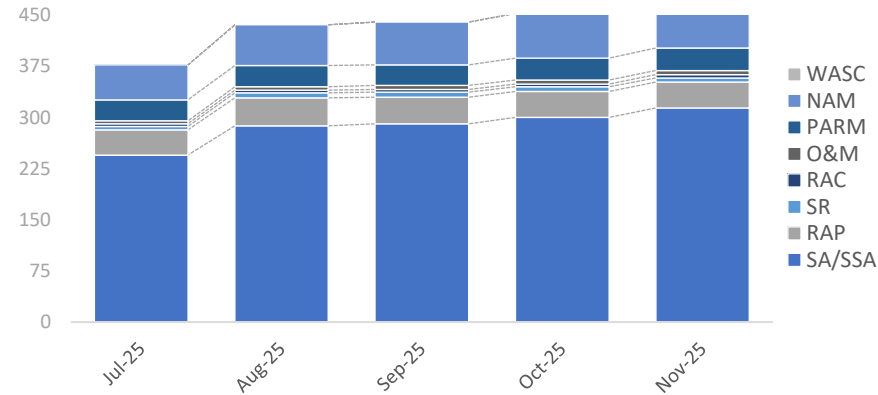

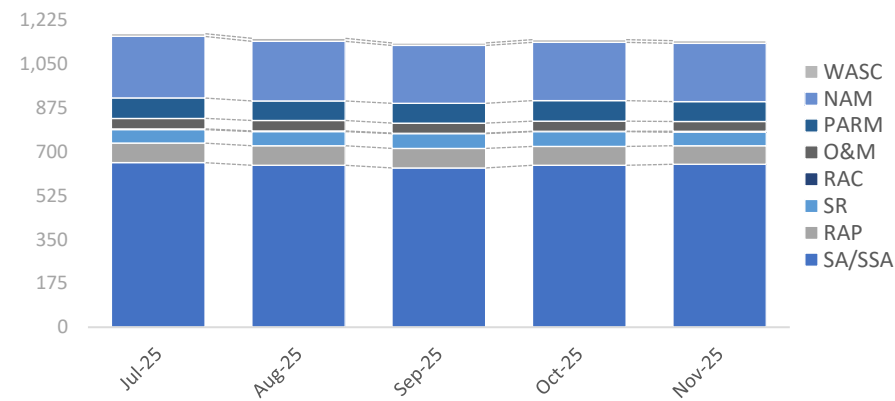

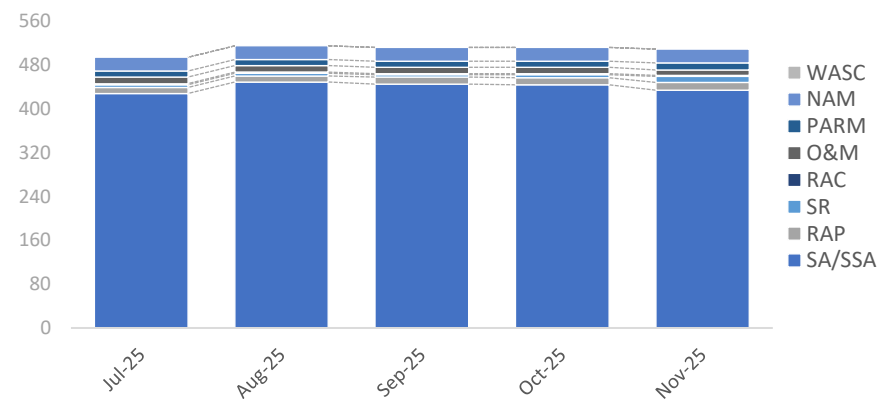
