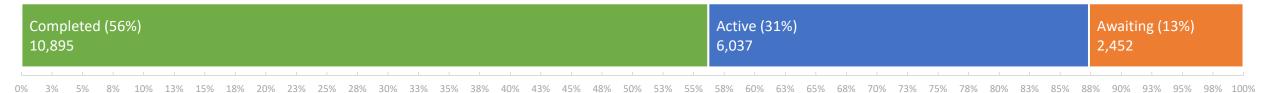

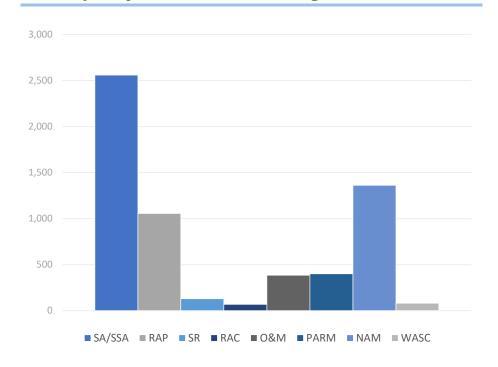

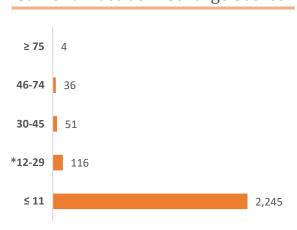
Discharge Closures by Fiscal Year



Monthly Snapshot of Active Discharge Sub-Phases



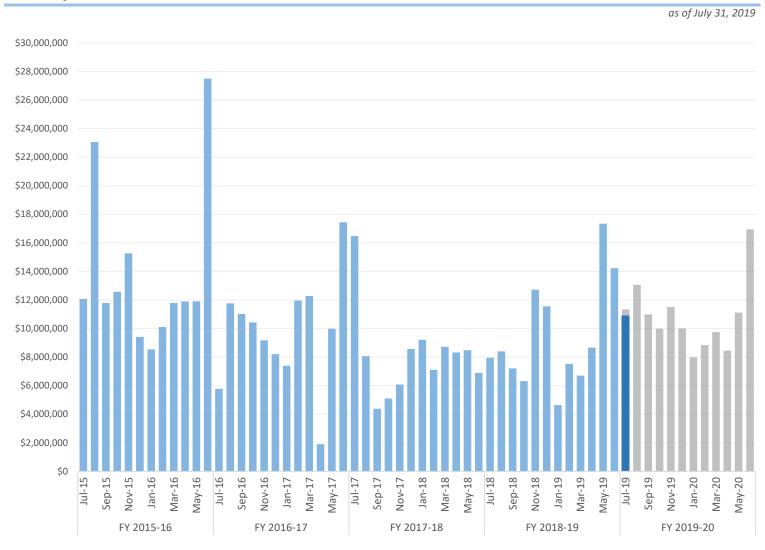

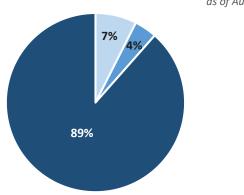

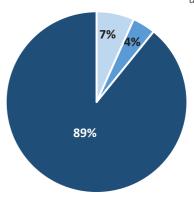

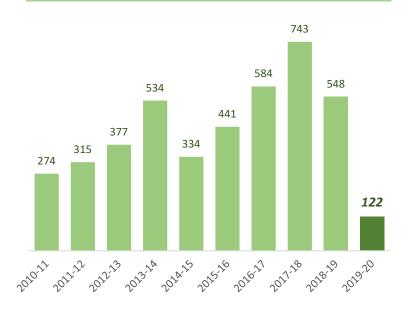

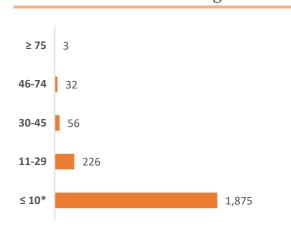
Discharge Closures by Fiscal Year



Monthly Snapshot of Active Discharge Sub-Phases



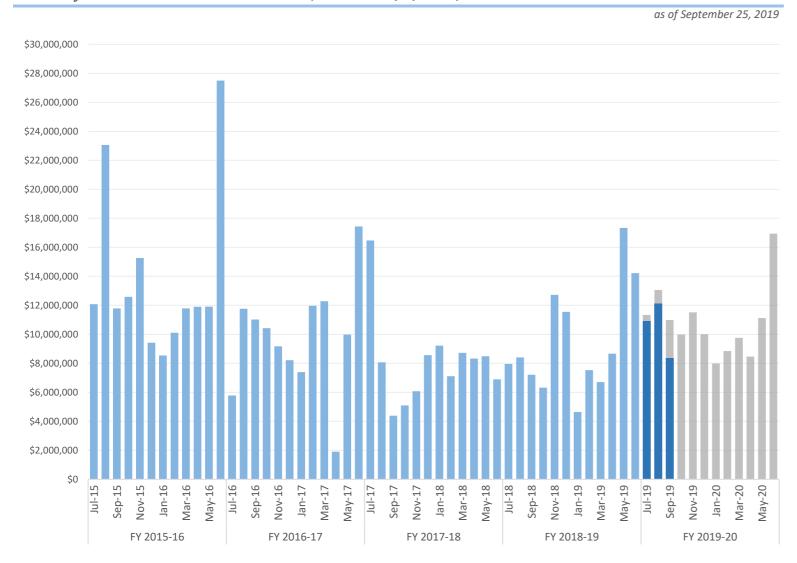

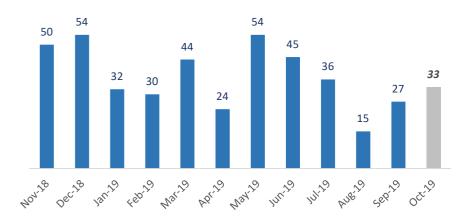

Monthly Net Encumbrance Amounts (with FY 19-20 projections)



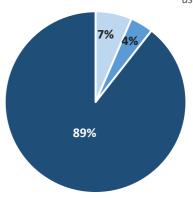

Monthly Net Encumbrance Amounts (with FY 19-20 projections)



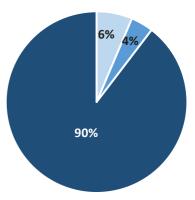

Monthly Net Encumbrance Amounts (with FY 19-20 projections)



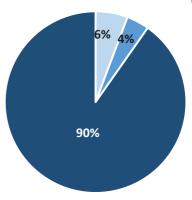

Monthly Net Encumbrance Amounts (with FY 19-20 projections)



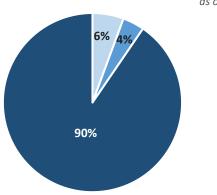

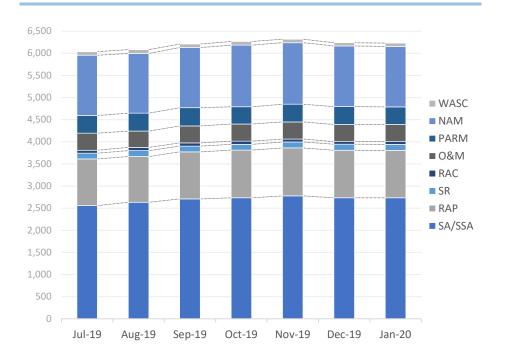

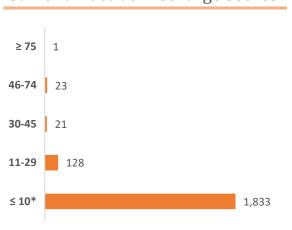

Monthly Net Encumbrance Amounts (with FY 19-20 projections)



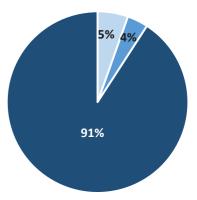
CSF Assignments by Month (with 1-month projection)

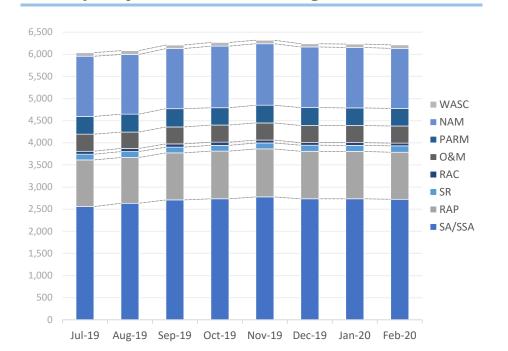

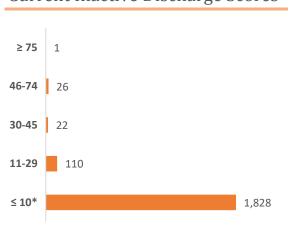

Monthly Net Encumbrance Amounts (with FY 19-20 projections)



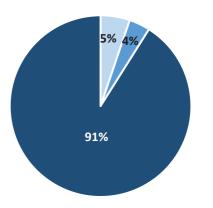

Monthly Net Encumbrance Amounts (with FY 19-20 projections)



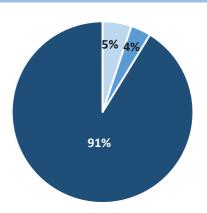

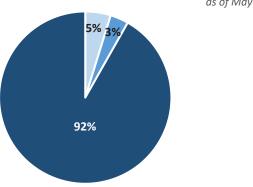

Monthly Net Encumbrance Amounts (with FY 19-20 projections)



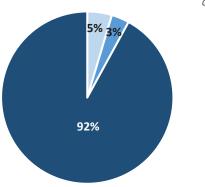
CSF Assignments by Month (with 1-month projection)

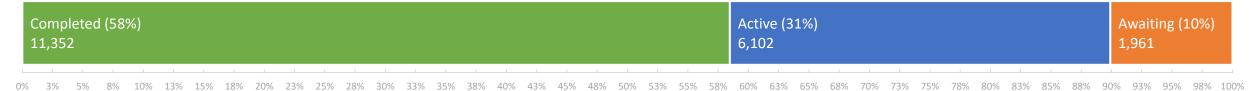

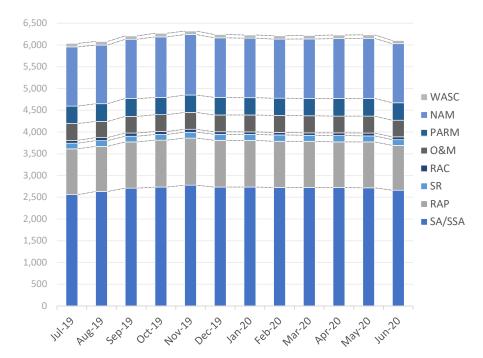

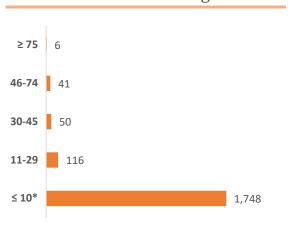

Monthly Snapshot of Active Discharge Sub-Phases

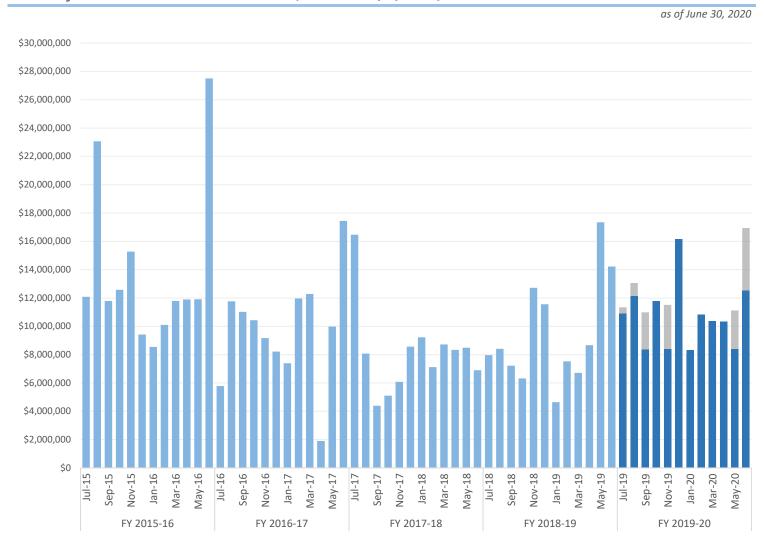

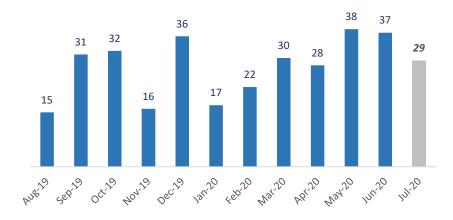

Monthly Net Encumbrance Amounts (with FY 19-20 projections)

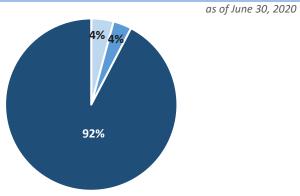


CSF Assignments by Month (with 1-month projection)
