## STATE 404 PROGRAM PUBLIC NOTICE

Permit Application No. 06-398537-001-EE

TO WHOM IT MAY CONCERN: The Department of Environmental Protection has received an application for a State 404 Program permit pursuant to 62-331, Florida Administrative Code, as described below:

APPLICANT: Jet Infrastructure SCS Engineers 1 Saint Louis Street, Suite 1001, Mobile AL 36532 251-459-5049

LOCATION: Approximately 168 In. ft. northeast of the intersection of SW 54<sup>th</sup> St., and SW 55<sup>th</sup> Ave., Davie, FL 33314

APPROXIMATE CENTRAL COORDINATES: Latitude 26.053710 N°, Longitude -80.21960 W°

PROJECT PURPOSE: The EP is a high pressure (600+psi) jet fuel pipeline that services the Miami International Airport (MIA). A release from the EP would severely impact human health and the environment as well as jet traffic at MIA.

PROPOSED WORK: The applicant seeks authorization to excavate an approximately 10 feet long, 10 feet wide, and 7 feet deep hole (27 cy). The excavation will be dewatered to its base, with water pumped from the excavation to a frac tank for testing for turbidity and chemical analytes before discharge to the FTE pond.

EXISTING CONDITIONS: Existing area is currently a wetland.

COMMENTS regarding the potential authorization of the work proposed should be submitted in writing to Kaitlyn Mallett at 3301 Gun Club Road, MSC 7210-1, West Palm Beach FL 33406, or by electronic mail at <u>Kaitlyn.Mallett@FloridaDEP.gov</u>, within 30 days from the date of this notice. Written comments will be made part of the record and should reference the above permit application number. Objections must be factual, specific, and fully describe the reasons upon which any objection is founded.

Any comments received will be considered by the Department to determine whether to issue, modify, condition, or deny a permit for this proposal. Unless a written request is filed with the Department within the 30-day public comment period, the Department may decide on the application without a public meeting.

EVALUATION: The determination as to whether a permit will be issued, or a public meeting held, will be based on an evaluation of all relevant factors, including the public comments received and the effect of the proposed work on the public interest, including, but not limited to, fish, wildlife, historical resources, and pollution. The specific permit decision criteria can be found in Chapter 62-331, Florida Administrative Code.

The Department is soliciting comments from the public; federal, state, and local agencies and officials; Indian Tribes; and other interested parties in order to consider and evaluate the impacts of this proposed activity. To make this consideration, comments are used to assess impacts to endangered species, historic properties, water quality, general environmental effects, and other public interest factors. Comments are also used to determine the need for a public meeting and to determine the overall public interest of the proposed activity.
