# Program Overview and Purpose

The Florida Department of Environmental Protection (DEP), pursuant to Memorandum of Agreement dated August 1, 1993, is authorized to establish the Recreational Trails Program to provide financial assistance to qualified local governmental entities for the development of recreational trails, trailheads and trailside facilities.

The Recreational Trails Program is a federally funded competitive grant program administered by the Florida Department of Environmental Protection (FDEP) in coordination with the Florida Department of Transportation (FDOT) and Federal Highway Administration (FHWA) Florida Division.

# RTP Eligibility

## Eligible Applicants

Municipal, county, state, or federal governmental agencies, recognized state and federal Indian tribal governments, and organizations registered as active Florida nonprofit corporations, which have an agreement with a governmental agency to develop public lands and the project.

**Please Note:** Nonprofit corporations must provide the following documentation with the application:

1. Letter from the public landowner or manager stating that they support the project and will abide by compliance requirements.
2. A copy of the agreement between the landowner or manager and the nonprofit corporation.



# RTP Eligibility

## Application Limit per Submission Cycle

The maximum number of applications an applicant may submit shall be as follows:

- Local governments may submit **one (1)** per district
- Consolidated city-county governments may submit two **(2)** per district
- Nonprofit corporations may submit **one (1)** per district
- State and federal agencies may submit **one (1)** per district





# RTP Eligibility

## **Project Eligibility**

RTP grants shall only be awarded to grantees for projects that are for the primary purpose of providing recreational trails for the public.

## **What is a “Recreational Trail”?**

A thoroughfare or track across land or water, used for recreational purposes such as bicycling, hiking/jogging/running or similar activities, equestrian activities, overnight and long-distance backpacking, roller skating, in-line skating, non-motorized aquatic or water activities including canoeing and kayaking, and vehicular travel by motorcycle, four-wheel drive or all terrain, off-road vehicles, or dune buggies.



# RTP Eligibility

## Site Eligibility

Applicants must have and demonstrate adequate site control of project sites and are able to construct, operate, and maintain the area for the term required by RTP and the grant agreement. For RTP projects on land owned by the applicant, that term is 99 years; for sites owned by someone other than the applicant, that term is at least 25 years past the project completion date.

## Proper Site Control Documentation

- Warranty Deed
- Quit-Claim Deed
- Special Warranty Deed
- Lease Agreement
- Title Commitment or Title Policy

Property Appraiser report cards, surveys, and maps are not sufficient evidence of site control. Use agreements are also insufficient.





# Proper Site Control Documentation

## Warranty Deed

Older deeds may not specify which type they are, and you will need to read the deed to see if it contains language guaranteeing that the person transferring the title has good title to the property. If this language is included, the deed is a warranty deed.

## Quit-Claim Deed

Means that the person transferring the property didn't guarantee that they had good title to the property. In these cases, the department requires that you submit a thirty-year title search, with copies of all title-related documents, AND an attorney's opinion that the title search establishes good title in the applicant and that none of the encumbrances on the property will interfere with the proposed uses for the property.

## Special Warranty Deed

If there are **exceptions** listed in the deed, or if the deed is titled a **special warranty deed** it means there are encumbrances on the property. These may be easements, covenants and restrictions, or other recorded documents that affect title to the property. This means that other people have enforceable property rights that could interfere with your proposed use of the property. If this is the case, you need an attorney's opinion that the exceptions listed in the deed won't interfere with the uses planned for the park. You will also need to include copies of those recorded documents in your site control documentation.



# Proper Site Control Documentation

- Deeds frequently attach the legal description as an exhibit. Make sure the legal description is included in your application. Deeds without a legal description are not sufficient.
- Make sure the legal description in the deed matches the legal description on your boundary map, survey, conceptual site plan, or other documentation.
- Make sure your site control documentation covers the entire site. If your proposed site covers more than one parcel, make sure all relevant deeds are included and provide a map showing which deed relates to which parcel.
- If the transfer was by plat and dedication, make sure the dedication on the plat is readable. If the print is too small, provide both the entire plat and an enlarged copy of just the dedication.





# Proper Site Control Documentation

If you lease the project site, you need to provide the **lease agreement**.

The lease must:

- Extend for thirty years from the date of application;
- Must not be revocable at will by the grantee;
- Must not prohibit the proposed uses of the site; and
- Must grant the applicant the authority to dedicate the property for a minimum of twenty-five years after the project is complete.

Make sure the lease includes the legal description of the property and that the legal description matches your boundary map, site plan, survey, and other documentation.



# Proper Site Control Documentation

## **Title Commitment or Title Policy**

A title policy and or title commitment is useful mainly if copies of all exceptions and a title opinion stating that none of the exceptions will preclude the trail is included.

## **Right of Way**

Where a project uses a city or county right-of-way, the property may have been conveyed to the city or county by the state, may have been dedicated by plat, or may have been dedicated under Florida Statute. You may need to consult your city or county attorney to determine the source of your title.





# Proper Site Control Documentation

Please note that submittal of any deeds, lease agreements, or title documents does not automatically guarantee that the applicant has properly demonstrated site control for the proposed project site. RTP staff will thoroughly review submitted site control documents for sufficiency, noting any deficiencies.



# RTP Eligibility

## Permissible Use of Funds

- Development or renovation of trailside or trailhead facilities or trail linkages
- Maintenance or renovation of existing trails
- Purchase of trail construction or trail maintenance equipment
- Construction of new trails on local and state lands
- Construction of new trails on federal lands (restrictions may apply; refer to 62S-2.072(2)(e), F.A.C.)





# RTP Eligibility

## Examples of **Eligible** Project Elements

- Trails or Boardwalks
- Kayak/Canoe Launches
- Trail/Directional/Wayfinding/Educational Signage and Location Markers
- Amenities (benches, trash/recycle receptacles, informational kiosk, drinking fountain, bike racks, water bottle filling station, lighting, landscaping)
- Restroom Facilities
- Parking Lots
- Fitness Trail; Purchase and Installation of Fitness Equipment
- Covered Pavilions or Shade Shelters with seating (must connect to or support trail)
- Sidewalks (must connect to or support trail)
- Design, engineering, permitting (not to exceed 15% of total project construction cost)



# RTP Eligibility

## Prohibited Uses

- Condemnation of real property
- Construction of recreational trails for motorized use on U.S. Forest Service land unless the land is designated for motorized use and such construction is consistent with the approved U.S. Forest Service land resource management plan
- Facilitating motorized trails on otherwise nonmotorized trail areas
- Upgrading, expanding, or otherwise facilitating motorized use or access to recreational trails predominantly used by nonmotorized trail users





# RTP Eligibility

## Examples of **Ineligible** Project Elements

- Stormwater Ponds or Retention Facilities
- Fencing
- Gates
- Landscape Irrigation
- Gazebo
- Butterfly Garden
- Community Gathering Space
- Any structures or amenities that do not support or connect to the trail.



# RTP Program Intent

A request for financial assistance under RTP may be for development or maintenance of recreational trails, trailhead, and trailside facilities and related support facilities. Development projects should consist of the complete or partial development of the project site. A development project, when completed, must be a usable recreational trail or trail facility along a usable recreational trail. Development projects may also renovate existing trails and facilities in order to provide access for persons with disabilities.

# RTP Application

Pursuant to RTP Rule 62S-2, F.A.C.:

## 6. PROJECT DESCRIPTION

McIntosh Preserve is a 363-acre multi-phase preserve located in Plant City, Florida. The McIntosh Regional Preserve tract was purchased in 1998 for \$1.1 million by the Florida Communities Trust and the Hillsborough County Environmental Land Acquisition and Protection Program (ELAPP). Located off Knights Griffin Road, close to I-4 and the Central Florida Expressway, the preserve is easily accessible through major roadways with a gated access for vehicular traffic. The land use is uplands and wetlands with oaks, pines, and submerged aquatic vegetation. There are no historical or archaeological resources available. The current preserve amenities include walking, hiking, picnicking, and fishing. The proposed project activities under Phase II, this funding request application, is to continue to expand ADA access to McIntosh Preserve through connecting the current upland pedestrian trail to 1,400 linear feet of 5 foot wide boardwalk with timber piles and concrete footings. The boardwalk is designed to sweep out into the wetlands and come near the live oak tree islands for improved wildlife viewing. A 200 square foot seating area with bench is situated south of the tree islands for scenic views of over 50 acres of wetlands. The largest segment of boardwalk traverses south to connect to a pedestrian trail and access to the second smaller wetland with a 200 linear foot boardwalk that also crosses the wetlands and stops to overlook a smaller live oak tree island. At the junction between the two boardwalks, there will be a second bench with trash cans situated at both benches and at the head of the boardwalk system. Other items include two educational signs that provide more information about the residents of McIntosh Preserve.

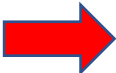

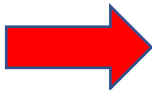

McIntosh Preserve is committed to promoting active healthy lifestyles by providing safe and accessible spaces through 2-miles of existing hard-packed trails that will connect to the proposed phase II boardwalk. Goal 1-2: Increase the number the recreation facilities, programs and opportunities in urban areas and rural communities. McIntosh Preserve is in the heart of an urban/rural area and will benefit the surrounding community with an innovative space that promotes wellbeing and environmental education through the expansion of ADA accessible walking/hiking trails to fish and/or bird watch. Priority Area 2: Public Access, Accessibility and Connectivity.

Goal 4 – Establish Partnerships and Engage Stakeholders: The McIntosh Preserve project would be a vital link in this corridor and would promote collaboration between the City of Plant City, Hillsborough County, and the State of Florida. This would assist with the development and expansion of natural corridors within the area, establish a cohesive approach when multi-agency programs share responsibilities to address local needs, promote supportive exchange of ideas between agencies, and increase the fit between services offered and those desired by users.

### 5. ACCESSIBILITY

In conjunction with the McIntosh Preserve Phase I (existing), all trails, boardwalks, and observation areas have been designed and constructed to meet or exceed current ADA standards for outdoor recreation trail facilities. Trails are of a compacted crushed stone to facilitate ease for wheelchairs and wagons and the family designated trails are sized at 8 feet wide to minimize difficulty of passing foot traffic. The proposed (Phase II) boardwalk is concrete boardwalk system to increase access to boardwalk and therefore the wetlands and tree islands. This allows access to all persons regardless of their mobility constraints or the need for mechanical assistance items.

The proposed Elfers Spur Trail will meet with the Coastal Anclote Trail, which in turn will serve as a connector to several parks: Anclote River Park, Anclote Gulf Park, Key Vista Nature Park, Tarpon Springs Safford Avenue Park, Tarpon Springs Dog Park and the Tarpon Springs Splash Park.

The project area exhibits a low potential for undocumented cultural resources. See attached letter from the Florida Department of State. The proposed Elfers Spur Trail project will increase access to existing intermodal transportation corridors. The Elfers Spur Trail will connect to the Pinellas Suncoast Transportation Authority (PSTA) bus service on US 19 ALT. This central route connects to central transit centers in the City of Clearwater with further access to transportation across the county.

(D) Residential populated areas.

The Elfers Spur Trail is centrally located in the City of Tarpon Springs and within residential areas of the City. Tarpon Springs has a total population of 25,176 (US Census, 2019 Community Survey 5-year estimates). Further, both ends of the trail connect residential areas to the Pinellas Trail and the Coastal Anclote Trail as well as several parks as mentioned above.

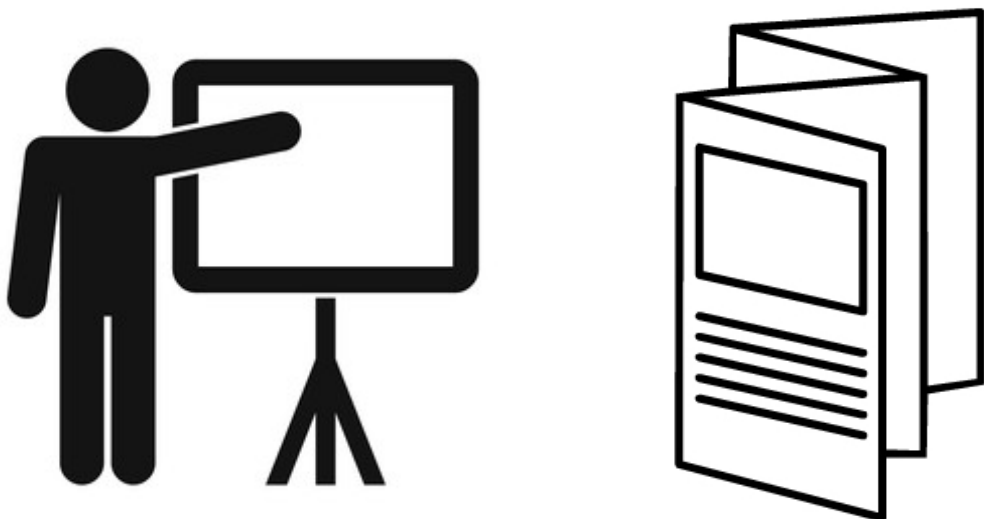

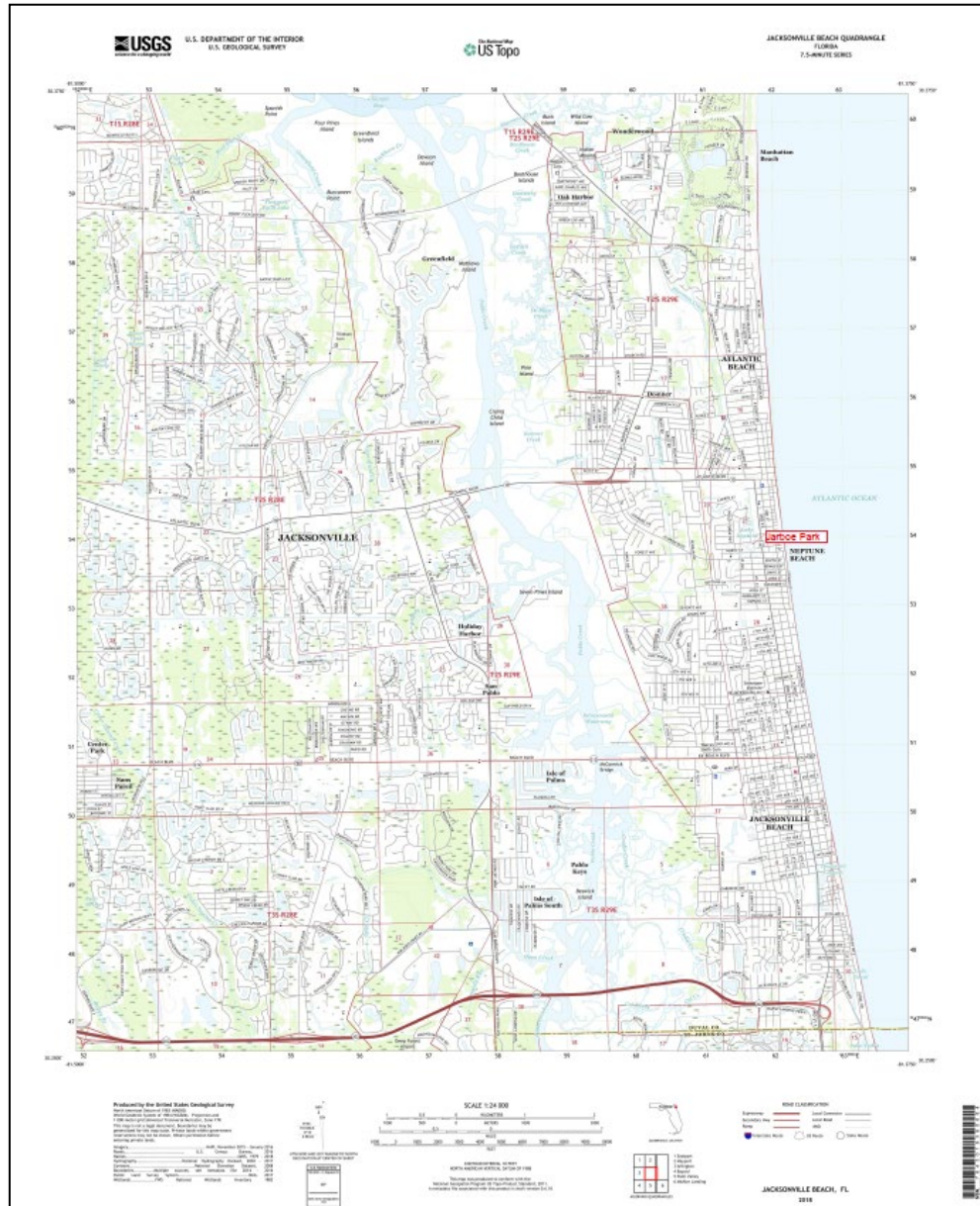

An alligator has nested alongside the boardwalk, giving visitors an up-close view, bird nests and overhead flight can be seen, a variety of trees and wetland plants provide knowledge of Florida's diversity and beauty.</p> <p>ONP's boardwalk was built over a vegetated wetland area. To accomplish its construction, workers persevered through the dense undergrowth, water, and deep mud; removing only one single large tree to construct the winding pathway. Several hundred hours a year are required to remove and replace broken, badly worn, or splintery boards, which pose a hazard to users. Occasionally large sections of the boardwalk need to be restricted to the public while repairs are made because of damage from storms and hurricanes.</p>		<p>A more effective method would be to install composite boardwalk decking along the entire length of the boardwalk. Composite boardwalk decking is highly weather resilient, slip resistant, and easy to keep in excellent condition. These planned boardwalk renovations would allow the structure to continue to serve as a comprehensive recreational and educational amenity for many years to come, without the constant repair required for boards.</p> <p>As the land managing agency, the Town of Oakland applauds the efforts of ONP to replace this amazing boardwalk with highly stable material that will hold up better moving into the future. 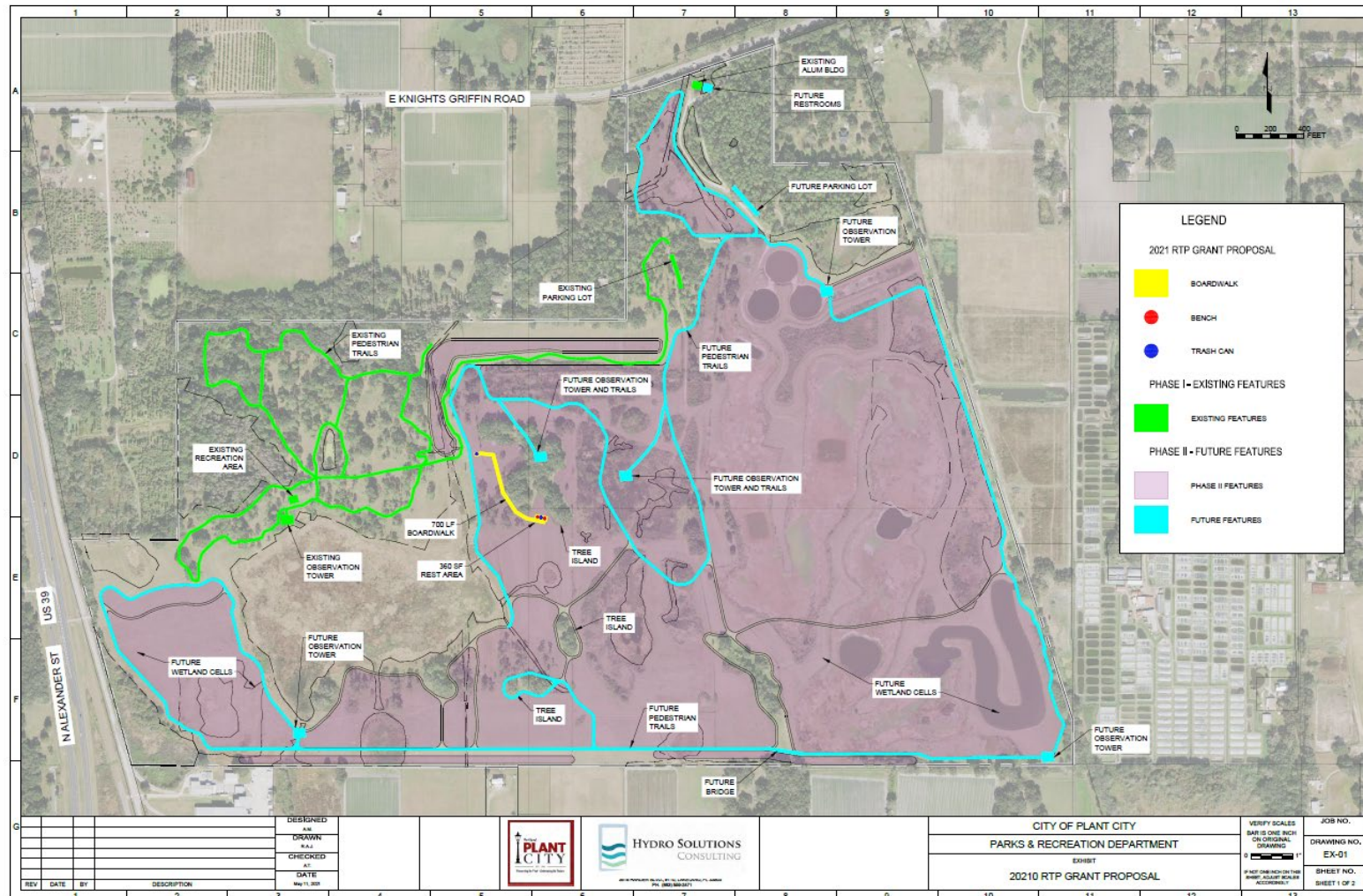

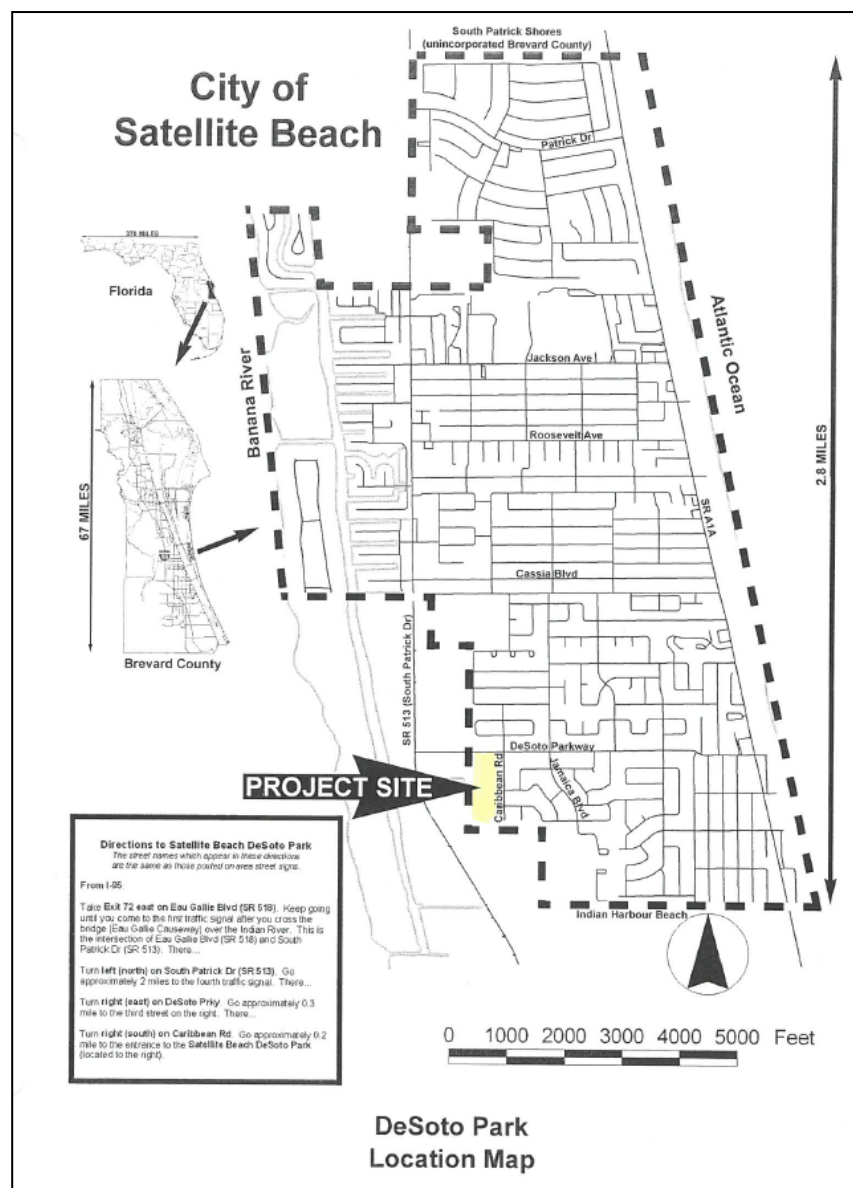

### DeSoto Park Complex Multi-Use Recreational Trail

**Goal 2-1:** Maintain and manage adequate availability of resources for a growing population.

According to the U.S. Census Bureau<sup>1</sup>, the City of Satellite Beach experienced a growth increase of 7.2% between 2010 and 2016. To increase recreational opportunities for this growing population, the project will enhance an existing recreational property, DeSoto Park Complex, by adding a 1,800 l.f. multi-use trail and installing the community's first multi-generational playground. In addition, there are future plans to build the City's first public canoe/kayak launch, which will connect to the trail and provide a water access point.

**Strategy 1:** "Given Florida's current economic situation...agencies should focus efforts on enhancing existing access points and facilities..."

**Goal 2-3:** All recreation providers should seek to increase universal accessibility.

The multi-use recreational trail will be an 8' wide, concrete, ADA accessible path. The multi-generational exercise stations will offer equipment that is both ADA compliant and will accommodate various fitness levels. Adequate and accessible information on the park's new features will be readily available through multiple printed and online resources.

**Goal 2-4:** Protect water resources while providing adequate access.

Three educational, solar panel kiosks will be erected in conjunction with this project. One kiosk will cover the benefits of solar power. The other two kiosks will focus on protecting water resources, specifically nutrient reduction and the Indian River Lagoon, and manatee awareness. They will be located on the project's west boundary, along a canal that is frequented by endangered manatees. The City's first, public kayak launch will provide water access and will be connected to the new multi-use recreational trail and paved parking area.

**Strategy 5:** "...work to reduce the amount of nutrient pollution that enters Florida's waters through programs that teach the public about where nutrients come from and what they can do to help." **Strategy 7:** "...increase public access to Florida's waters by preserving...and identifying sites for public and private recreation."

**Strategy 8:** "...identify water areas under their jurisdiction where inadequate recreational access exists or where existing water access can be improved, and give priority to making the needed improvements."

The Florida State Historic Preservation Office reviewed the referenced project for possible effects on historic properties listed, or eligible for listing, on the *National Register of Historic Places*. The review was conducted in accordance with Section 106 of the *National Historic Preservation Act of 1966*, as amended, and its implementing regulations in *36 CFR Part 800: Protection of Historic Properties*.

Based on our desktop review, the project area exhibits a low potential for undocumented cultural resources. It is the opinion of this office that the proposed project is unlikely to affect historic properties. However, the grant, if issued, should include the following special condition regarding unexpected discoveries:

- If prehistoric or historic artifacts, such as pottery or ceramics, projectile points, dugout canoes, metal implements, historic building materials, or any other physical remains that could be associated with Native American, early European, or American settlement are encountered at any time within the project site area, the permitted project shall cease all activities involving subsurface disturbance in the vicinity of the discovery. The applicant shall contact the Florida Department of State, Division of Historical Resources, Compliance Review Section at (850)-245-6344. Project activities shall not resume without verbal and/or written authorization. In the event that unmarked human remains are encountered during permitted activities, all work shall stop immediately and the proper authorities notified in accordance with Section 872.05, *Florida Statutes*.



Facility Tour: The members in attendance discussed the different aspects of the park and all the available recreation components, including the senior baseball field, the tennis courts, racquetball courts, and community garden. Following closure of the application submission period, Department staff will review and score submissions per [Rule 62S-2, F.A.C.](#)

Once notified of deficiencies, applicants may retain eligibility by submitting all documentation missing from or not clear in the application within fifteen (15) working days from the date of the Department's written notification.

If Department staff determines your project does not meet the intent of the program or you fail to provide adequate documentation during the deficiency period, you will be provided, in writing, with a formal ineligible determination letter.





# Post Application & Evaluation Process

As the deficiency response period closes, qualified applications are forwarded to the State Clearinghouse for review. Because the RTP program provides federal assistance and projects may have a significant impact on Florida's environment, each application must undergo a state-level environmental review. Once completed, a clearance letter or state process recommendation letter is issued.

All qualified applications are then forwarded to the Recreational Trails Program Advisory Committee (TAC) for review. The TAC holds a Committee Meeting to review these projects, decide if their proposals meet RTP's funding purpose, and approve a draft Priority List. Applicants will be invited to attend the TAC Committee Meeting to present their projects.





# Post Application & Evaluation Process

The approved Priority List will comprise of ranked scores for each category: motorized, nonmotorized single-use, and nonmotorized diverse-use. Applications will be ranked on the priority list according to assigned point scores. The application with the highest score will receive the highest rank. The remaining applications will be arranged in descending order according to their assigned point scores.

If two or more applications receive the same score, a tie-breaker system will be used to decide the priority ranking among them. Applications with equal scores shall be assigned an order of priority based on the amount of funds previously received by the applicant through RTP during the previous 5 fiscal years. The application from the applicant which received the lowest amount of program funds will receive the highest priority. The remaining tied applications will be arranged in descending order related inversely to the amount of program funds received.



# Post Application & Evaluation Process

As the recommended Priority List is finalized, the document is presented to the FDEP's Department Secretary or their designee. It is reviewed, revised as necessary, and executed through signature.

The final Priority List is then forwarded to the U.S. Department of Transportation's Federal Highway Administration (FHWA) for final review. FHWA's endorsement of the final Priority List prompts Department staff to issue award memos for applicants with corresponding projects.





# Post Application & Evaluation Process

Post issuance of an award memo, the Department and Grantee shall enter into a grant agreement that sets forth the responsibilities of each part regarding administration of the approved project as outlined in the Application, pursuant to Rule 62S-2.075(1) F.A.C.

The grant agreement shall contain terms and conditions particular to each project. This document is forwarded to the grant manager for review and approval by the appropriate signatory authority. Upon its signature, the grant agreement is returned to the Department and executed through a secondary signature from the Department's Secretary or designee.

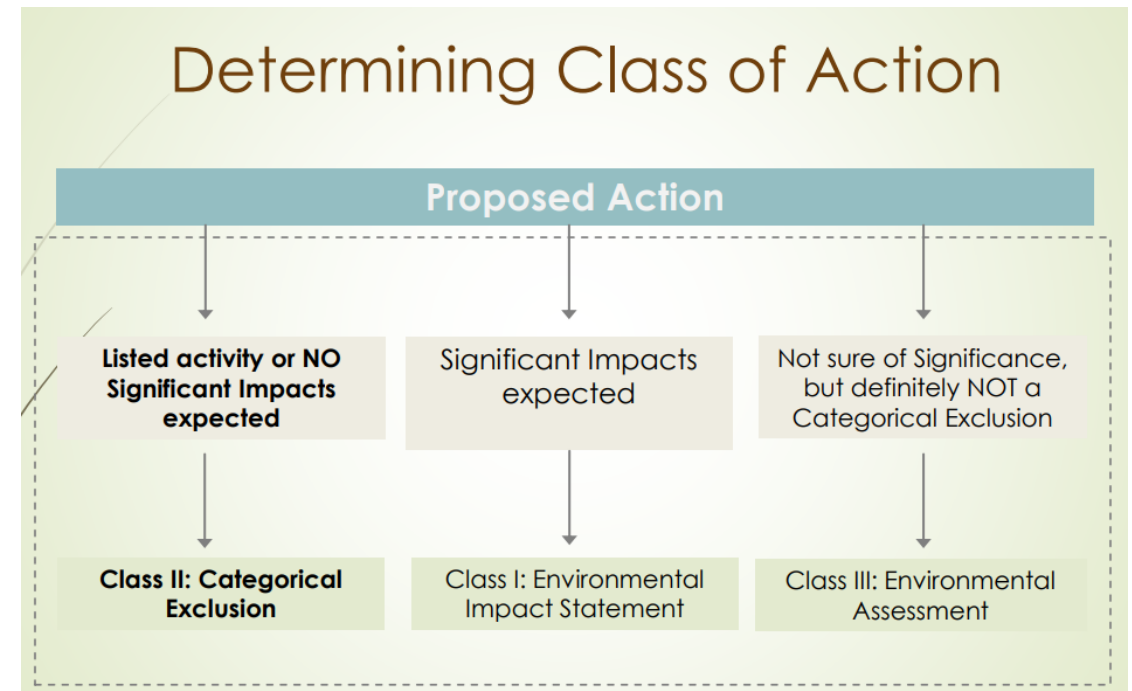
Florida's RTP grant agreements include a two-year term, starting upon the execution date. As the agreement is executed, new grantees will (a) have 180 calendar days to complete and receive approval of required National Environmental Policy Act (NEPA) documentation by FDOT and (b) have twelve months to complete the commencement process outlined in Task 1.

NEPA established a national policy for protection of the environment and to raise awareness of the importance of natural resources to the nation. It requires federal agencies, in cooperation with state and local governments, to address the environmental impacts of a federal action. NEPA applies to project decisions or funding by all federal agencies.



# Post Application & Evaluation Process

Each funded project will be required to submit all documentation on the Type 1 CE checklist to FDOT in order to determine if the project is classified as a categorical exclusion (CE). A CE is a project which, based upon past experience with similar actions, does not individually or cumulatively have a significant environmental effect, and is excluded from the requirement to prepare an Environmental Assessment (EA) or an Environmental Impact Statement (EIS). Both an EA or EIS will need to be prepared by a qualified professional.

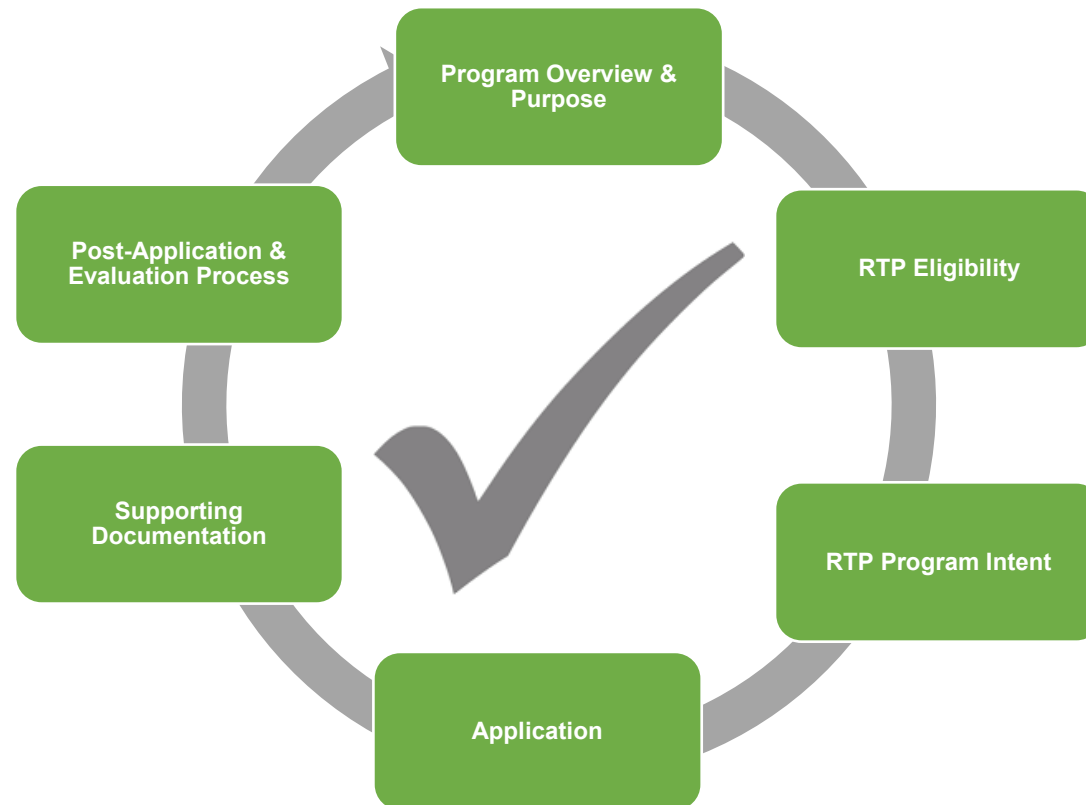
