

RESILIENT FLORIDA GRANT PROGRAM

To effectively address the impacts of flooding and sea level rise in Florida, the [Resilient Florida Program](#) includes a selection of grants that are available to counties, municipalities, certain special districts, flood control districts and regional resilience entities.

Eligible applicants may receive funding assistance for:

- **Planning projects**, which help entities identify and prepare to address risks of flooding. Regional resilience entities can also receive grants to provide technical assistance to counties and municipalities as they coordinate multijurisdictional vulnerability assessments and develop project proposals to be submitted for the inclusion in the Statewide Flooding and Sea Level Rise Resilience Plan.
- **Implementation projects**, which are available only after eligible entities have conducted a vulnerability assessment, evaluation, report or other similar documentation demonstrating the risk of flooding or sea level rise to critical assets or the project area or if a project adapts a critical asset to risks identified in the Statewide Flood and Sea Level Rise Vulnerability Assessment.



Beginning in 2024, a vulnerability assessment meeting the requirements of [Section 380.093, Florida Statutes](#), will be required to receive funding.

Applications submitted for funding consideration will undergo a comprehensive evaluation to ensure that funds are allocated timely and appropriately and pursuant to Florida Statute.
