

State Revolving Fund Interest Rate Fact Sheet

CWSRF Financing Rate Formula

$$FR = MR - 4 + (4/(1+(100/AI)^3)) - 1/\text{Log}(P)$$

Where:

FR = Financing Rate

MR = Market Rate

AI = Affordability Index

P = Population served or to be served by the sponsor

DWSRF Interest Rate Formula

$$i = \%MR(MR)$$

$$\%MR = 40(MHI/SMHI) + 15$$

Where:

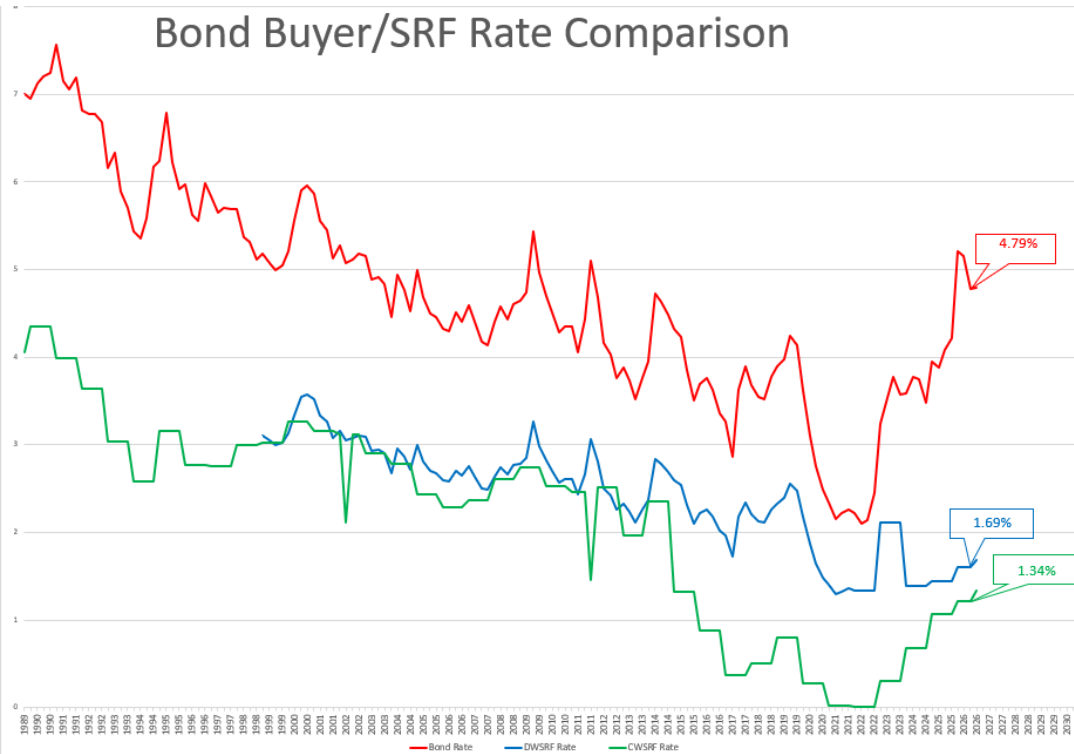
i = Interest Rate

MR = Market Rate

MHI = Median Household Income of the public water system's service area

SMHI = State of Florida MHI
