Mission of the Operator Certification Program

The mission of the Florida Operator Certification Program is to promote public health and safety, protect the environment, and conserve Florida's water resources by ensuring that all persons working in drinking water, water distribution, wastewater, and septic tank contracting meet the highest standards for certification as determined by the rules and regulations of the Florida Department of Environmental Protection under the guidelines of the United States Environmental Protection Agency.

Introduction: Please Read This First!

Chapter 62-6, Florida Administrative Code (F.A.C.) defines specific requirements for application, examination, registration, renewal, and regulation of Septic Tank Contractors.

This handbook contains useful information on process information, related regulations, and associations that assist in training or technical programs. We encourage you to carefully read all information in the handbook before completing an application.

Step One: Examination Process

Here is what you will need to be considered eligible to qualify for the Septic Tank Contractor Registration examination:

- Complete DEP Form 4074: Application for Septic Tank Contractor Registration.
- Provide all information on the application in the appropriate spaces. If you are requesting special testing accommodations, please send documentation as to the disability or accommodation needed. A doctor's note or other documentation is required to obtain pre-approval. You may be contacted if we need any additional information.
- Examination Fees
 - **Initial application: \$100** (\$25 account creation fee and \$75 examination fee)
 - **Retake application: \$75**
 - Fees shall be paid by check or money order made out to the Florida Dept of Environmental Protection (FDEP).

All examination applications must be submitted with required documentation and fees to be considered complete. Applications received with missing information, documentation, or insufficient fees are considered INCOMPLETE. Applicants must meet the minimum eligibility requirements for examination prior to approval and scheduling.

Applications do not come directly to our office. Applications go to Finance and Accounting where a receipt number is issued. Upon receipt our department has up to 30 business days to process an application. If you have not received notification at the end of 30 business days please contact our office. Remember our mail is not automatically forwarded. Please provide a current address.

Retain all instructions and make copies of the completed application for your records before mailing. Upon review of your application, you will receive a status notification from the Department.

Please type or write clearly on your application to ensure your name and address is spelled accurately.

Please remember that information in this handbook is subject to change at any time. If you find information in this book that you believe to be questionable, please contact our office for clarification.

- The **100-question exam** covers the subject matter and regulatory information mentioned above. You will receive these reference materials to use during the test. A **minimum score of 75%** is required to pass.
- The applicant has ninety days after the Department issues a request for additional information to submit the requested information to the Department. If the applicant does not respond within ninety days, the application will be denied.

Step Two: Registration Process

Once you have passed the examination, we will receive your exam score directly from the testing vendor.

- Complete DEP Form 4074: Application for Septic Tank Contractor Registration.
- Provide all information on the application in the appropriate spaces, including signatures and dates.
- Verification of at least three years of experience, demonstrated by 6,000 hours of experience signed by either a septic tank contractor or plumbing contractor
 - Up to 4,000 hours (2 years) may be substituted with coursework or related experience, see F.A.C. 62-6.019(3)(a)(2-5)
- Approved coursework will be counted at a ratio of 33 work hours per hour of coursework up to a maximum of 4000 hours. Out of State Applicants
 - Per 62-6.019(3)(a)(4), certification from a regulatory agency of another state demonstrating the applicant held a statewide license for septic tank contracting in their jurisdiction, length of time the license has been held, verification of compliance with continuing education requirements consistent with Florida's requirements, and verification of the passing of an examination that at a minimum included the following topics: system location and installation, site evaluation criteria, system size determinations, disposal of septage, construction standards for drainfield systems, and U.S. Department of Agriculture's soil textural classification system. Out of state experience will be prorated as 2000 hours per 365 days of license holding. Per 62-6.019(3)(a)(2), the experience of a person employed by and under the supervision of a contractor licensed in another state for septic tank contracting is considered related work experience. No more than two years (maximum 4,000 hours) of related work experience will be accepted, and the certification must account for the hours of related work.
 - Please provide our office with the following information, along with the standard application information so that your out-of-state septic tank contractor registration can be evaluated:
 - Septic Tank Contractor Registration Verification Letter (reach out to the Operator Certification Program for this form)
 - A copy of your current and active out-of-state Septic Tank Contractor license(s)

Change of Address and Name

It is the responsibility of the applicant/contractor to inform the OCP office in writing by fax, mail, or email of any changes of address and name. **No changes will be made over the phone.** Failure to notify our office of your current address will delay notification of your examination, registration, and renewal status. Registration Renewal and Inactive Status

All registrations must be renewed annually, by September 30th to continue septic tank contracting. Ninety days prior to the renewal deadline, registration-holders are sent a renewal notice to their last address of record. Please note that all operators are responsible for keeping track of their renewals; all notices sent by the Department are courtesy reminders that renewal of your license(s) is due. Remember to notify our office in writing of your current address.

Any registration renewal application which is not submitted in a timely and complete manner will revert to inactive status after expiration until renewed. Registrations not renewed by the renewal deadline are considered inactive, and the business authorization that the registration-holder qualifies will also move to inactive status. Those operators working with an inactive license may be subject to disciplinary and enforcement actions. An inactive registration which is not reactivated for more than 5 renewal cycles will be moved Null & Void status. Subsequent registration will require meeting all the current requirements for the Septic Tank Contractor Registration including examination. Example: Your registration is active until the expiration date 9/30/2026. If you fail to renew your license by this date it becomes inactive until 9/30/2031. If proper fees and CEU's are not received by 9/30/2031, your registration will become Null & Void.

How to Renew:

- Complete DEP Form 4076: Application for Septic Tank Contractor Registration.
- Include copies of your CEU certificates; 12 hours required, up to 6 hours can be rolled over from the previous year
- Check for \$100
