

NPDES Stormwater Multi Sector Generic Permit Guidance

Sector AB: Manufacturers of Transportation Equipment Industrial or Commercial Machinery

Sector AB -- Manufacturers of Transportation Equipment Industrial or Commercial Machinery of the Multi-Sector Generic Permit (MSGP) gives special conditions for the storm water discharges associated with Industrial Activity from facilities which manufacture transportation equipment, industrial or commercial machinery.

- Motor Vehicles and Motor Vehicle Equipment (3711, 3713, 3714, 3715, 3716).
- Aircraft and Parts (3721, 3724, 3728).
- Motorcycles, Bicycles, and Parts (3751).
- Guided Missiles and Space Vehicles and Parts (3761, 3764, 3769).
- Miscellaneous Transportation Equipment (3792, 3795, 3799).

Recommended BMPs (not limited to):

Stormwater treatment BMPs are intended to prevent or minimize the contamination of runoff, or treat runoff contaminated with pollutants.

- Confine and perform loading/unloading activities indoors or in a covered designated area.
- Berm, curb, or dike loading/unloading, and storage areas.
- Divert stormwater around storage areas with vegetated swales, and/or berms.
- Store waste in enclosed and/or covered areas and in covered, leak proof containers (e.g., dumpsters, drums).
- Confine storage to areas outside of drainage pathways and away from surface waters
- Do all cleaning at a centralized station, and clean up leaks, drips, and other spills without using large amounts of water or without using liquid cleaners whenever possible.
- Perform all cleaning operations indoors or under covering when possible.
- Ensure hazardous and solid waste disposal practices are performed in accordance with applicable federal, state, and local requirements.
- Train employees on proper loading/unloading techniques, and on proper waste control and disposal procedures.

Industrial facilities which have the potential to discharge stormwater to surface waters of the State or into a municipal separate storm sewer system (MS4) and fall under any one of the 11 categories of industrial activities identified in 40 CFR 122.26(b)(14), may require coverage under the Multi-Sector Generic Permit.
