The natural environment is the lifeblood of our state's economy. The DEP wants to work with you to protect, conserve and manage Florida's environment and valuable natural resources. The DEP's South District focuses on issues facing the region which includes Charlotte, Collier, Desoto, Highlands, Glades, Lee, Monroe and Sarasota counties. The District's main office in Fort Myers and a branch office in the Florida Keys provide regulatory expertise including permitting, compliance and enforcement and technical assistance for the following programs:

- <u>Air Resources</u> including major and minor air pollution sources as well as monitoring for airborne particulate matter and ozone levels
- <u>Water facilities</u> including drinking water, domestic and industrial wastewater, groundwater and underground injection control
- Waste Management including solid and hazardous waste, petroleum storage tanks, and waste cleanup
- Environmental Resource Permitting is responsible for resource protection as well as regulatory and proprietary issues involving submerged lands

The Department also assists with non-regulatory programs including

<u>Watershed planning</u> and water resource issues, Clean Marina and Green Lodging Programs.

KNOWLEDGE TEST ANSWERS

- 1. Renovation or demolition of a commercial building requires an asbestos survey and a notification to the Department's Air Program.
- 2. Spray painting operations may require an air permit and/or hazardous waste notification.
- 3. Specific air and hazardous waste regulations apply to dry cleaning operations and registration with the Department is required.
- 4. Cross connection of a well and a potable water system is absolutely prohibited. Always contact the utility before making any connections. A permit from our Water Facilities Program may be required.
- 5. If you are on a public water system you should contact our Water Facilities Program with concerns about water quality. If you are on a private well, call your local Health Department.
- 6. Used oil or filters generated by businesses should be recycled through an appropriately registered hauler and specific containment and labeling requirements do apply and can be found on our Waste Program website. Many small businesses find it more convenient to leave engine maintenance to a commercial automotive facility.
- 7. Vegetative wastes should be disposed of at facilities registered with DEP. You can apply for registration to manage the material at your landscaping business if the site is appropriately zoned and meets specific requirements. Contact our Waste Program.
- 8. Utilizing Self-Certification or scheduling a preapplication meeting can reduce the time to receive an Environmental Resource Permit to construct in waters or wetlands. Contacting us to discuss your project or checking the website for helpful information can also reduce delays.
- **9.** Algae blooms could be caused by excess nutrients such as fertilizers in stormwater runoff. Contact us to learn more about watershed protection efforts.

DEP Launches Online Business Portal
