






#### ELIGIBLE SITE STATUS

- The Petroleum Restoration Program (PRP) is currently managing almost 1/3 of all sites ever determined eligible.
- There are only 3% of eligible sites awaiting cleanup.
- We have completed cleanup on 2/3 of the sites eligible for state funding.





RESPONSIBLE PARTY (RP) SITE STATUS

- The Department is currently working on over 2,000 RP lead discharges.
- Approximately 1,700 of these are being managed by PRP.
- Less than 1% of RP sites are inactive.





PETROLEUM DISCHARGE CLOSURES THIS FISCAL YEAR TO DATE

 The overall closure goal for petroleum discharges is 500 discharges this fiscal year.



- The Program received an all-time high level of funding.
- \$210 Million FY 24-25
- \$138 Million carryover.

- The Program is managing a record 7,760 sites.
- 6,083 State Funded.
- 1,677 Responsible Party.

#### Goals

- Move sites into active remediation.
- Implement dynamic cleanup approaches.
- Issue purchase orders for work on all managed sites.
- Actively manage all eligible sites.
